# FEMA Region 6 Weather Threat Briefing

Saturday December 23, 2023

**Disclaimer:** The purpose of this briefing is to provide a <u>Regional</u> weather threat assessment and is meant as a general overview. County/Parish decision makers should consult their local NWS forecast offices for the latest detailed, local weather information.

- Marginal risk area for strong/severe thunderstorms from the TX Panhandle into SW TX and SE NM. Damaging winds/hail the main threats.
- Heavy snow through Sunday morning across northern NM.
- Marginal to slight risk of excessive rainfall leading to flash flooding across S OK, N/Ctrl/SETX on Saturday and SE OK, AR, ETX, LA on Sunday.
- Monitoring for potential of minor river flooding across NETX and LA this weekend.



Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall









#### 'Day 8-14" Hazards Outlook








Green	Very Common Safety: Rarely a Direct Threat to Life and Property Impact Potential: Typically Results in Little Inconvenience to Daily Routines	Severe: Marginal Risk from SPC Flooding: Minor flooding expected over localized areas Tropical: None Fire Weather: No Watches/Warnings, fuel moisture above 10% or green up active	Thunderstorms expected over LA this afternoon; a few may produce winds to knock down a few trees  Something that happens almost every day in a particular season such as sea breeze storms in coastal TX
