- Elevated to critical fire weather conditions today through Wednesday for E NM and WTX.
- Marginal risk of severe thunderstorms across NE OK on Tuesday and E **OK, NTX on Wednesday.**
- Slight risk of severe thunderstorms and excessive rainfall across SE OK, NETX, AR, N LA on Thursday and possibly continuing into Friday.
- Minor river flooding lingers in ETX and NW LA with some flooding of secondary roadways.








Today's Tornado & Severe Wind / Hail Probabilities





Tomorrow's Tornado & Severe Wind / Hail Probabilities









Heavy rainfall may lead to isolated flash flooding across ETX, SEAR, LA.




Drought Monitor




