STATEWIDE CURRENT SITUATION:

On March 11, Governor Abbott today announced that he requested disaster declarations from the U.S. Small Business Administration (SBA) for Texas communities affected by wildfires that began on February 26. If approved, these SBA declarations would make federal assistance available in the form of disaster loans for Carson, Hemphill, and Hutchinson counties and their contiguous counties.

If the state's request is approved, the SBA would provide low-interest loans through its disaster programs to qualifying Texans whose homes and businesses sustained damage during the Panhandle wildfires.

Local, state, and federal officials <u>conducted an analysis of damage sustained</u> in impacted communities, which verifies that Carson, Hemphill, and Hutchinson counties meet the federally-required thresholds for SBA assistance. Officials also reviewed disaster damage information self-reported by Texans through <u>Individual</u> <u>State of Texas Assessment Tool (iSTAT)</u> surveys.

Governor Abbott continues to take action to provide all available resources to help support local communities and protect Texans from these devastating wildfires, including:

- <u>Granting a waiver</u> for the Texas Comptroller of Public Accounts to assist with fueling capabilities amid the wildfire response.
- Requesting joint preliminary damage assessments with local, state, and

federal officials in impacted communities.

- <u>Holding a briefing</u> with lead state response agencies as well as local partners in Canadian to discuss and provide an update on the state's continued response efforts.
- <u>Issuing a disaster declaration</u> for 60 Texas counties in response to widespread wildfire activity. Additional counties may be added as conditions warrant.
- <u>Holding a briefing</u> with state and local officials in Borger and providing an update on the state's ongoing response to wildfires impacting the state.
- <u>Granting waivers</u> for the Texas Commission on Environmental Quality (TCEQ), Texas Department of Motor Vehicles (TxDMV), and Texas Department of Public Safety (DPS) to support a swift state response in support of impacted Texans.
- <u>Directing TDEM</u> to deploy additional state emergency response resources and raise the readiness level of the State Emergency Operations Center to support the priority needs of communities facing impacts from these wildfires.
- Receiving approval from the Federal Emergency Management Agency (FEMA) for a <u>Fire Management Assistance Grant (FMAG)</u> request for the Smokehouse Creek Fire and Windy Deuce Fire, meaning that Texas will be eligible for 75% reimbursement from the federal government for costs associated with fighting those fires.

OPERATIONAL PRIORITIES:

- 1. Protect life and property.
- 2. Support rapid & effective response.
- 3. Collect and disseminate accurate incident information to improve decisionmaking.
- 4. Accurately track incident costs associated with assigned resources for cost recovery.

Region 1 (Includes DDs 1, 2, and 7)

Disaster District (DD) 1 – Amarillo (Includes Armstrong, Briscoe, Carson, Castro, Childress, Collingsworth, Dallam, Deaf Smith, Donley, Gray, Hall, Hansford, Hartley, Hemphill, Hutchinson, Lipscomb, Moore, Ochiltree, Oldham, Parmer, Potter, Randall, Roberts, Sherman, Swisher, and Wheeler Counties)

DDEOC 1 activated to Level II on February 27.

Carson County: A disaster declaration was issued for the entire county by the County Judge on February 28.

Childress County: Evacuated livestock are being housed at the Mashburn Event Center.

Gray County: Gray County issued a disaster declaration on February 28. County officials submitted a Disaster Summary Outline to TDEM on March 1. Evacuation from the city of Pampa is voluntary for residents and an emergency shelter is located at First Baptist Church and at the Gray County Animal Supply Point in Pampa.

The Grapevine Creek Fire has burned 34,883 acres and is 100% contained.

Hemphill County: Hemphill County submitted a Disaster Summary Outline to TDEM on March 3. Hemphill County issued a disaster declaration on February 27.

Hutchinson County: The County Judge issued a disaster declaration on February 27, a Disaster Summary Outline on March 1, an update submitted on March 2, a disaster declaration continuation, and Letter to the Governor on March 4. A request for a Fire Management Assistant Grant (FMAG) was submitted and approved by FEMA on February 27 for the Smokehouse Creek Fire (FM-5488-TX).

Mandatory evacuation orders were issued for Meadowlark, Arroyo Verde, Sage Mesa, Bugbee, Double Diamond, Arrowhead, Sanford, Miami, and Maverick Village. The city of Borger relocated the agriculture supply point from the current location at the Hutchinson County Airport to 407 Industrial Blvd in Borger. A shelter at the Johnson Park Youth Center in Borger remains open.

The 687 Reamer Fire burned 2,000 acres before joining the Smokehouse Creek Fire, 14 homes and seven outbuildings have been lost with 10% containment.

The Smokehouse Creek Fire has burned 1,078,638 acres with 87% containment. The cities of Canadian, Miami, and Skellytown have been secured with both fire lines and blackline fire breaks. The city of Glazier remains under a mandatory evacuation for all occupants.

Moore County: A request for a Fire Management Assistance Grant (FMAG) was submitted and later approved by FEMA on February 27 for the Windy Deuce Fire (FM-5487-TX).

The Windy Deuce Fire has burned 144,206 acres with 94% containment.

Ochiltree County: The mandatory evacuation order remains in effect for residents from HWY 83 North to South River Road, to the Ochiltree County line.

Potter County: Potter County issued a Letter to the Governor requesting a declaration of a state of emergency on February 27. The city of Amarillo issued a disaster declaration on February 27. A mandatory evacuation order was issued for Mesilla Park and a shelter is open at 1330 NW 18th Street. First Methodist Church of Amarillo has announced that the church is open to evacuees.

Randall County: Randall County issued a disaster declaration on February 27.

Roberts County: Roberts County issued a disaster declaration on February 27 and a Disaster Summary Outline on March 4.

Wheeler County: Wheeler County Judge issued a disaster declaration on February 29.

DD 2 – Lubbock (Includes Bailey, Cochran, Crosby, Dickens, Floyd, Garza, Hale, Hockley, King, Lamb, Lubbock, Lynn, Motley, Terry, and Yoakum Counties)

DDCEOC 2 activated at Level III at 8:00 AM on March 7.

RESPONDING STATE AGENCIES/ORGANIZATIONS REPORTS

Texas Division of Emergency Management, Texas A&M University System

(TDEM): TDEM worked with AgriLife Extension, Daisy Farms, and Logistics to move hay from Daisy Farms location to the Panhandle for the Animal Supply Centers. TDEM collaborated with Mass Care and Boeing to help them with a proposed monetary donation for the wildland fire response. Texas Oil and Gas Association (TXOGA) met with TDEM representatives to strengthen situational awareness for refineries located in the panhandle. TDEM alongside AgriLife contacted feed companies and big box retailers for donated resources designated for incident recovery.

TDEM has communicated with Private Sector Partners (HEB and Walmart) to obtain their response posture. This included a survey of the retail environment to obtain awareness for open and closed locations in the affected area. TDEM has worked with the Texas Food and Fuel Association to secure fuel in affected areas.

TDEM continues working with Mass Care and HEB to aid in maximizing their planned donations for the affected area and coordinating with Walmart regarding four associates affected by the wildfire in Fritch. Walgreens continues to provide information on the Smokehouse Creek Fire, and TDEM has connected the United Supermarkets with American Red Cross to support donations.

TDEM Communications Coordination Group (CCG): Cisco Systems is providing networking equipment and Starlink high performance units at the Incident Command Post (ICP) in Amarillo and to the (2) base camps in Borger and Canadian.

Amateur Radio operators (RACES/ARES) are supporting the Panhandle with the wildfire situation. Amateur Radio operators have identified personnel and resources to be deployed. High Frequency (HF) nets have been activated and are providing public service information to residents with amateur radios in isolated areas.

The Commission on State Emergency Communications (CSEC) reported Public Safety Access Points (PSAP) in the Panhandle have contingency plans in place to re-

route 9-1-1 calls. Circuits have been re-routed due to non-fire issues with back-up connections due to interruptions from high winds.

TDEM Communications Division will be supporting internal and external communications requests through the deployment of Iridium satellite phones and hand-held land mobile radios (LMR). Other Private Sector Partners have reached out to offer assistance and resources.

The National Emergency Management Response (NEMR) group has a communications platform deployed to the Borger Base Camp.

Texas A&M AgriLife Extension Service (AgriLife): AgriLife currently has six personnel working at the Pampa Animal Supply point, five personnel at the Borger Animal Supply Point, five personnel supporting the Canadian Animal Supply point, and one liaison at the Incident Support Team (IST). AgriLife is working with TAHC to identify potential haulers to get hay from supply points to ranchers that lost equipment in the fire. AgriLife agents continue assisting TAMFS and seven County Extension Agents to complete damage assessments. AgriLife is coordinating with Texas Search and Rescue (TEXSAR) to distribute resources to all three animal supply points. A total of 39 requests for AgriLife assistance have been received and were forwarded to AgriLife field representatives to contact the affected landowners.

A State of Texas Assistance Request (STAR) was submitted on behalf of the Gray County Judge by the AgriLife SOC Liaison Officer (LNO). The request was for Disaster, Assessment and Recovery (DAR) Agents to stand up and staff an Animal Supply Point and Shelter in response to the wildfires in the Texas Panhandle. AgriLife Extension Liaisons have participated in situational weather awareness call, tactics, and Industry stakeholder coordination call. AgriLife agents are operating a shelter and food distribution of 109 round bales, and 80 50lb. feed bags were distributed. AgriLife Extension DAR Communications continues to provide the public information and response materials via the news media and social media accounts. AgriLife developed a DAR publication *Returning Home After a Wildfire* hosted on the www.texashelp.tamu.edu website. A press release was made on <u>Recognizing Mental</u> Health Challenges and Symptoms following Wildfires.

Texas A&M Engineering Extension Service (TEEX/TX-PWRT): TEEX/TX-PWRT coordinated with Texas A&M AgriLife Extension for carcass remediation operations. A current total of twelve personnel for field response and one staff member at the SOC in Austin for Liaison and coordination of teams. One TEEX Liaison is on site in Amarillo (TDEM Region 1, District 1 DDEOC). The Liaison at the DDEOC and SOC are monitoring WebEOC for requests and attending briefings. Crews are currently adjusting staffing and equipment in preparation for demobilization on March 14.

Texas A&M Engineering Extension Service (TEEX) Texas Task Force 1 (TEEX/TX-TF1) and Texas Task Force 2 (TEEX/TX-TF2): TX-TF1 were authorized to demobilize resources and return to home stations on March 9. TEEX TX-TF1/2 have identified 1,700 structures damaged and 396 are classified as destroyed.

Texas A&M Forest Service (TAMFS): Local and State firefighters continue suppression efforts on large wildfires burning across the Texas Panhandle. Intense winds, dry conditions, and warm temperatures contribute to active fire behavior and growth.

Texas Animal Health Commission (TAHC): On March 8, TAHC added agricultural carcass disposal numbers reported by TX A&M AgriLife Extension. TAHC is actively coordinating with state veterinarian offices in New Mexico and Oklahoma to facilitate documenting interstate movement for livestock producers. TAHC has begun to distribute animal agriculture focused publications addressing carcass disposal guidance, state, and federal resources, and AgriLife supply point information.

TAHC is working with AgriLife Extension to incorporate animal agriculture losses from the drop location identified in Pampa and is communicating with the Texas and Southwest Cattle Raisers Association for numbers reported by producers. The total number of estimated reported animal losses to date is: 7,306.

Texas Commission on Environmental Quality (TCEQ): TCEQ has staff available to respond to any air/water/waste issues including drinking water and wastewater or emergency response. TCEQ staff continue to provide technical assistance on debris and waste management operations.

Texas Department of Public Safety (DPS): The DPS Aviation Operations Division remains on call for continued aerial assistance as requested.

Texas Highway Patrol (THP) Troopers alongside local and county law enforcement continued 24-hr security coverage for the city of Fritch. THP Troopers are conducting patrol duties and traffic control in Hemphill and Hutchinson County.

Texas Department of Transportation (TxDOT): TxDOT's guardrail contractor began repairs on March 11. TxDOT has provided photo documentation to AgriLife agents to identify livestock carcass removal and remediation in the state-owned rights-of-ways (ROWs) in support of efforts to positively identify livestock and match with ranch owners. Local crews in Hemphill County began repairs of delineation markers on March 6. TxDOT has provided responding agencies with a total of 1,495 gallons of fuel.

TxDOT contractors are aware of extensive damage and are working to replace the over 4,400 identified safety barriers, signs, delineators, and other roadway devices that were lost. Over 1,100 items were lost in the Windy Deuce fire and over 3,300

items were lost in the Smokehouse Creek fire. Local crews have begun recovery efforts and roadway restoration as materials become available and crews can safely enter. All major highways are open and flowing, however, motorists are encouraged to drive with caution and check <u>DriveTexas.org</u> for the most current road conditions, visibility warnings and road closures.

Texas Department of State Health Services (DSHS): Points of Contact (POC) for the Rapid Behavioral Health Assessment Team (RBHAT) and the HHSC Behavioral Health IC Team were established prior to their arrival in Amarillo on March 11. DSHS PHR 1 plans to provide tetanus shots and other public health services on March 15, at the Fritch Multiagency Resource Center (Hutchinson County) Time TBD, Celebration Family Church 811 E Broadway St., Fritch, TX 79036.

A request from TDEM Recovery was submitted for DSHS to present a Fire-Reentry Safety briefing targeting survivors and responders during the Recovery and Coordination call.

DSHS Texas Emergency Medical Task Force (DSHS/EMTF): EMTF-1 will remain on a standby with Wildland Fire Medical Support (WLFS) packages (PKG) prepositioned in Amarillo, Childress and Lubbock. 1 WLFS is prepositioned in Ozona, TDEM Region 7.

Texas Military Department (TMD): TMD CH-47 activated aircraft have flown a total of 59.8 hours and dropped a cumulative 100,800 gallons of water. TMD has one CH-47, two UH-60 rotary wing aircraft, and one UH-60 rotary wing aircraft with lift capabilities to support TX-TF1 medics in response to critical fire weather activated. One MQ-9 Remote Piloted Aircraft has been activated to provide aerial reconnaissance and situational awareness of fire operation. A LNO to TAMFS, a Winter Weather MRP and a SOC Support team are also activated in addition to the 25 TMD personnel and three aircraft activated.

Texas Health and Human Services Commission (HHSC): HHSC has deployed a 6-person Rapid Behavioral Health Assessment Team (RBHAT) to Amarillo to evaluate both the incident situation and to assess the behavioral health resources needed. HHSC has one liaison at the SOC and the 2-1-1 Texas Information and Referral Network is distributing relevant information about disaster response, including shelter locations.

Texas Department of Licensing and Regulation (TDLR): TDLR staff are at the SOC and stand ready to assist as requested.

American Red Cross (ARC): The Red Cross response has moved into the Recovery phase. Recovery teams will be positioned at key community locations to meet with survivors as they continue their recover journey. In the coming days, we will end our Mass Care and Distribution of Emergency Supplies (DES) operations.

Disaster assessment and DES is continuing in newly identified areas in Miami and rural Roberts County. We have 65 volunteers and staff now assigned to the operation.

ARC caseworkers are now working with individuals. One focus site to open cases is at the Celebration Friendship Church in Fritch. Individual disaster assistance casework is scheduled on 3/15-16 in Stinnett (First Baptist Church) and on 3/14-15 in Canadian (Hemphill County Exhibition Center).

We remain ready to open shelters should a new fire event develop given the forecast weather conditions.

ARC has planned to deliver DES in four ways: fixed sites, pop-ups, mobile routes, and in response to requests. ARC plans to continue to deliver DES in Fritch, Canadian, and mobile delivery of DES in Stinnett. ARC had services available in the communities of Borger and Fritch on March 9 for the family of fallen Chief Zeb Smith. ARC will be aiding clients with medical supply replenishment and emotional support needs.

Total Assessments: 965 Destroyed: 270 Major Damage: 0

The ARC has distributed 1,293 meals, 85 clean up kits, 15,219 DES, and 330 households have been provided with DES to date.

Texas Baptist Men (TBM): TBM has received requests for debris cleanup assistance and 40 pending cleanup requests for fire recovery, chainsaw, and heavy equipment. TBM Hay & Feed Team has collected donations and organized deliveries, including food pantry items, fuel, animal feed, and 300+ bales of hay. Services provided by TBM as of March 11, include a total of 5,601.5 hours logged by volunteers, 1,931 meals prepared, 80 damage assessments completed, 229 hours of heavy equipment operations, 371 showers, and 53 loads of laundry provided to volunteers and victims.

The Southern Baptist of Texas Convention (SBTC): SBTC has prepared 2,180 meals as of March 12. A Quick Response Feeding Unit continues to support the operation. Clean up and Recovery Units will work through March 14. SBTCS has received 47 work requests, 15 clean-up assistance jobs have been completed by SBTC, 12 clean-up assistance jobs were completed by other groups, provided 161 showers, cleaned 140 loads of laundry, and logged 159 hours for heavy equipment. STBC has 50 active volunteers and provided 3,452 volunteer hours. A total of 99 bales of hay have been donated.

The Salvation Army (TSA): As of March 11, TSA has distributed 2,104 meals, 2,192 snacks, 2,149 drinks, 203 comfort/hygiene kits, 190 Emotional & Spiritual Care (ESC) Contacts, 79 gift cards, 29 food boxes, 15 bibles, and 46 TSA store vouchers. ESC teams will continue to support the community through March 17. Operations have been turned over to the local units. The Borger Service Unit will participate in two upcoming Multi-Agency Resource Centers (MARC): one in Stinnett on March 14; one in Fritch on March 15.
