STATEWIDE CURRENT SITUATION:

On March 22, Governor Abbott directed the Texas Division of Emergency Management (TDEM) to activate state emergency response resources ahead of critical wildfire conditions anticipated for the Panhandle and West Texas over the weekend and into the beginning of the week.

On March 13, Governor Abbott announced that the U.S. Small Business Administration (SBA) has approved his request for disaster declarations in Texas communities affected by wildfires in the Panhandle. Texas counties included in the declarations are Armstrong, Carson, Donley, Gray, Hansford, Hemphill, Hutchinson, Lipscomb, Moore, Potter, Randall, Roberts, Sherman, and Wheeler.

The SBA has granted access to its Home Disaster Loans, Business Physical Disaster Loans, and Economic Injury Disaster Loan (EIDL) program, which will provide low-interest loans to qualifying homeowners, renters, and businesses in affected communities following the Smokehouse Creek Fire and the Windy Deuce Fire.

SBA representatives will open two Disaster Loan Outreach Centers to explain the application process, assist with completing applications, and address questions about the disaster loan programs.

Starting March 14, a Disaster Loan Outreach Center will be located at the Hemphill County Courthouse at 400 Main St. in Canadian, TX 79014, which will be open from 9 a.m. – 6 p.m. Mondays through Saturdays.

Starting March 14, a Disaster Loan Outreach Center will be located at The Dome Civic Center & Convention Center at 1113 Bulldog Blvd. in Borger, TX 79007, which will be open weekdays from 8 a.m. – 5 p.m. and from 9 a.m. – 6 p.m. on Saturdays.

OPERATIONAL PRIORITIES:

- 1. Protect life and property.
- 2. Support rapid & effective response.
- Collect and disseminate accurate incident information to improve decisionmaking.
- 4. Accurately track incident costs associated with assigned resources for cost recovery.

Region 1 (Includes DDs 1, 2, and 7)

DD 1 – Amarillo (Includes Armstrong, Briscoe, Carson, Castro, Childress, Collingsworth, Dallam, Deaf Smith, Donley, Gray, Hall, Hansford, Hartley, Hemphill, Hutchinson, Lipscomb, Moore, Ochiltree, Oldham, Parmer, Potter, Randall, Roberts, Sherman, Swisher, and Wheeler Counties)

DD 1 - Amarillo will activate to Level II (Escalated Response Conditions) on March 24, 2024, at 10:00 AM.

Carson County: A disaster declaration was issued for the entire county by the County Judge on February 28.

Childress County: Evacuated livestock are being housed at the Mashburn Event Center.

Gray County: Gray County issued a disaster declaration on February 28. County officials submitted a Disaster Summary Outline to TDEM on March 1.

The Grapevine Creek Fire has burned 34,883 acres and is 100% contained.

Hemphill County: Hemphill County submitted a Disaster Summary Outline to TDEM on March 3. Hemphill County issued a disaster declaration extension on March 17.

Hutchinson County: The County Judge issued a disaster declaration on February 27, a Disaster Summary Outline on March 1, an update submitted on March 2, a disaster declaration continuation, and Letter to the Governor on March 4. A request for a Fire Management Assistant Grant (FMAG) was submitted and approved by FEMA on February 27 for the Smokehouse Creek Fire (FM-5488-TX).

The Smokehouse Creek Fire has burned 1,078,638 acres with 100% containment.

Moore County: A request for a Fire Management Assistance Grant (FMAG) was submitted and later approved by FEMA on February 27 for the Windy Deuce Fire (FM-5487-TX). The Windy Deuce Fire has burned 144,206 acres with 100% containment.

Ochiltree County: The mandatory evacuation order remains in effect for residents from HWY 83 North to South River Road, to the Ochiltree County line.

Potter County: Potter County issued a Letter to the Governor requesting a declaration of a state of emergency on February 27. The city of Amarillo issued a disaster declaration on February 27.

Randall County: Randall County issued a disaster declaration on February 27.

Roberts County: Roberts County issued a disaster declaration on February 27 and a Disaster Summary Outline on March 4.

Wheeler County: Wheeler County Judge issued a disaster declaration on February 29.

DD 2 – Lubbock (Includes Bailey, Cochran, Crosby, Dickens, Floyd, Garza, Hale, Hockley, King, Lamb, Lubbock, Lynn, Motley, Terry, and Yoakum Counties)

DD 2 Lubbock will activate to Level III (Increased Readiness Conditions) on March 24, 2024, at 10:00 AM.

Region 7 (Includes DDs 8, 9, and 10)

DD 8 – El Paso (Includes Brewster, Culberson, El Paso, Hudspeth, Jeff Davis, and Presidio Counties)

DD 8 El Paso will activate to level III (Increased Readiness Conditions) on March 24, 2024, as a hybrid activation.

DD 9 – Midland/Ft. Stockton (Includes Andrews, Borden, Crane, Dawson, Ector, Gaines, Glasscock, Howard, Loving, Martin, Midland, Pecos, Reeves, Terrell, Upton, Ward, and Winkler Counties)

DD 9 El Midland/Ft. Stockton will activate to level III (Increased Readiness Conditions) on March 24, 2024, as a hybrid activation.

DD 10 – San Angelo (Includes Coke, Concho, Crockett, Irion, Kimble, Mason, McCulloch, Menard, Reagan, Schleicher, Sterling, Sutton, and Tom Green Counties) DD 10 San Angelo will activate to level III (Increased Readiness Conditions) on March 24, 2024, as a hybrid activation.

RESPONDING STATE AGENCIES/ORGANIZATIONS REPORTS

Texas Division of Emergency Management, Texas A&M University System (TDEM): TDEM coordinated with Agriculture and Natural Resources, AgriLife, and various private sector partners to process donated fencing equipment for the Animal Supply Points in Region 1. TDEM alongside AgriLife contacted feed companies and big box retailers for donated resources designated for incident recovery.

TDEM Communications Coordination Group (CCG): Cisco Systems is providing networking equipment and Starlink high performance units at the Incident Command Post (ICP) in Amarillo. CCG is supporting internal and external communications requests through the deployment of Iridium satellite phones and hand-held land mobile radios (LMR). The National Emergency Management Response (NEMR) group has a communications platform deployed to the Borger Base Camp.

Texas A&M AgriLife Extension Service (AgriLife): AgriLife Liaison (LNO) coordinated with TDEM and Texas Department of Agriculture (TDA) to secure additional funding for hay and feed transport to the Panhandle Animal Supply Points. The LNO also made contact with agriculture industry partners to secure fencing and supply donations at the Texas Southwestern Cattle Raisers Association convention. DAR and Community Extension Agents (CEA) Strike Team personnel in Gray, Hemphill, Hutchinson, and Roberts counties will demobilize March 30, and the management of the Animal Supply Points will be turned over to the local CEAs for distribution of supplies, on April 1. Four DAR agents located in the North Region will continue to provide support to the CEAs as needed. AgriLife has two personnel working at the Pampa Animal Supply point, one person working at the Borger Animal Supply Point, and two personnel supporting the Miami satellite distribution site. The remaining personnel supporting the Canadian Animal Supply Point have been released. A total of 39 requests for AgriLife assistance have been received and were forwarded to AgriLife field representatives to contact the affected landowners.

AgriLife developed a Disaster Recovery Agents (DAR) publication *Returning Home After a Wildfire* hosted on the www.texashelp.tamu.edu website. A press release was made on <u>Recognizing Mental Health Challenges and Symptoms following</u> Wildfires.

Texas A&M Forest Service (TAMFS): TAMFS will maintain their resources comprising of out-of-state and TAMFS equipment in Region 1. TIFMAS resources are staged in the following locations: two strike teams (ST) to Amarillo (ST 130/131), two strike teams to Lubbock (ST133/134), one strike team to Childress (ST132), one strike team to Big Spring (ST135), and one strike team to Alpine (ST136). Each ST is comprised of four Type VI Engines, one Type III Engine, and a Strike Team Leader (STEN). ST 136 will have two Type III's Engines and three Type VI Engines and a STEN.

Texas Animal Health Commission (TAHC): TAHC distributed livestock focused publications addressing carcass disposal guidance, state, and federal resources, and AgriLife supply point information. The total number of estimated reported animal losses to date is: 7,350.

Texas Commission on Environmental Quality (TCEQ): TCEQ has staff available to provide technical assistance on debris and waste management operations and to respond to any air/water/waste issues including drinking water and wastewater or emergency response.

Texas Department of Transportation (TxDOT): Motorists are encouraged to drive with caution and check <u>DriveTexas.org</u> for the most current road conditions, visibility warnings and road closures.

Texas Department of State Health Services (DSHS): The State Medical Operations Center remains activated.

DSHS Texas Emergency Medical Task Force (DSHS/EMTF): Three Wildland Fire Support (WLFS) packages and a Rapid Extraction Module (REM) are in Childress, Fort Stockton, and Lubbock due to elevated fire conditions. One WLFS package remains in Amarillo.

Texas Military Department (TMD): TMD has activated two UH-60 rotary wing aircraft crews to provide direct support to TAMFS with aerial fire suppression capability in response to the critical fire weather.

American Red Cross (ARC): ARC has provided 332 households with DES to date. Individual assistance has been provided to 74 cases. Total Assessments: 1,004 Destroyed: 280

Texas Baptist Men (TBM): TBM has received requests for debris cleanup assistance for fire recovery, chainsaw, and heavy equipment crews. TBM Hay & Feed Team has collected donations of 300+ bales of hay and animal feed. TBM organized deliveries, including food pantry items, and fuel to affected residents. TBM has completed 136 work requests. All donations collected have been distributed and public laundry services have ended. TBM is scheduled to leave the panhandle on March 27.

The Southern Baptist of Texas Convention (SBTC): SBTC will deactivate all personnel and resources on March 23, and release volunteers to return home. SBTC has prepared 3,021 meals as of March 21. SBTC has received 52 work requests, 30 requests have been completed by SBTC, and 21 were completed by other groups. A

total of 892 bales of hay have been donated. SBTC has provided 370 showers, cleaned 294 loads of laundry, and logged 357 hours for heavy equipment. STBC has 22 active volunteers accounting for 6,070 hours.
