- Slight to Enhanced risk of severe thunderstorms (wind, hail and tornadoes) over OK, NW AR, and NTX.
- Minor river flooding continues in ETX, LA, and AR.




Minor river flooding continues in ETX, LA, AR.







Today's Tornado & Severe Wind / Hail Probabilities





Fire Weather Outlooks








April 8, 2024 Eclipse Cloud Cover
