#### **STATEWIDE CURRENT SITUATION:**

On April 5, TDEM announced <u>activation of state emergency response resources</u> in anticipation of critical fire weather conditions expected for the western half of the state beginning Friday and lasting through the weekend.

On March 28, Governor Abbott renewed his Wildfire Disaster Declaration for the Texas Panhandle and other counties currently identified as in drought or severe wildfire risks. Those counties listed in the declaration include Archer, Armstrong, Bailey, Baylor, Briscoe, Carson, Castro, Childress, Cochran, Collingsworth, Cottle, Crosby, Dallam, Deaf Smith, Dickens, Donley, Fannin, Floyd, Foard, Garza, Gray, Gregg, Hale, Hall, Hansford, Hardeman, Harrison, Hartley, Haskell, Hemphill, Hockley, Hutchinson, Kent, King, Knox, Lamb, Lipscomb, Lubbock, Lynn, Moore, Motley, Nacogdoches, Newton, Ochiltree, Oldham, Parmer, Potter, Randall, Roberts, Sherman, Stonewall, Swisher, Terry, Throckmorton, Upshur, Wheeler, Wichita, Wilbarger, Yoakum, and Young Counties.

On March 22, Governor Abbott directed the Texas Division of Emergency Management (TDEM) to activate state emergency response resources ahead of critical wildfire conditions anticipated for the Panhandle and West Texas over the weekend and into the beginning of the week.

On March 13, Governor Abbott announced that the U.S. Small Business Administration (SBA) has approved his request for disaster declarations in Texas communities affected by wildfires in the Panhandle. Texas counties included in the declarations are Armstrong, Carson, Donley, Gray, Hansford, Hemphill, Hutchinson, Lipscomb, Moore, Potter, Randall, Roberts, Sherman, and Wheeler. The SBA has granted access to its Home Disaster Loans, Business Physical Disaster Loans, and Economic Injury Disaster Loan (EIDL) program, which will provide low-interest loans to qualifying homeowners, renters, and businesses in affected communities following the Smokehouse Creek Fire and the Windy Deuce Fire.

**Hemphill County:** A Disaster Loan Outreach Center is located at the Hemphill County Courthouse at 400 Main St. in Canadian, TX 79014, which will be open from 9 a.m. – 6 p.m. Mondays through Saturdays.

**Hutchinson County:** A Disaster Loan Outreach Center is located at the Dome Civic Center & Convention Center at 1113 Bulldog Blvd. in Borger, TX 79007, which will be open from 9 a.m. – 6 p.m. Mondays through Saturdays.

A Disaster Loan Outreach Center is located at the Celebration Family Church, West Room, at 811 E Broadway Street, Fritch, TX 79306, which will be open from 9 a.m. – 6 p.m. Mondays through Saturdays.

### **OPERATIONAL PRIORITIES:**

- 1. Protect life and property.
- 2. Support rapid & effective response.
- 3. Collect and disseminate accurate incident information to improve decisionmaking.
- 4. Accurately track incident costs associated with assigned resources for cost recovery.

DD 1 – Amarillo (Includes Armstrong, Briscoe, Carson, Castro, Childress, Collingsworth, Dallam, Deaf Smith, Donley, Gray, Hall, Hansford, Hartley, Hemphill, Hutchinson, Lipscomb, Moore, Ochiltree, Oldham, Parmer, Potter, Randall, Roberts, Sherman, Swisher, and Wheeler Counties): Level III (Increased Readiness Conditions)

DD 2 – Lubbock (Includes Bailey, Cochran, Crosby, Dickens, Floyd, Garza, Hale, Hockley, King, Lamb, Lubbock, Lynn, Motley, Terry, and Yoakum Counties): Level III (Increased Readiness Conditions)

**Carson County:** A Disaster Declaration was submitted by the County Judge on February 28.

**Gray County:** Gray County submitted a Disaster Declaration on February 28 and Disaster Summary Outline to TDEM on March 1.

**Hemphill County:** Hemphill County submitted a Disaster Summary Outline to TDEM on March 3 and a Disaster Declaration extension on March 17.

**Hutchinson County:** The County Judge submitted a Disaster Declaration on February 27 and a Disaster Summary Outline on March 1. A Disaster Declaration continuation and a Letter to the Governor was submitted on March 4. A Fire Management Assistant Grant (FMAG) was submitted and approved by FEMA on February 27 for the Smokehouse Creek Fire (FM-5488-TX).

**Moore County:** A Fire Management Assistance Grant (FMAG) was submitted and later approved by FEMA on February 27 for the Windy Deuce Fire (FM-5487-TX).

**Potter County:** Potter County submitted a Disaster Declaration and a Letter to the Governor on February 27. The city of Amarillo submitted a Disaster Declaration on February 27.

**Randall County:** Randall County submitted a Letter to the Governor on February 27.

**Roberts County:** Roberts County submitted a Disaster Declaration on February 27, and a Disaster Summary Outline on March 4.

**Wheeler County:** Wheeler County Judge submitted a Disaster Declaration on February 29.

# Region 7 (Includes DDs 8, 9A, 9B, and 10)

DD 9 – Midland/Ft. Stockton (Includes Andrews, Borden, Crane, Dawson, Ector, Gaines, Glasscock, Howard, Loving, Martin, Midland, Pecos, Reeves, Terrell, Upton, Ward, and Winkler Counties): Level III (Increased Readiness Conditions)

# **RESPONDING STATE AGENCIES/ORGANIZATIONS REPORTS**

**Texas Division of Emergency Management, Texas A&M University System (TDEM):** TDEM coordinated with Agriculture and Natural Resources, AgriLife, and various private sector partners to process donated fencing equipment for the Animal Supply Points in Region 1.

**TDEM Communications Coordination Group (CCG):** CCG is supporting internal and external communications requests through the deployment of Iridium satellite phones and hand-held land mobile radios (LMR).

**Texas A&M AgriLife Extension Service (AgriLife):** The Animal Supply Points (ASP) are operating with the resident County Extension Agent (CEA) and one DAR agent. The DAR unit will continue to assist CEA with the ASP until the end of April.

AgriLife developed a Disaster Recovery Agents (DAR) publication *Returning Home After a Wildfire* hosted on the www.texashelp.tamu.edu website. A press release was made on <u>Recognizing Mental Health Challenges and Symptoms following</u> <u>Wildfires</u>. **Texas A&M Forest Service (TAMFS):** TFS will maintain a resource footprint in regions 1 and 7 that will be comprised of both out-of-state and TFS equipment. TIFMAS resources are staged in the following locations: 1 strike team in Alpine (ST136), 1 strike team in Big Spring (ST152), 1 EMTF in Amarillo and 1 EMTF with REM located in Ft. Stockton.

**Texas Animal Health Commission (TAHC):** The total number of estimated reported animal losses to date is: 7,350. See the <u>TAHC Natural Disasters webpage</u> for updated information and resources for the 2024 Texas Panhandle Wildfires.

**Texas Commission on Environmental Quality (TCEQ):** TCEQ has staff available to provide technical assistance on debris and waste management operations and to respond to any air/water/waste issues including drinking water and wastewater or emergency response.

**Texas Department of Transportation (TxDOT):** Motorists are encouraged to drive with caution and check <u>DriveTexas.org</u> for the most current road conditions, visibility warnings and road closures.

**Texas Department of State Health Services (DSHS):** The State Medical Operations Center remains activated.

**DSHS Texas Emergency Medical Task Force (DSHS/EMTF):** Two Wildland Fire Support (WLFS) packages and a Rapid Extraction Module (REM) remain in Amarillo and Fort Stockton due to elevated fire conditions.

**American Red Cross (ARC):** ARC has provided 332 households with DES. Individual assistance has been provided to 74 cases.
