Summary of the Upcoming Week

- Slight risk of heavy rainfall/flash flooding for S OK,W/N/Ctrl/SETX today and for E OK, N/Ctrl/E/SETX, AR, NW LA on Sunday. Heavy rain threat continues for AR/OK Monday through Wednesday.
- Slight/Enhanced risk of severe storms for SE NM, WTX today and OK, NTX on Monday. Slight risk for SE OK, NETX, AR on Tuesday and for N/Ctrl/ETX, S/E **OK, AR, NW LA on Wednesday.**
- Critical fire weather conditions for NM on Sunday expanding into Far WTX, **TX/OK Panhandles Monday/Tuesday/Wednesday.**
- Moderate to major river flooding continues across E/SETX into next week with some isolated record setting levels this weekend.






Today's Tornado & Severe Wind / Hail Probabilities






Tomorrow's Tornado & Severe Wind / Hail Probabilities




