## Summary of the Upcoming Week

- Flash flood threat near burn scar areas across NM through the weekend.
- Slight risk of severe storms with heavy rain across NE OK and NAR.
- Excessive heat across much of FEMA Region 6 through Friday.
- Tropics
  - Hurricane Beryl will continue to move toward the Yucatan Peninsula and into the Bay of Campeche by the weekend. Landfall as a hurricane in NE Mexico/STX late Sunday into Monday.
    - No impacts to FEMA Region 6 through Saturday. Monitor for impacts to FEMA Region 6.
  - Low chance...20%... for tropical development in the western Atlantic in the next seven days.
    - No impacts expected to FEMA Region 6.







Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall




Isolated minor flooding in **SETX**.










Flash flooding across burn scar areas in NM.

Marginal risk of heavy rain across TX and LA.




## Tomorrow's Tornado & Severe Wind / Hail Probabilities













Green	Little to None Safety: Rarely a Direct Threat to Life and Property Impact Potential: Typically Results in Little Inconvenience to Daily Routines	Severe: Marginal Risk from SPC Flooding: Minor flooding expected over localized areas Tropical: None Fire Weather: No Watches/Warnings, fuel moisture above 10% or green up active	Thunderstorms expected over LA this afternoon; a few may produce winds to knock down a few trees  Something that happens almost every day in a particular season such as seabreeze storms in coastal TX

Purple	Extreme Safety: Property Damage Unavoidable, Immediate Action to Save Life will be Needed Impact Potential: Typically Results in Long-Lived Widespread Major Disruption to Daily Life	Severe: High Risk from SPC Flooding: Major flooding expected over a widespread area (including urban locations) Tropical: A Major Hurricane (Cat3 or greater) expected to move towards or near any coastline Fire: Large area of critical conditions for 2 or more days, Warnings for 3 or more days, Long term (months) of severe to extreme drought	<ul> <li>A Category 4 hurricane is headed towards the SE LA; major storm surge, flooding and damaging winds anticipated to begin tomorrow</li> <li>Widespread severe storms expected, tornado outbreak probable with long- lived, very widespread and particularly intense storms</li> </ul>
