- Flash flood threat near burn scar areas across NM through the weekend.
- Marginal to slight risk for severe storms across E NM and the TX/OK **Panhandles through Sunday.**
- Beryl is moving over the Gulf of Mexico at 12 mph. Landfall as a hurricane along the Middle/upper TX coast on Monday.
 - **Tropical Storm Force Winds most likely arrive by Sunday evening.**
 - Heavy rainfall/flash flooding across SETX early next week.
 - Increasing risk for isolated tornadoes, storm surge and rip currents.










Hurricane Beryl










Today's Tornado & Severe Wind / Hail Probabilities





Tomorrow's Tornado & Severe Wind / Hail Probabilities









"Day 8-14" Hazards Outlook







