- Slight risk of excessive rainfall over NM burns scars through next week.
- Elevated heat conditions today over OK and NWTX today and over LA Wed/Thu.
- Elevated risk for significant wildfires across SW OK, NW TX today with gradually improving conditions through mid-week.
- Marginal risk for severe storms today over NM into the TX/OK Panhandles
- No tropical impacts to FEMA 6 expected for the next 7 days.








Today's Tornado & Severe Wind / Hail Probabilities






Tomorrow's Tornado & Severe Wind / Hail Probabilities







"Day 3-7" Hazards Outlook





"Day 8-14" Hazards Outlook
















Space Weather 3-Day Forecast
