**STATEWIDE CURRENT SITUATION:** On September 10, Governor Abbott provided updates on Texas' preparation efforts ahead of Tropical Storm Francine following two briefings with state and local officials at the State Operations Center (SOC) in Austin and at the Beaumont Emergency Operations Center (EOC) in Beaumont. Texans along the coast should prepare for heavy rain, flash flooding, high winds, and possible tornadoes starting on September 10.

On September 8, Governor Abbott directed the Texas Division of Emergency Management (TDEM) to activate additional state emergency response resources ahead of potential impacts from tropical activity in the Gulf of Mexico.

On September 5, Texas emergency management officials <u>deployed additional state</u> <u>emergency response resources</u> amid rainfall, flash flooding, and tropical weather threats. These assets are activated in addition to the state emergency response resources already deployed and responding to continuing heavy rainfall and flash floods across Texas.

#### **OPERATIONAL PRIORITIES:**

- 1. Protect life and property.
- 2. Support rapid & effective response.
- 3. Collect and disseminate accurate incident information to improve decisionmaking.

4. Accurately track incident costs associated with assigned resources for cost recovery.

# **Region 3 (Includes DDs 5, 6, 14, and 15)**

DD 15 – Beaumont (Includes Hardin, Jefferson, and Orange Counties)

Disaster District Emergency Operations Center (DDEOC) 15 returned to Level IV (Normal Conditions) on September 11.

# Region 4 (Includes DD 16)

DD 16 – Houston (Includes Austin, Brazoria, Chambers, Colorado, Fort Bend, Galveston, Harris, Liberty, Matagorda, Montgomery, Walker, Waller, and Wharton Counties)

DDEOC 16 returned to Level IV on September 11.

Galveston County: A voluntary evacuation order was issued for the Bolivar Peninsula from 8 AM September 10 to 8 PM September 11.

## Region 5 (Includes DDs 19-21)

DD 20 – Corpus Christi (Includes Aransas, Bee, Brooks, Duval, Jim Wells, Kenedy, Kleberg, Live Oak, Nueces, Refugio, and San Patricio Counties)

DDEOC 20 returned to Level IV on September 11.

DD 21 - Weslaco (Includes Cameron, Hidalgo, and Willacy Counties)

DDEOC 21 returned to Level IV on September 11.

Cameron County: Local jurisdictions have reported some nuisance flooding, sporadic power outages, and some trees in roadways. No evacuations or rescues have been reported.

## Region 6 (Includes DDs 17, 18A, 18B, and 24)

DD 17 – Victoria (Includes Calhoun, DeWitt, Goliad, Gonzales, Lavaca, Jackson, and Victoria Counties)

DDEOC 17 returned to Level IV on September 11.

#### **RESPONDING STATE AGENCIES/ORGANIZATIONS REPORTS**

Texas Division of Emergency Management, Texas A&M University System (TDEM):

Communications Coordination Group (CCG): CCG partners continue to prepare resources to respond if necessary. The public, private and volunteer sectors have adjusted their resources for this weather event. The Commission on State Emergency Communications (CSEC) and Texas Telecommunications Emergency Response Taskforce (TX TERT), reached out to the Public Safety Access Points (PSAP) in the potentially impacted areas to determine possible needs. Cellular providers have secured backup resources and are monitoring their networks. The FirstNet Authority has coordinated response with private sector and federal partners. Land Mobile Radio (LMR) communications platforms are on standby. The Texas HF 7290 Traffic Net, which supports multiple Federal Emergency Management Agency (FEMA) Region 6 states, was on standby to assist Texas Radio Amateur Civil Emergency Services (RACES) and The Amateur Radio Emergency Services (ARES) operations should conditions warrant a response. Discussions and planning are ongoing with FEMA Cybersecurity and Infrastructure Security Agency (CISA) and the Federal Communications Commission (FCC) regarding possible support.

**Texas A&M AgriLife Extension Service (AgriLife):** The AgriLife Disaster Assessment and Recovery (DAR) Unit is monitoring Tropical Storm Francine and DAR Agents have sent out weather information to officials in the affected counties. DAR Agents are on standby effective September 9. AgriLife Liaison Officers (LNO) have been activated and sent to the SOC and RELLIS IST (Incident Support Team). The AgriLife DAR Public Information Officer (PIO) is disseminating public messaging from TDEM regarding tropical storm preparedness and response. AgriLife is working with the Texas Animal Health Commission (TAHC) and Texas Department of Agriculture (TDA) for any agricultural or animal issues.

Director Dr. Rick Avery and Associate Director Dr. Angela Burkham briefed Governor Abbott at the SOC on all the efforts made by AgriLife prior to the press conference on September 10.

**Texas A&M Engineering Extension Service (TEEX):** Texas A&M Engineering Extension Service (TEEX) / Texas A&M Public Works Response Team (TX-PWRT) continues to support and coordinate operations from the SOC and various DDEOCs serving as ESF-3.

**Texas A&M Engineering Extension Service Texas Task Force 1 (TEEX/TX-TF1):** On September 10, TX-TF1 linked-up with TIFMAS, EMTF, and TMD to consolidate the response footprint for multiple areas. Hurricane Francine has begun to turn toward the East, leading to a reduction in threats to the Texas Gulf Coast. All resources will maintain their current positions in case the hurricane makes an unexpected turn, or the State of Louisiana requests assistance from Texas. TX-TF1 resources are engaging with local resources to learn where the traditional problem areas are located and how local authorities plan to respond.

**Texas A&M Forest Service (TAMFS):** TAMFS has two Texas Intrastate Fire Mutual Aid System (TIFMAS) All-Hazard Strike Teams (ST) positioned in Beaumont

and Tyler. Two TIFMAS STs were released on September 11. The Five All-Hazard Incident Management Team (AHIMT) members assigned to support DDEOC 16 Houston were cancelled enroute. TAMFS has assigned LNOs to the SOC. One TAMFS LNO and one TIFMAS LNO have been assigned to RELLIS.

#### **Other State Agencies**

**Texas Animal Health Commission (TAHC):** TAHC has contacted local producers to ensure appropriate measures for basic storm preparedness and communication has been made with livestock deputies and CEAs. The TAHC PIO has been engaged with TDEM sharing social media updates.

**Texas Commission on Environmental Quality (TCEQ):** TCEQ has teams available to respond to any air/water/waste related issues including drinking water/wastewater and emergency response.

**Texas Department of State Health Services (DSHS):** The State Medical Operations Center (SMOC) is at Increased Readiness with 22 personnel. DSHS is monitoring the weather situation and contacting partners for the incoming weather systems. DSHS has begun to release resources.

**Texas Education Agency (TEA):** TEA and TDEM have been in communication with the appropriate Education Service Centers (ESCs) and University Systems and will continue to maintain contact throughout the event.

**Texas Health and Human Services Commission (HHSC):** HHSC has one LNO supporting the SOC. There have been no reports of long-term care (LTC) facilities, acute healthcare facilities, or state operated facilities being impacted by the incoming weather. Vendors for emergency ice and water are on standby.

**Texas Military Department (TMD):** TMD has activated 152 personnel, 31 vehicles and two aircraft for this event.

**Texas Parks and Wildlife Department (TPWD):** TPWD has prepared department resources consisting of Texas Game Wardens and State Park Police Officers, equipped with swift water boats and shallow water boats to support rescue operations. TPWD personnel are continually being advised of the current weather conditions and are maintaining a state of readiness. TPWD is working closely with the SOC to ensure TPWD Search and Rescue (SAR) resources and first responders are available.

# **Federal Agencies**

**United States Coast Guard (USCG) Port of Corpus Christi:** Due to the increased intensity of Tropical Storm Francine, the USCG Captain of the Port of Corpus Christi (COTP) has set Port Condition Yankee for the Ports of Brownsville, Mansfield, Harlingen, and Port Isabel, effective 11 AM on September 9. Port Condition X-ray will remain in effect for all other ports in the COTP zone area of

responsibility from the Colorado Locks to Corpus Christi (including the ports of Port Lavaca-Point Comfort, Palacios, Victoria, and West Calhoun).

**United States Coast Guard (USCG) Sector Houston-Galveston:** The COTP has set Port Condition Yankee for the ports of Houston, Galveston, Freeport, and Texas City on September 9.

# **Volunteer Organizations Active in Disasters (VOAD)**

**American Red Cross (ARC):** On September 10, ARC initiated a Disaster Response Operation for Hurricane Francine and established an office in Houston. ARC has four shelters on standby in the cities of Nederland, Jasper, Newton, and Orange.
