# Summary of the Upcoming Week

- Slight risk for heavy rain/flash flooding across the NM burn scars today.
- Marginal risk of severe weather (hail/winds) over N NM,TX/OK Panhandles today and over W OK,TX Panhandle on Wednesday.
- Tropical Storm Gordon remains in the central Atlantic for the next several days.
   No impacts to FEMA 6.

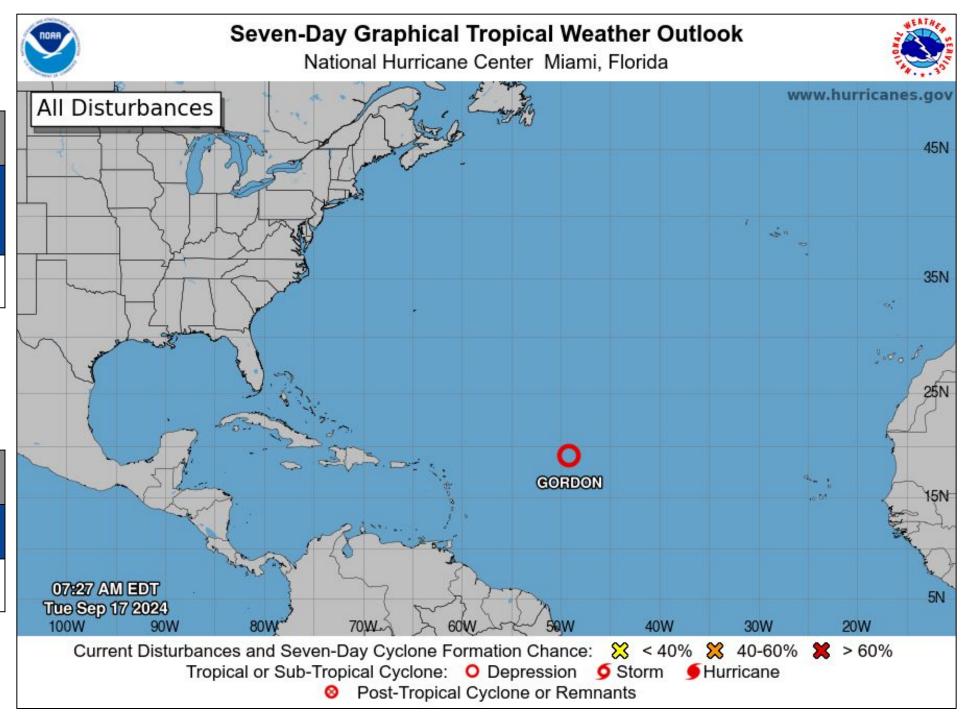

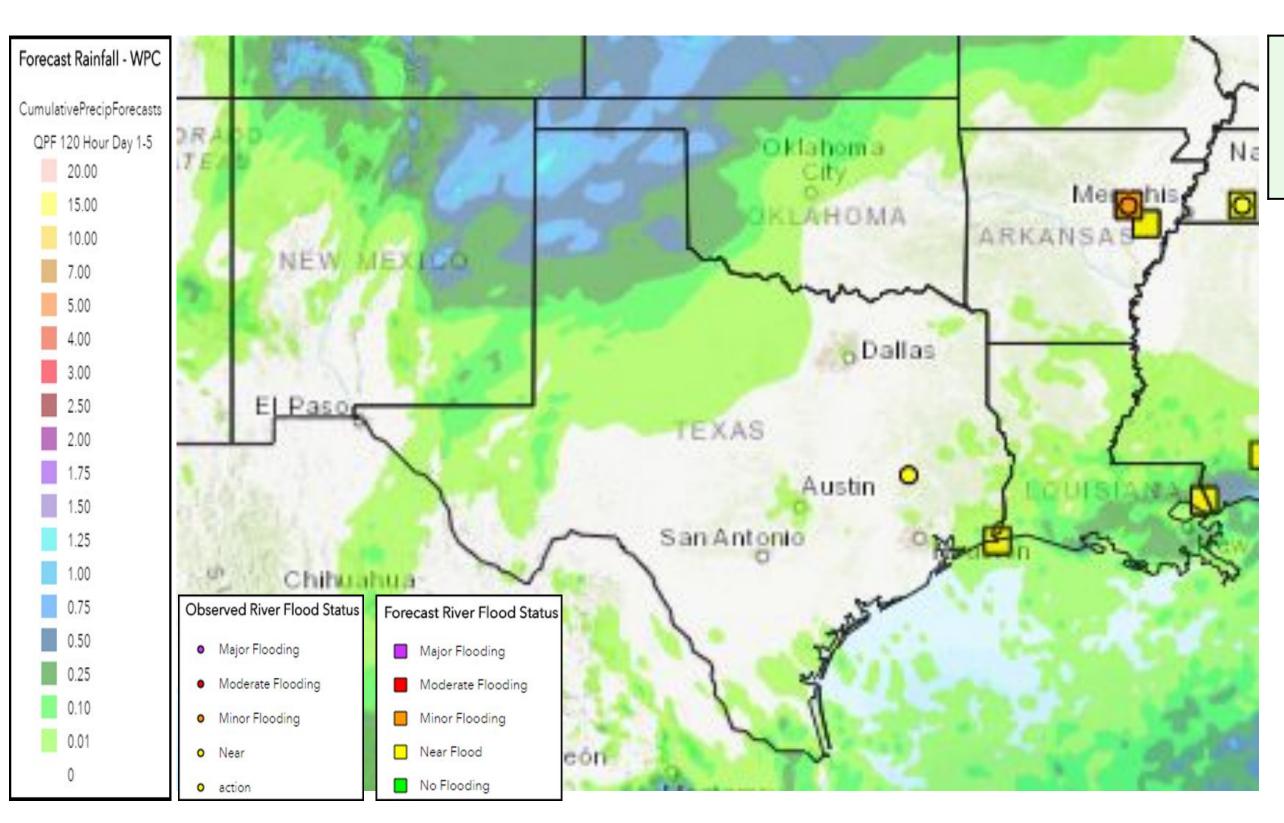

#### 5-Day Precipitation Forecast & River Flood Status

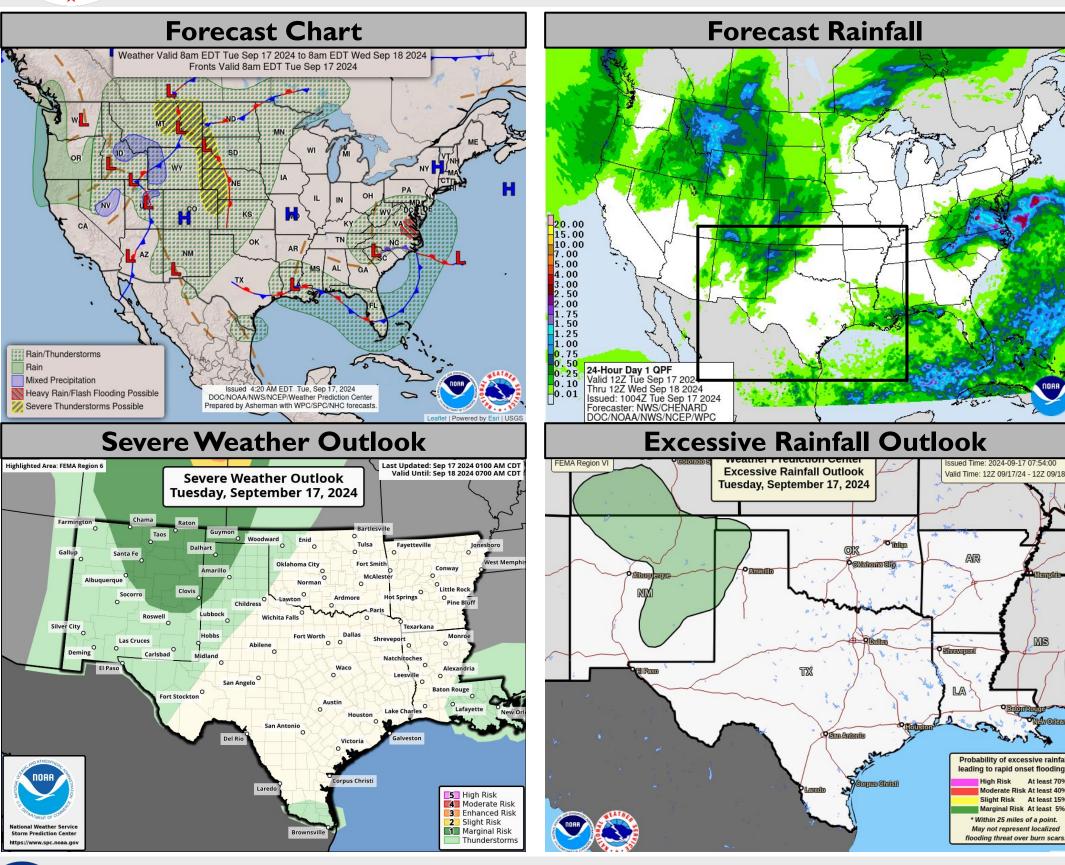
Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall

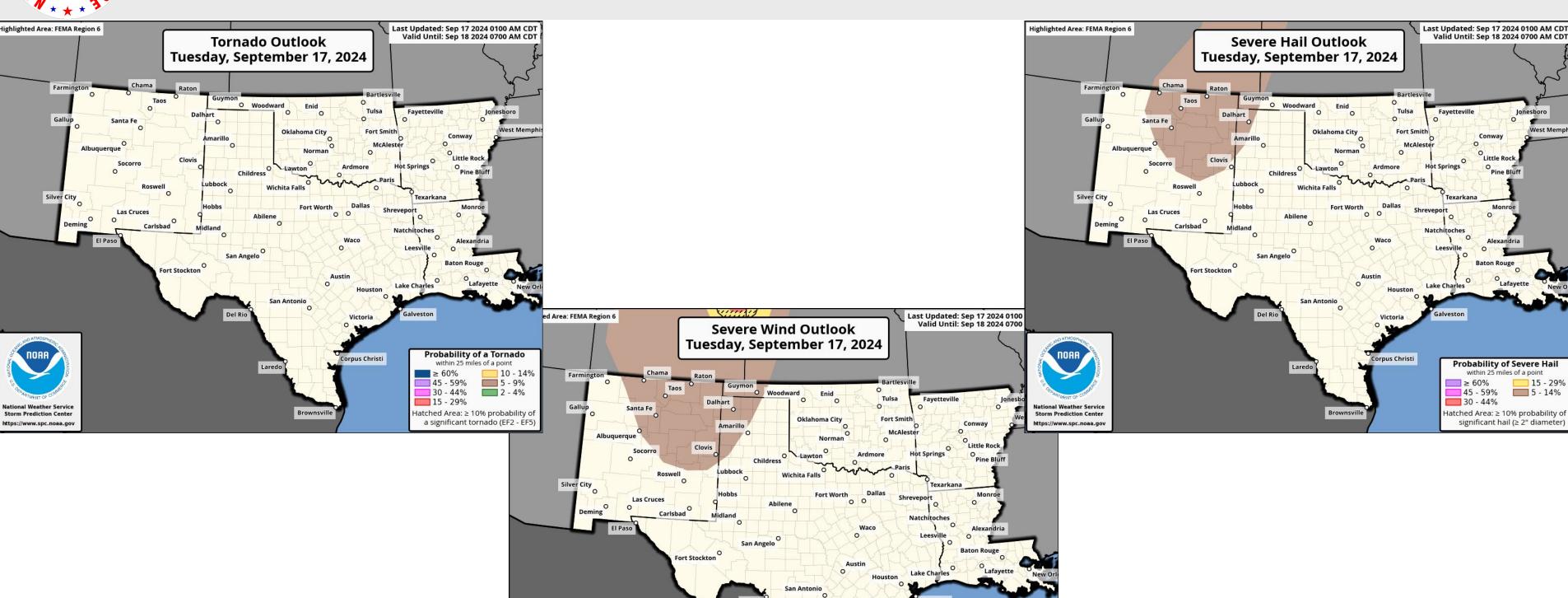

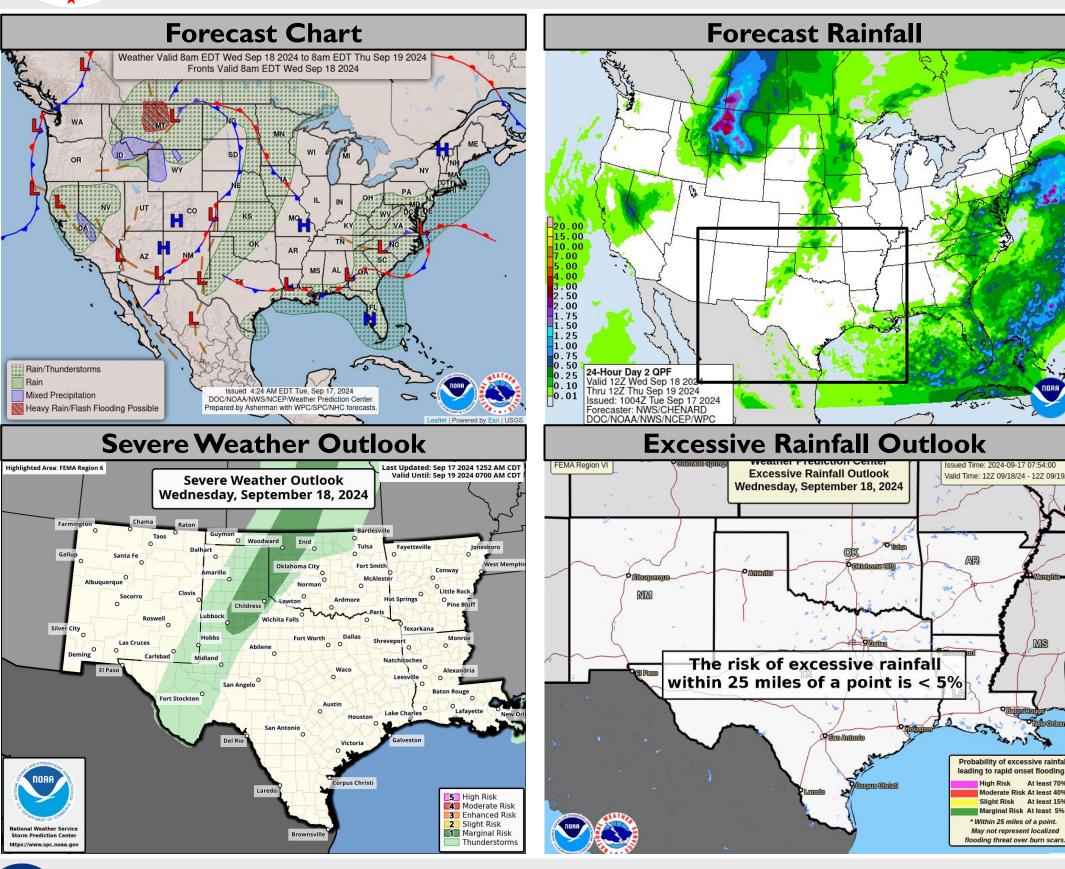

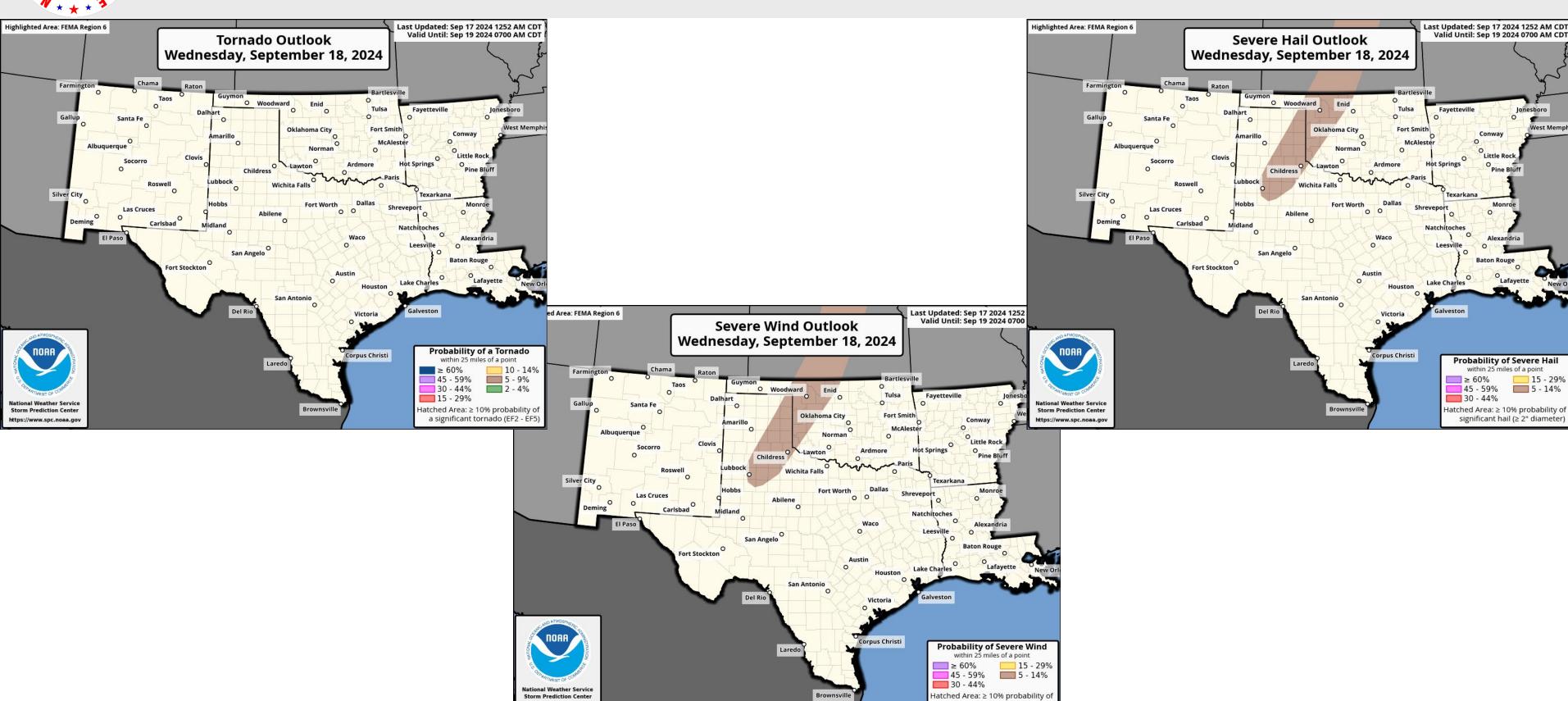

#### Tomorrow's Tornado & Severe Wind / Hail Probabilities

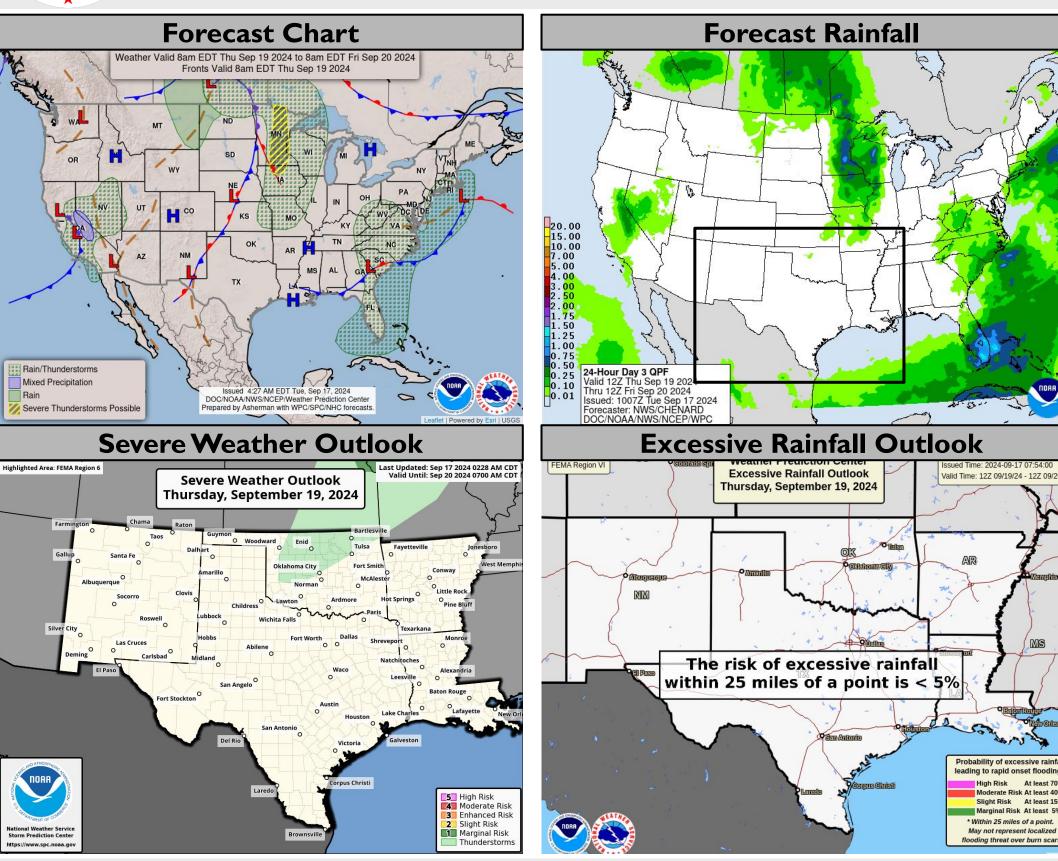

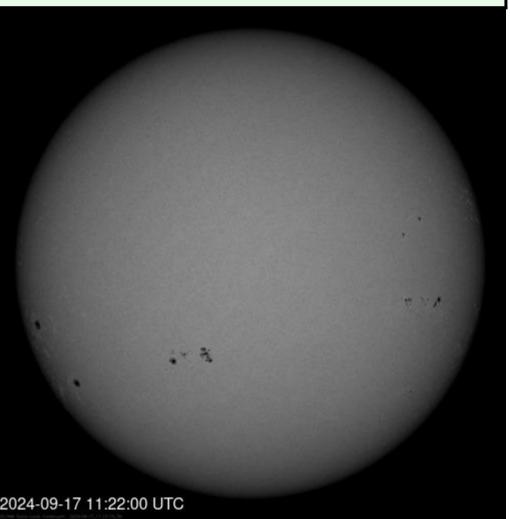

Green	Little to None Safety: Rarely a Direct Threat to Life and Property Impact Potential: Typically Results in Little Inconvenience to Daily Routines	Severe: Marginal Risk from SPC Flooding: Minor flooding expected over localized areas Tropical: None Fire Weather: No Watches/Warnings, fuel moisture above 10% or green up active	Thunderstorms expected over LA this afternoon; a few may produce winds to knock down a few trees  Something that happens almost every day in a particular season such as seabreeze storms in coastal TX

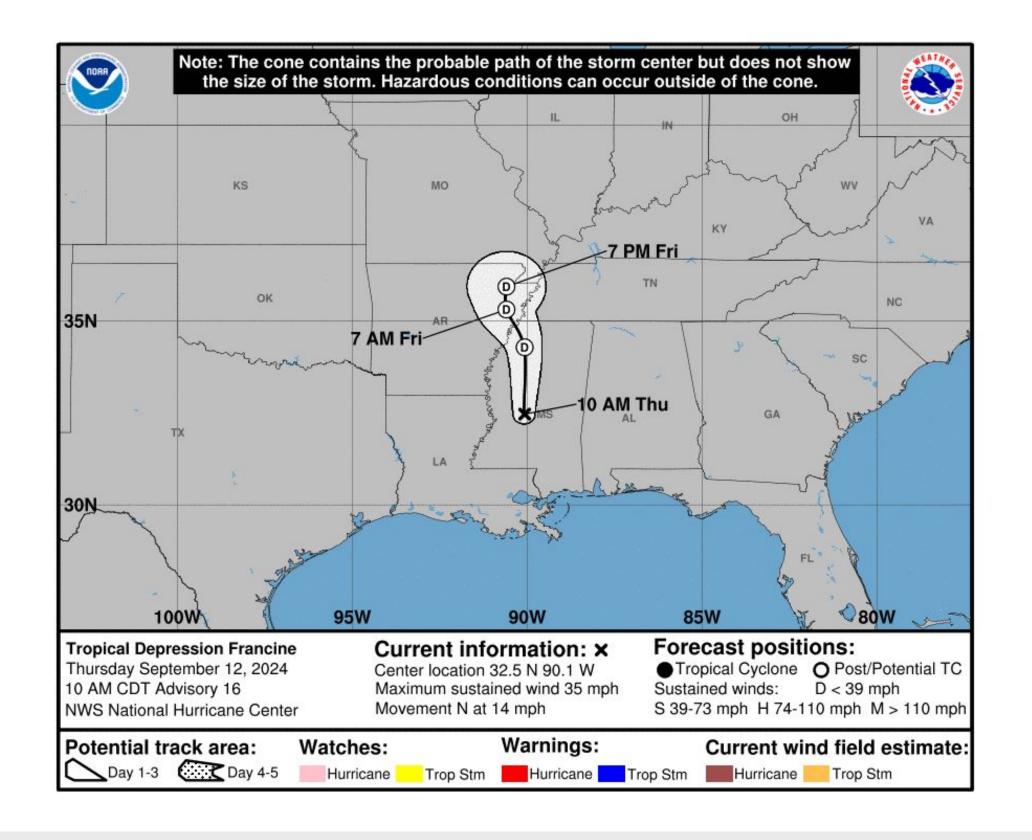
