# FEMA Region 6 Weather Threat Briefing

Thursday, September 19, 2024

# Summary of the Upcoming Week

- Marginal to Slight risk of severe weather (hail/winds) over OK today. Marginal risk over E NM,TX/OK Panhandles Saturday.
- Marginal to Slight risk for heavy rainfall/flash flooding over NM burn scars Friday,
   Saturday, and Monday.
- Tropical Weather Outlook:
  - There is a medium chance (40%) for tropical development in the Caribbean over the next 7 days. Monitor for impacts.
  - Remnants of tropical storm Gordon will move northward across the central Atlantic. No impacts to FEMA 4.
  - There is a low chance (20%) percent for tropical development in the central Atlantic over the next 7 days. No impacts to FEMA 4.





#### 5-Day Precipitation Forecast & River Flood Status


Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall










#### Tomorrow's Tornado & Severe Wind / Hail Probabilities





Green	Little to None Safety: Rarely a Direct Threat to Life and Property Impact Potential: Typically Results in Little Inconvenience to Daily Routines	Severe: Marginal Risk from SPC Flooding: Minor flooding expected over localized areas Tropical: None Fire Weather: No Watches/Warnings, fuel moisture above 10% or green up active	Thunderstorms expected over LA this afternoon; a few may produce winds to knock down a few trees  Something that happens almost every day in a particular season such as seabreeze storms in coastal TX


