- Minor to isolated moderate river flooding over AR and LA through the week.
- Slight risk (level 2 out 5) of severe storms over W/NWTX on Sunday and over N/CntlTX on Monday.
- Slight risk (level 2 out of 4) for excessive rainfall leading to flash flooding across NW TX,W OK on Sunday and marginal risk (level I out of 4) over the OK, NTX, SE TX, **S LA on Monday and SE LA Tuesday.**
- Potential for snow to return Tuesday to NM.
- **Tropical Storm Sara has formed in the western Caribbean and is forecast to move** very slowly towards the Yucatan Peninsula. There is low confidence on track/intensity for the system next week due to land interactions with the Yucatan, but no impacts to FEMA Region 6 expected.















Today's Tornado & Severe Wind / Hail Probabilities



Tomorrow's Weather







Tomorrow's Tornado & Severe Wind / Hail Probabilities









"Day 8-14" Hazards Outlook
















Space Weather 3-Day Forecast
