### STATEWIDE CURRENT SITUATION:

On January 22, Governor Greg Abbott urged Texans impacted by this week's winter weather to document and report any property and agricultural damages sustained from ice, snow, and freezing temperatures by utilizing the Texas Division of Emergency Management's online, [self-reported damage assessment tool](#).

### OPERATIONAL PRIORITIES:

1. Protect life and property.
2. Support rapid & effective response.
3. Collect and disseminate accurate incident information to improve decision-making.
4. Accurately track incident costs associated with assigned resources for cost recovery.

### Region 1 (Includes DDs 1, 2, and 7)

DD 1 – Amarillo (Includes Armstrong, Briscoe, Carson, Castro, Childress, Collingsworth, Dallam, Deaf Smith, Donley, Gray, Hall, Hansford, Hartley, Hemphill, Hutchinson, Lipscomb, Moore, Ochiltree, Oldham, Parmer, Potter, Randall, Roberts, Sherman, Swisher, and Wheeler Counties)

DD 2 – Lubbock (Includes Bailey, Cochran, Crosby, Dickens, Floyd, Garza, Hale, Hockley, King, Lamb, Lubbock, Lynn, Motley, Terry, and Yoakum Counties)

DD 15 – Beaumont (Includes Hardin, Jefferson, and Orange Counties): DDEOC 15 has [returned to Level IV \(Normal Conditions\) on January 23.](#)

### **Region 4 (Includes DDs 16)**

DD 16 – Houston (Includes Austin, Brazoria, Chambers, Colorado, Fort Bend, Galveston, Harris, Liberty, Matagorda, Montgomery, Walker, Waller, and Wharton Counties): DDEOC 16 has [returned to Level IV \(Normal Conditions\) on January 23.](#)

### **Region 5 (Includes DDs 19-21)**

DD 19 – Laredo (Includes Jim Hogg, Starr, Webb, and Zapata, Counties) returned to Level IV (Normal Conditions) on January 22.

DD 20 – Corpus Christi (Includes Aransas, Bee, Brooks, Duval, Jim Wells, Kenedy, Kleberg, Live Oak, Nueces, Refugio, and San Patricio Counties): DDEOC 20 has returned to Level IV (Normal Conditions) on January 22.

DD 21 – Weslaco (Includes Cameron, Hidalgo, and Willacy Counties): DDEOC 21 has returned to Level IV (Normal Conditions) on January 22.

### **Region 6 (Includes DDs 17, 18, and 24)**

DD 17 – Victoria (Includes Calhoun, DeWitt, Goliad, Gonzales, Lavaca, Jackson, and Victoria Counties): DDEOC 17 has returned to Level IV (Normal Conditions) on January 21.

DD 18 – San Antonio (Includes Atascosa, Bandera, Bexar, Comal, Frio, Gillespie, Guadalupe, Karnes, Kendall, Kerr, McMullen, Medina, and Wilson Counties): DDEOC 18 returned to Level IV (Normal Conditions) on January 21.

DD 24 – Del Rio (Includes Dimmit, Edwards, La Salle, Kinney, Maverick, Real, Uvalde, Val Verde, and Zavala Counties): DDEOC 24 has returned to Level IV (Normal Conditions) on January 21. Interstate Highway (IH) 35 in La Salle County is closed due to multiple vehicle collisions.

## **RESPONDING STATE AGENCIES/ORGANIZATIONS REPORTS**

### **STATE RESOURCES COMMITTED**

#### **Texas Division of Emergency Management, Texas A&M University System (TDEM):**

##### **Incident Support Task Force (ISTF):**

The ISTF is on standby.

##### **Mass Care:**

As of January 22, 466 warming centers and 50 general population shelters were opened. Warming centers continue to open in expectation of the cold weather. A State of Texas Assistance Request (STAR) has been submitted for cots, water, meals ready to eat (MRE), and blankets. The food bank feeding operations continue as normal.

##### **Texas A&M AgriLife Extension Service (AgriLife):**

AgriLife Marketing and Communications has distributed and updated preparedness information with educational resources through the agency's social media channels and the county agent network in preparation of the winter weather. The Disaster Assessment Recovery (DAR) Public Information Officer (PIO) has been participating in weather calls and is representing AgriLife on the State Communications Council providing updates on messaging, social media, and other communications needs.

There are 26 DAR agents on standby to support ESF-11 (Agriculture and Natural Resources) and with response and recovery efforts. There are seven AgriLife extension service representatives monitoring the six DDEOC activations across the state and six AgriLife liaisons are supporting the DD 16 and DD 18 activations.

##### **Texas A&M Engineering Extension Service (TEEX) Texas A&M Public Works Response Team (PWRT):**

PWRT has rostered personnel available for local or state assistance and two PWRT personnel have been deployed to support DDEOC 16 operations.

##### **Texas A&M Forest Service (TAMFS):**

TAMFS has heavy equipment, operators, and overhead available to support TDEM Regions 3, 4, 7, and 8. TAMFS liaisons are at DDEOCs 14 and 16.

##### **Public Utility Commission of Texas (PUC):**

As of 3 PM on January 22, there were less than 7,000 outages statewide. An estimated 2,000 - 3,000 of them remain from the winter weather.

Utilities across the state have been preparing for several days in anticipation of the winter weather. Electric Reliability Council of Texas (ERCOT) expects to have sufficient power to meet the demand throughout the event. PUC and ERCOT will continue to monitor the weather and provide updates as the event evolves.

On January 21, approximately 48,000 customers were without power in the morning, and this number decreased to 17,000 customers by the afternoon, with Hidalgo, Brazoria, Nueces, and Jim Hogg counties being the primary affected areas. The majority of the power restorations are expected to be completed today.

**Texas Animal Health Commission (TAHC):**

**Texas Commission on Environmental Quality (TCEQ):**

[As of January 23](#), TCEQ is currently tracking [14](#) drinking water systems that are on a Boil Water Notice (BWN). TCEQ has agency staff and emergency response contractors to assist with air, water, waste, drinking water/wastewater and emergency response activities on standby.

**Texas Department of Information Resources (DIR):**

DIR is monitoring the situation using cybersecurity tooling and threat intelligence feeds. No cyber threats related to this weather event have been identified, and there are no requests for network or technology.

**Texas Department of Public Safety (DPS):**

Texas Department of Public Safety is actively supporting the state's response to the ongoing winter weather event across multiple DPS Districts, patrolling roadways, monitoring traffic, and assessing road conditions.

**Texas Department of State Health Services (DSHS):**

DSHS operations centers are on limited activation and Public Health Regions (PHR) are supporting DDEOCs throughout their region. PHR 6/5S has two personnel supporting DDEOCs 14 and 15. The CMOC reported Demobilization on January 22. [On January 23, the SOC liaison officers \(LNO\) and the Emergency Medical Task Force \(EMTF\) resources have demobilized.](#)

As of January 21, 34 dialysis centers have reported closures. Christus Jasper Memorial Hospital has reported an internal disaster due to the heat not working.

**Texas Emergency Medical Task Force (EMTF):**

EMTFs 1, 6, 7, 8, and 11 are on standby with EMTF 2 serving as backup.

**Texas Department of Transportation (TxDOT):**

Most TxDOT districts have returned to normal operations. As of January 22, over 100 state-maintained roads had been impacted by the snow and ice. TxDOT had personnel supporting the TxDOT EOCs, local EOCs, and the SOC. There have been over 2,600 personnel with 2,000 vehicles deployed to plow, treat, and patrol state roadways. Over 683,000 gallons of brine have been distributed on state roadways since January 19.

TxDOT and local EOCs statewide stood up on January 20 to support 24-hour shift work. TxDOT crews were out pre- and re-treating roads, bridges, and overpasses over the weekend and will be out throughout the event. TxDOT personnel from the northern districts have deployed to support the TxDOT central & southern districts. Coordination has begun with the Texas A&M Forest Service (TAMFS) and Texas Military Department (TMD) to provide additional support along major highway corridors.

**Texas Military Department (TMD):**

TMD has one Battalion Mission Command (BNMC) MRP to assist stranded motorists and conduct welfare checks on selected motorways. The SOC Support Team is supporting weather operations in Austin. [The Winter Weather \(WW\) Mission Ready Packages \(MRP\) have been released and TMD has transitioned to recovery operations.](#)

TMD has activated [103](#) personnel and [38](#) vehicles.

**Texas Parks and Wildlife Department (TPWD):**

As of January 22, all TPWD Field Offices have returned to normal operations.

**Volunteer Organizations Active in Disasters (VOAD)****American Red Cross (ARC):**

[All ARC supported and managed shelters have closed.](#)

**Texans on Mission (TXM):**

TXM is assisting with breakfast and dinner meals for the warming shelters in the Dallas area. TXM has provided [592](#) volunteer hours, [14,500](#) meals, [40](#) showers, and [17](#) laundry services.

**The Salvation Army (TSA):**

TSA locations with warming center services will operate according to local protocols and procedures. TSA Houston Area Command has provided Outreach Teams to the Fonde Community Center warming operations.
