FEMA Region 6 Weather Threat Briefing

Tuesday, January 28, 2025

Disclaimer: The purpose of this briefing is to provide a <u>Regional</u> weather threat assessment and is meant as a general overview. County/Parish decision makers should consult their local NWS forecast offices for the latest detailed, local weather information.

- Strong weather system will produce a marginal risk (level 1 of 5) of severe storms Wed over W/Ctrl/NTX and slight risk (level 2 of 5) Thu over ETX, LA. In addition, a slight risk (level 2 of 4) of heavy rainfall/flash flooding Thu over SE OK, AR, N LA, NETX.
- Minor impacts (level 2 of 5) from snow Wednesday and Thursday over N NM.
- Minor river flooding will continue into next week in ETX.Additional minor (possibly moderate) flooding may occur in ETX and LA starting late week with the expected heavy rainfall.



Minor river flooding continues next week in ETX with flooding of low-lying pastures, swampland, and secondary roads.


Additional minor to isolated moderate flooding may occur in E TX and LA late week with rainfall mid to late week.














Tomorrow's Tornado & Severe Wind / Hail Probabilities











Excessive Rainfall Outlooks not available beyond Day 5



"Day 3-7" Hazards Outlook






"Day 8-14" Hazards Outlook




