





FEMA Region 6 Weather Threat Briefing Tuesday, February 11, 2025

- Slight risk (level 2 out 4) for heavy rainfall/flash flooding over SEAR, ETX, N LA Tuesday and Wednesday and again on Saturday.
- Minor (level 2 of 5) impacts from a wintry mix of snow and ice through Wednesday in N NM,TX/OK Panhandles and N OK. Northern areas more likely snow (up to 2"), but transition area from snow to freezing rain leading to ice accumulation (up to 0.10"). Additional heavy snow in NM Mts from Friday into Saturday.
- Marginal risk (level 1 of 5) of severe storms over SETX and W LA today; slight risk for severe storms (level 2 of 5) over E LA on Wednesday and over ETX, LA and S/E AR on Saturday.
- Elevated (level 1 of 3) fire weather conditions for S NM, WTX today with elevated to critical (level I-2 of 3) conditions Wednesday and over WTX on Saturday. • Minor (level 2 of 4) river flooding will continue this week in ETX, AR, LA with additional
- rises possible from heavy rain.







Today's Tornado & Severe Wind / Hail Probabilities







Flood watch through Wednesday over ETX and NLA.





Tomorrow's Tornado & Severe Wind / Hail Probabilities











Excessive Rainfall Outlooks not available beyond Day 5









"Day 3-7" Hazards Outlook







"Day 8-14" Hazards Outlook





