FEMA Region 6 Weather Threat Briefing

Wednesday, February 26, 2025

Disclaimer: The purpose of this briefing is to provide a <u>Regional</u> weather threat assessment and is meant as a general overview. County/Parish decision makers should consult their local NWS forecast offices for the latest detailed, local weather information.

- Elevated (level I of 3) fire weather conditions possible in NM, WTX, TX Panhandle, W OK today. Friday may have elevated across NWTX, W OK.
- Slight risk (level 2 of 5) of severe weather next Tuesday for SE OK, AR, ETX, and LA. Chance for heavy rain in AR associated with these storms on Tuesday.
- Elevated fire weather conditions (level I of 3) may occur again this weekend and/or early next week in NM, WOK, and WTX.
- Minor (level 2 of 4) river flooding forecast to continue this week in ETX,AR, LA.



5-Day Precipitation Forecast & River Flood Status


Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall



Today's Tornado & Severe Wind / Hail Probabilities










Tomorrow's Tornado & Severe Wind / Hail Probabilities







Elevated (level 1 of 3) fire weather conditions in W OK, NW TX.




Saturday's Weather



Elevated (level 1 of 3) fire weather conditions across S NM,W TX.








Monitoring for fire weather conditions in TX Panhandle, W OK.






"Day 8-14" Hazards Outlook











