- Elevated to Critical (levels I-2 of 3) fire weather conditions along with blowing dust over NM, TX/OK Panhandles and WTX today and expanding on Saturday into S/CTX. Elevated to critical fire weather (levels 1-2 of 3) prevails on Sunday for SWTX.
- Renewed fire weather concerns Tue/Wed next week NM/TX border.
- Minor to isolated moderate (levels 2-3 of 5) winter impacts from snow from late today through Saturday across NM, TX/OK Panhandles.
- Marginal risk (level 1 of 5) for severe weather in NETX, SW AR, and LA Saturday.
- Minor river flooding forecast through next week in ETX, AR, LA.







Minor (level 2 of 5) impacts from snow starting in the afternoon to evening hours in NM and overnight TX/OK Panhandle.




Today's Tornado & Severe Wind / Hail Probabilities






Tomorrow's Tornado & Severe Wind / Hail Probabilities





















Space Weather 3-Day Forecast
