FEMA Region 6 Weather Threat Briefing

Saturday, March 22, 2025

Disclaimer: The purpose of this briefing is to provide a <u>Regional</u> weather threat assessment and is meant as a general overview. County/Parish decision makers should consult their local NWS forecast offices for the latest detailed, local weather information.

- Elevated to critical (levels I-2 of 3) fire weather concerns today across portions of TX, OK, and NM. Elevated conditions N/W TX, TX Panhandle, OK Sunday into Monday then in NW OK Tuesday.
- Marginal risk (level 1 of 5) for severe storms today in far NE OK, far NW AR during the evening. Slight risk (level 2 of 5) for severe weather Sunday for S AR, NE TX, and N LA. Main threats are hail and wind, but isolated tornado possible. Timing: afternoon through late evening. Finally Monday late morning to early afternoon has a marginal risk for SE LA.
- Marginal risk (level I of 4) for heavy rainfall on Sunday for SEAR, ETX, N LA and then in SE LA on Monday.
- Isolated minor river flooding in ETX and SE LA looks to end by mid week.



Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall




Isolated minor river flooding in across ETX, SE LA end by mid week.




Elevated to critical (levels I-2 of 3) fire weather concerns in NM, N/W TX,TX Panhandle, OK.


Slight Risk (level 2 of 5) for severe storms SAR, NETX, N LA.

Marginal Risk (level 1 of 4) for heavy rainfall in SEAR, ETX, N LA.




Tomorrow's Tornado & Severe Wind / Hail Probabilities


Elevated (level 1 of 3) fire weather concerns in NWTX,TX Panhandle, OK.

Marginal risk (level 1 of 4) for heavy rainfall in SE LA.




