FEMA Region 6 Weather Threat Briefing

Saturday, April 05, 2025

Disclaimer: The purpose of this briefing is to provide a <u>Regional</u> weather threat assessment and is meant as a general overview. County/Parish decision makers should consult their local NWS forecast offices for the latest detailed, local weather information.

- Severe Storms: Enhanced risk (level 3 of 5) ETX, SEAR, LA today including tornadoes. Slight risk (level 2 of 5) over SE LA Sunday.
- Flooding: High risk (level 4 of 4) today for AR with a moderate risk (level 3 of 4) over SE OK, NE TX and N LA. Slight risk (level 2 of 4) over SE LA on Sunday.
- Winter impacts over N/E New Mexico with 5-10" of snow and 50 mph wind gusts reducing visibility to near zero today including along I-25. 3-5" of snow along with gusty winds to 45 mph over the TX Panhandle today will combine to significantly reduce visibility and may cause power outages.
- Widespread moderate to major river flooding over AR through next week with widespread minor to isolated moderate river flooding over E OK, E/NETX and N LA.








5-Day Precipitation Forecast & River Flood Status

Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall






- Widespread moderate to major river flooding in AR where numerous homes and roads/highways will be flooded.
- Widespread minor with isolated moderate river flooding over E OK, N/E TX and N LA. Impacts mainly to secondary roads and agricultural areas.

Note: Numerical levels (e.g. level 1 of 4) will not be assigned to riverine flooding due to the varying levels of impacts across flood categories.








Tomorrow's Tornado & Severe Wind / Hail Probabilities






