






Level 2 of 5: S AR, N LA, E TX

- A brief tornado cannot be ruled out
- Damaging wind gusts of 60 + MPH
- Large hail of quarter size or larger



There is a Marginal Risk (1 of 5) for severe weather on Tuesday (May 20th) afternoon and into the evening. This threat extends across the western half of the region down to I-10.

Probability of severe weather within 25 mi of a point up to 14% or between 5 and 15 times greater than a non-risk weather day.





Keetch-Byram Drought Index


Keetch-Byram Drought Index


