# FEMA Region 6 Weather Threat Briefing

Wednesday, August 06, 2025

**Disclaimer:** The purpose of this briefing is to provide a <u>Regional</u> weather threat assessment and is meant as a general overview. County/Parish decision makers should consult their local NWS forecast offices for the latest detailed, local weather information.

- <u>Heat:</u> Hazardous heat across NM, WTX, TX/OK Panhandles today expands across all FEMA 6 states by Friday. Heat looks to ease over the weekend, but expand again next week.
- Flooding: Increased risk for burn scar flash flooding for S NM on Friday.
- <u>Tropical</u>: No tropical impacts expected in FEMA 6 over the next 7 days. While not outlooked, monitoring E Gulf for late week/weekend.





Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall








### Today's Tornado & Severe Wind / Hail Probabilities













#### Wind, Severe, Heat, and Flood Hazards

of 100-110 degrees.







#### Tomorrow's Tornado & Severe Wind / Hail Probabilities





Purple	Extreme Safety: Property Damage Unavoidable, Immediate Action to Save Life will be Needed Impact Potential: Typically Results in Long-Lived Widespread Major Disruption to Daily Life	Severe: High Risk from SPC Flooding: Major flooding expected over a widespread area (including urban locations) Tropical: A Major Hurricane (Cat3 or greater) expected to move towards or near any coastline Fire: Large area of critical conditions for 2 or more days, Warnings for 3 or more days, Long term (months) of severe to extreme drought	<ul> <li>A Category 4 hurricane is headed towards the SE LA; major storm surge, flooding and damaging winds anticipated to begin tomorrow</li> <li>Widespread severe storms expected, tornado outbreak probable with long- lived, very widespread and particularly intense storms</li> </ul>
