# Summary

- **Flash Flooding:**

- **Marginal risk (level 1 of 4) for flash flooding in much of NM today; NM and far W TX Saturday; E NM, W OK and TX on Sunday.**
- **NM Burn Scars: Major risk (level 3 of 4) today and tomorrow; moderate risk (level 2 of 4) on Sunday.**

- **Tropical Weather:**

- **AL 91 in the eastern Atlantic has a high chance (90%) for development into a tropical depression by this weekend. No impacts in the next 7 days.**
- **Remnant moisture from Hurricane Lorena may increase flash flood risk over NM, TX Fri-Sun, otherwise no tropical impacts to FEMA 6 expected.**

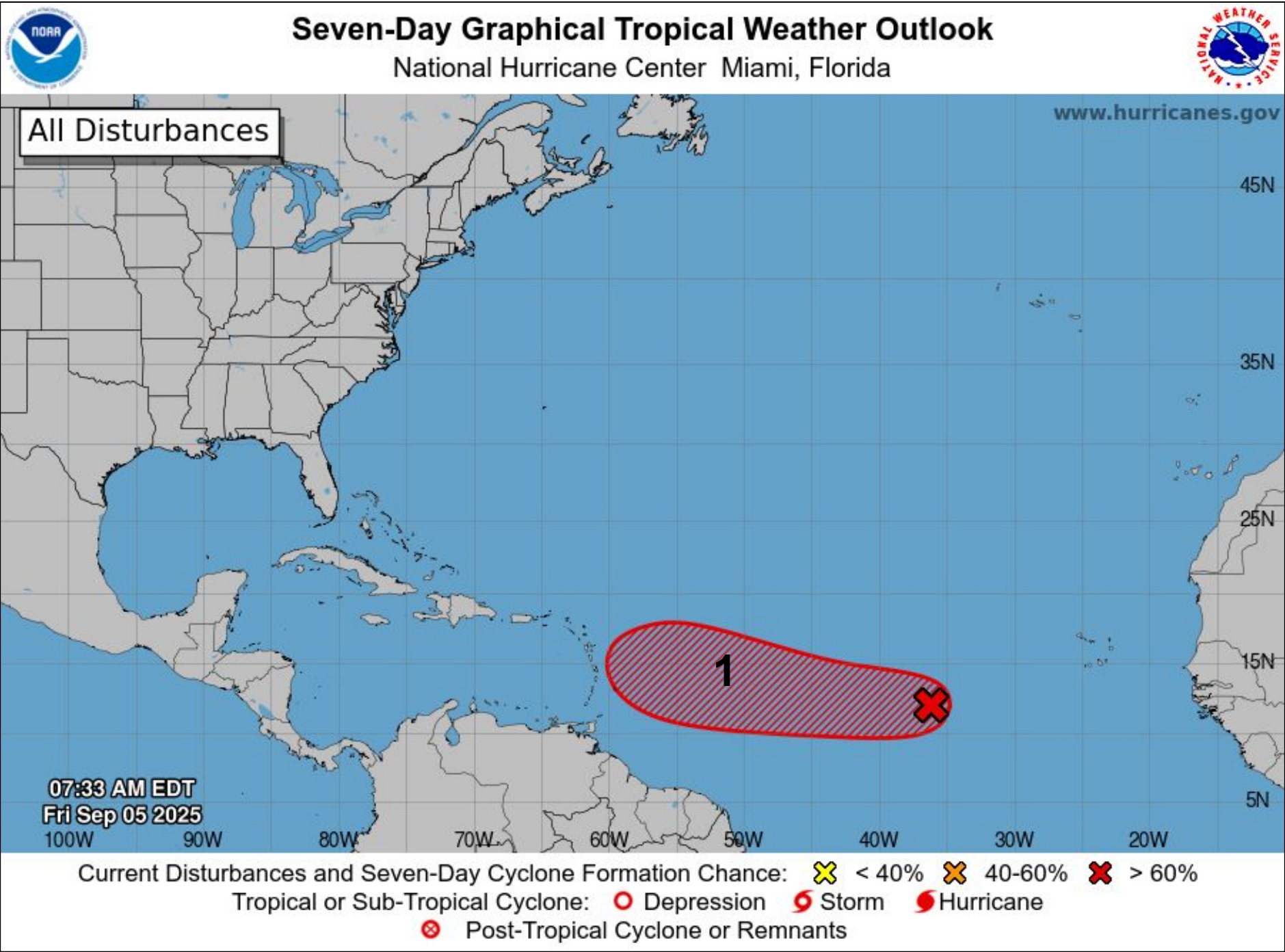

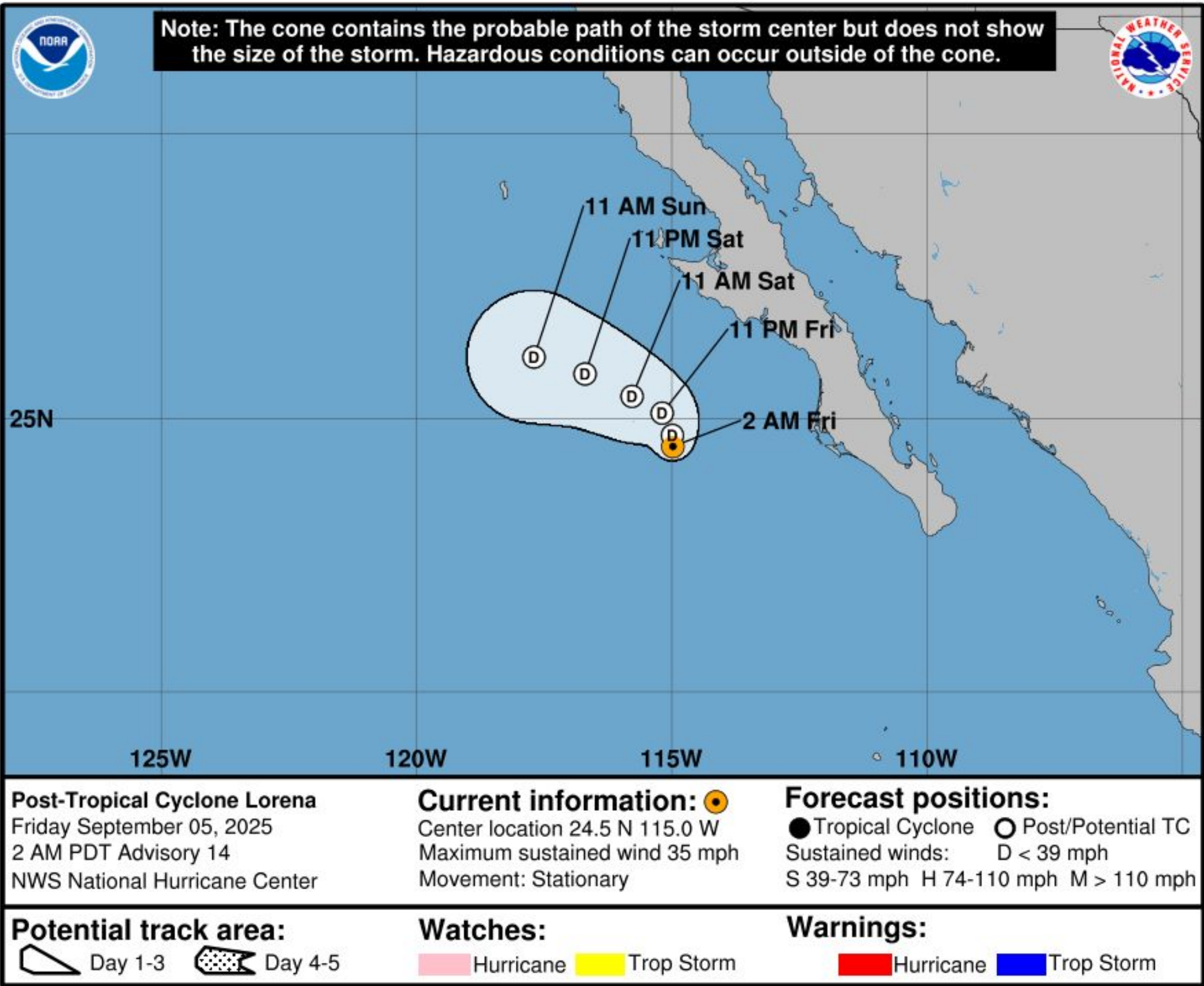




# Pacific Hurricane Lorena

- Hurricane Lorena is not expected to bring tropical storm wind impacts (winds less than 39 mph) to New Mexico or Texas.
- Favorable conditions for heavy rain and flash flooding could develop in portions of New Mexico and Texas Friday-Sunday as moisture from Hurricane Lorena streams northeastward.

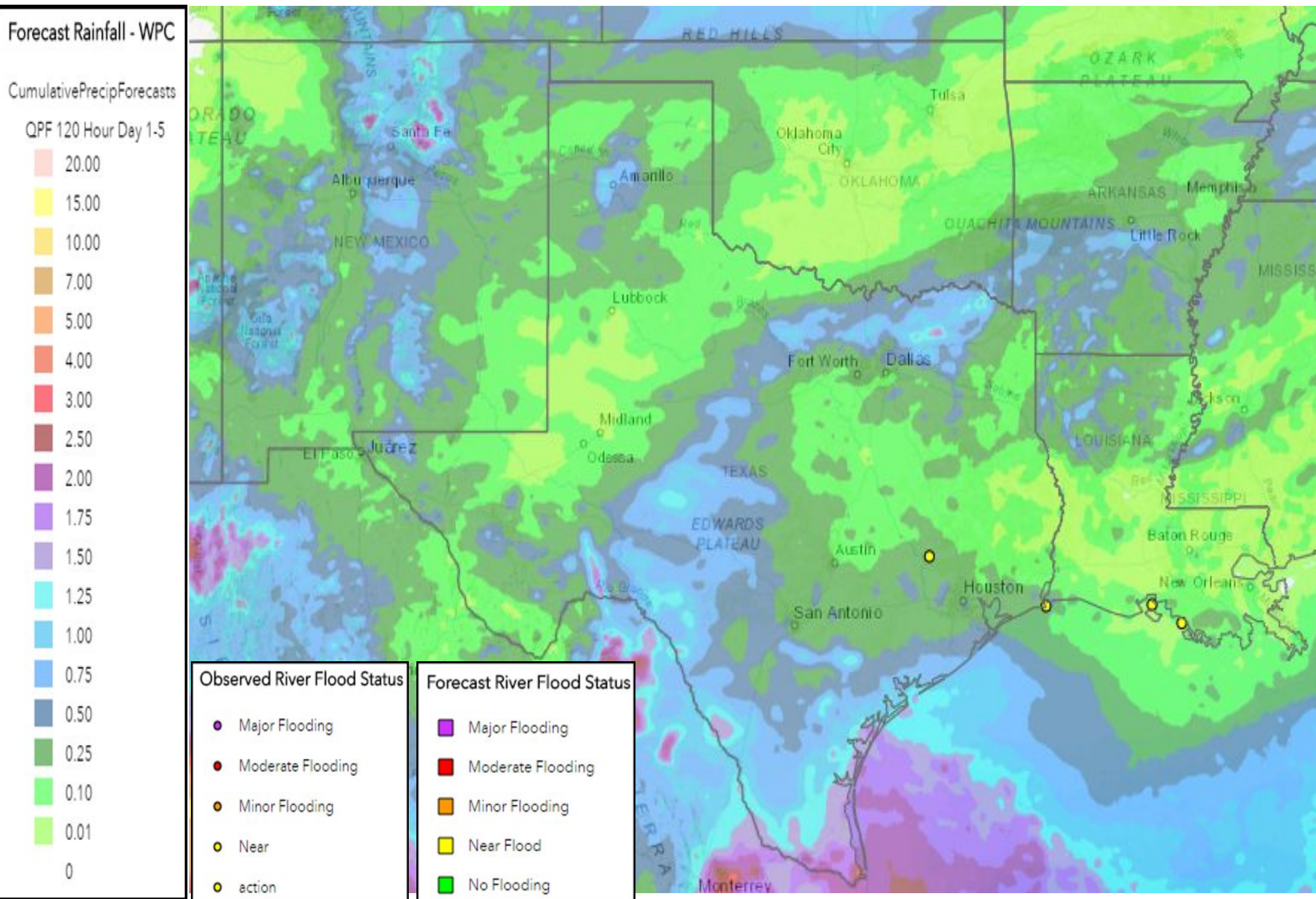






# 5-Day Precipitation Forecast & River Flood Status

**Significant river flooding is not expected.**

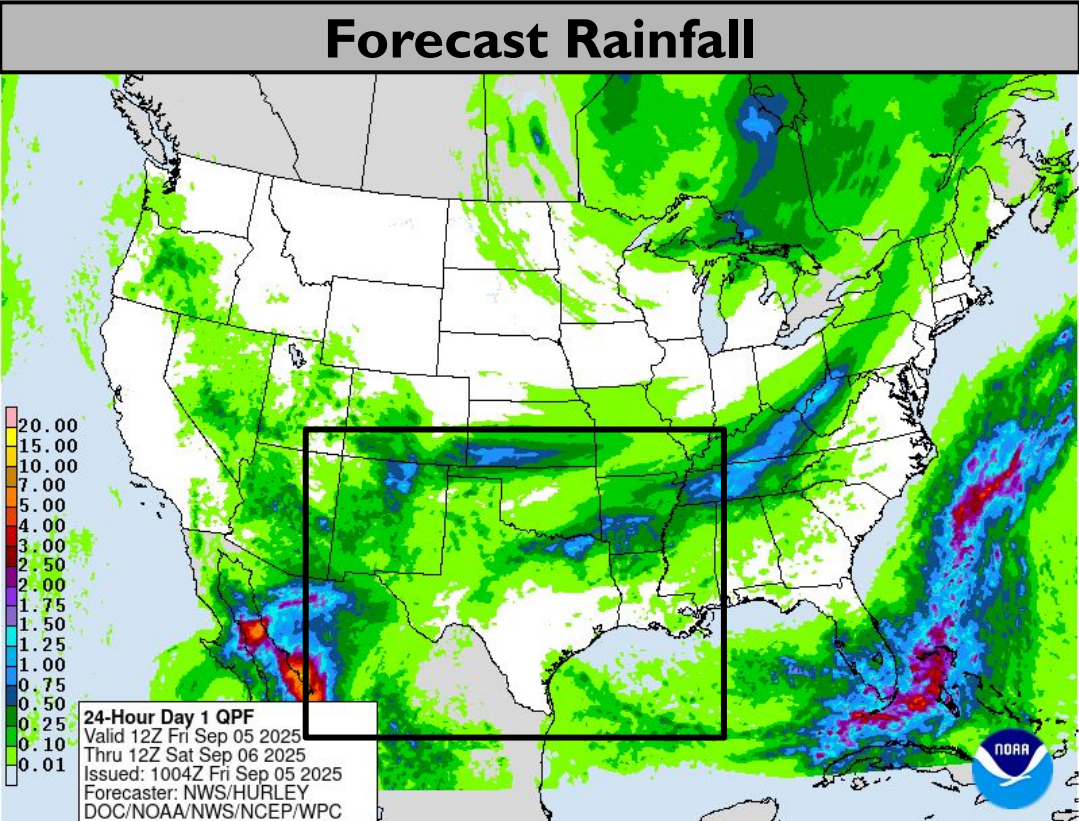
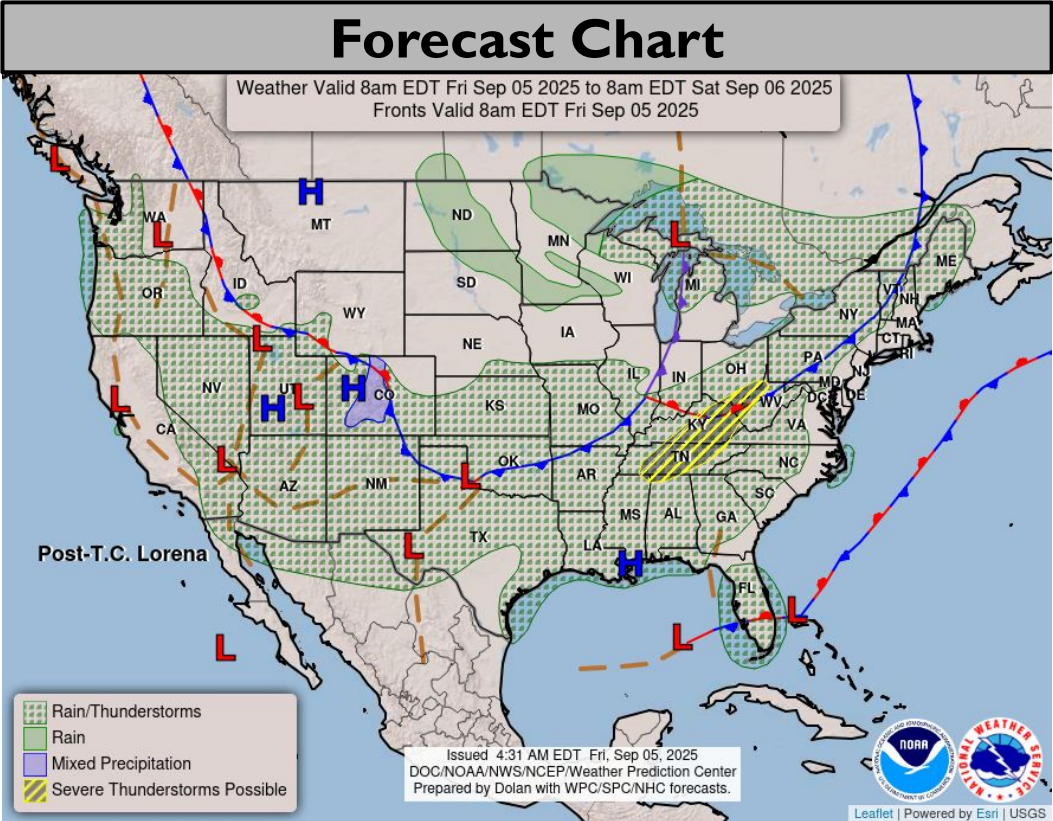

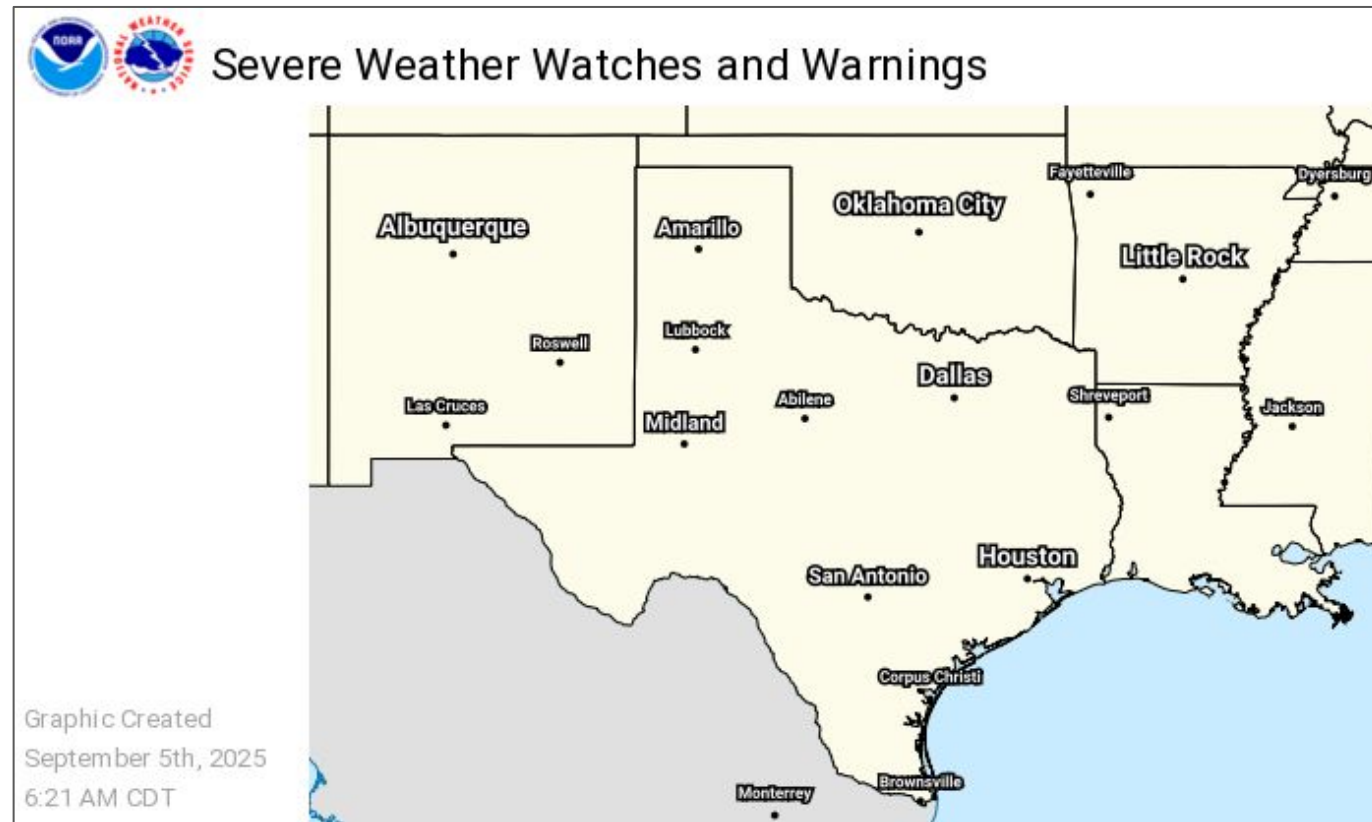






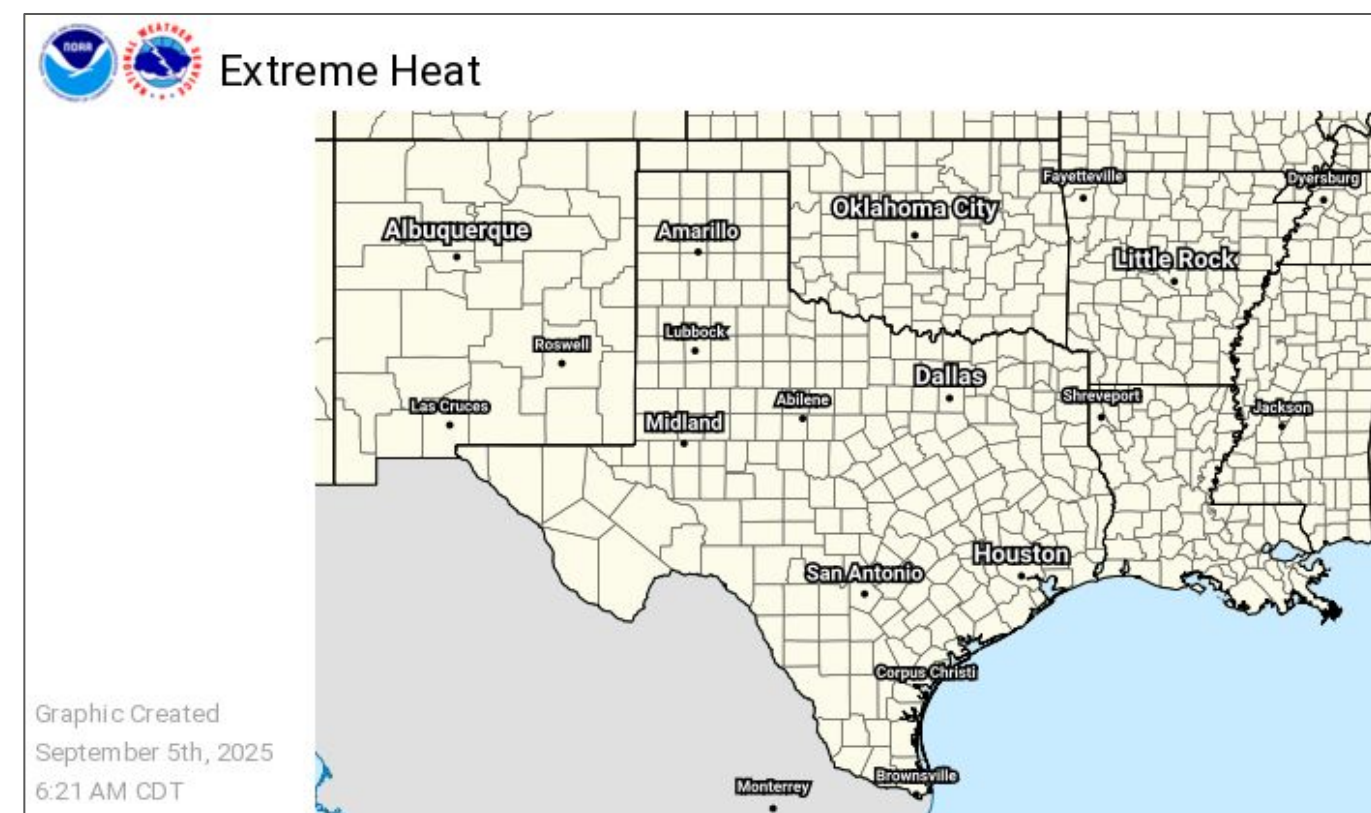
# Watches, Warnings, and Advisories

**Rainfall rates near 2 inches per hour may lead to flash flooding.**



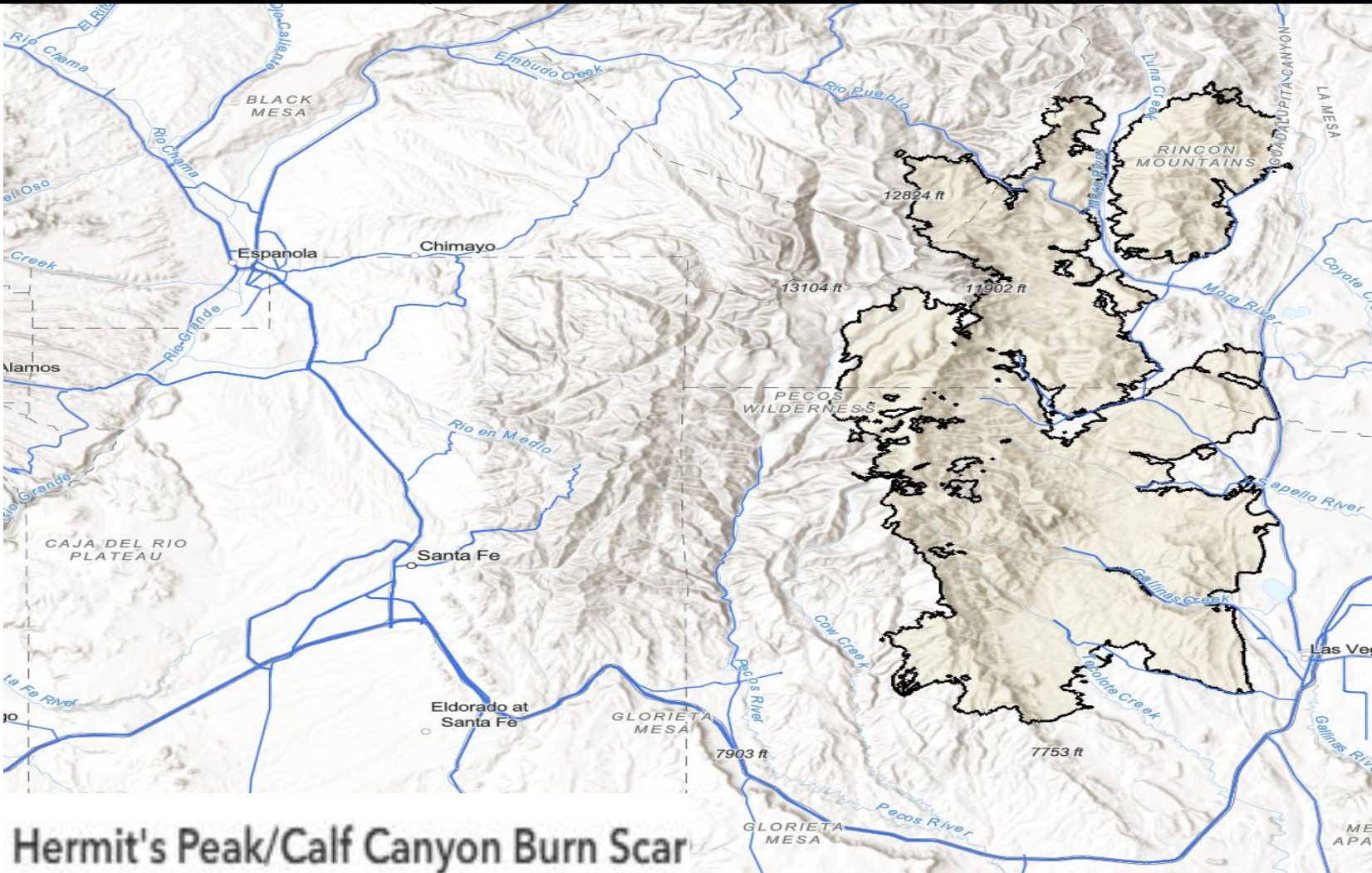

Green	<b>Little to None</b> Safety: Rarely a Direct Threat to Life and Property Impact Potential: Typically Results in Little Inconvenience to Daily Routines	Severe: Marginal Risk from SPC Flooding: Minor flooding expected over localized areas Tropical: None Fire Weather: No Watches/Warnings, fuel moisture above 10% or green up active	<ul style="list-style-type: none"> <li>Thunderstorms expected over LA this afternoon; a few may produce winds to knock down a few trees</li> <li>Something that happens almost every day in a particular season such as seabreeze storms in coastal TX</li> </ul>
