# Summary

- **Flooding:**
  - Slight risk (level 2 of 4) for flash flooding over N OK today; E OK, NE TX and AR on Tuesday.
  - NM Burn Scars: Minor risk (level 1 of 4) through Tuesday over the S NM.
- **Severe Weather:** Slight risk (level 2 of 5) over W OK, TX Panhandle today; AR, N TX and E OK on Tuesday.
- **Tropical Weather:**
  - Hurricane Gabrielle is forecast to move eastward across the Atlantic. No impacts to FEMA 6.
  - High chance (70%) for a wave in the central Atlantic to develop over the next 7 days. FEMA 6 impacts are not expected over the next week.
  - Medium chance (40%) for a wave east of the Lesser Antilles to develop over the next 7 days. FEMA 6 impacts are not expected over the next week.

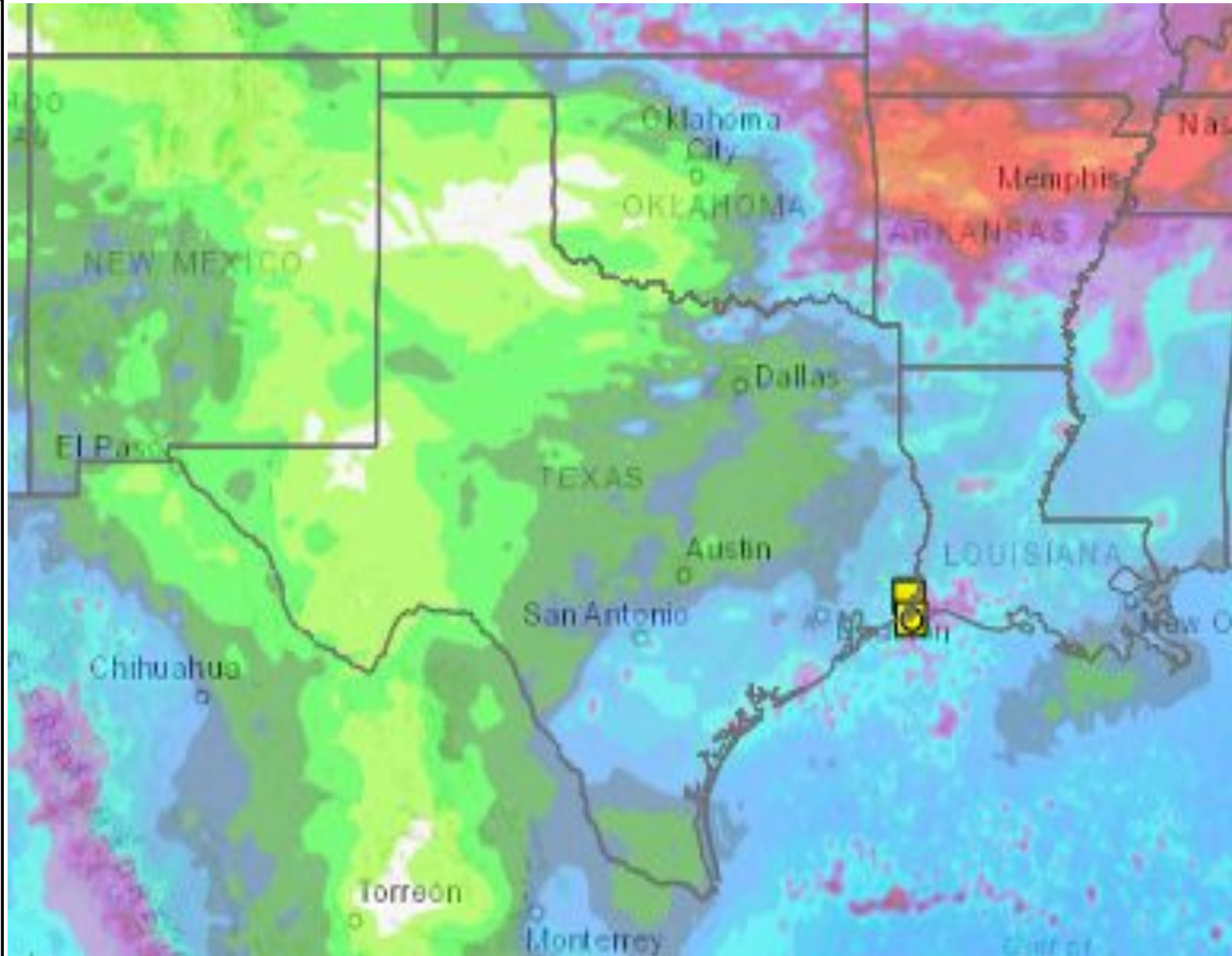
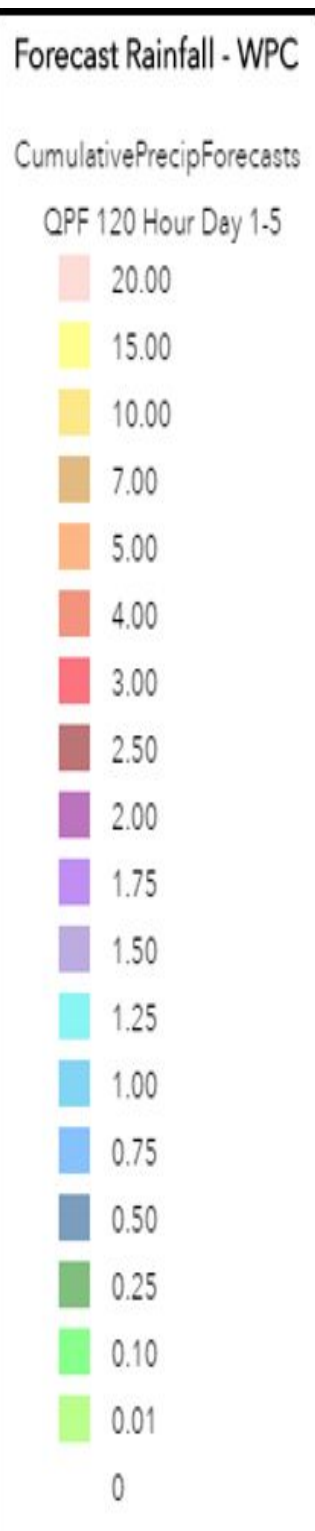






# 5-Day Precipitation Forecast & River Flood Status

# Today's Tornado & Severe Wind / Hail Probabilities



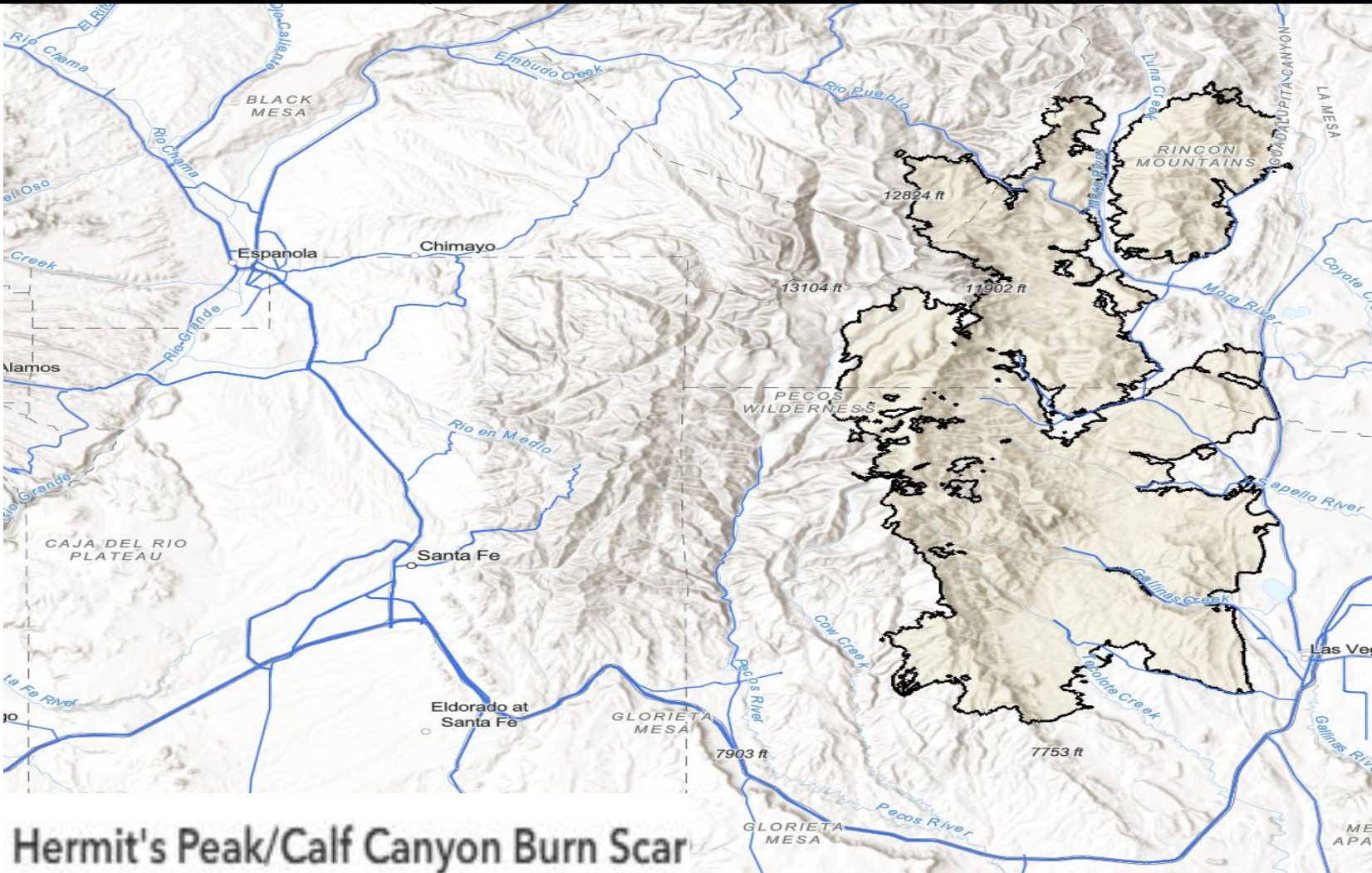

## U.S. Drought Monitor Class Change - CONUS 1 Week

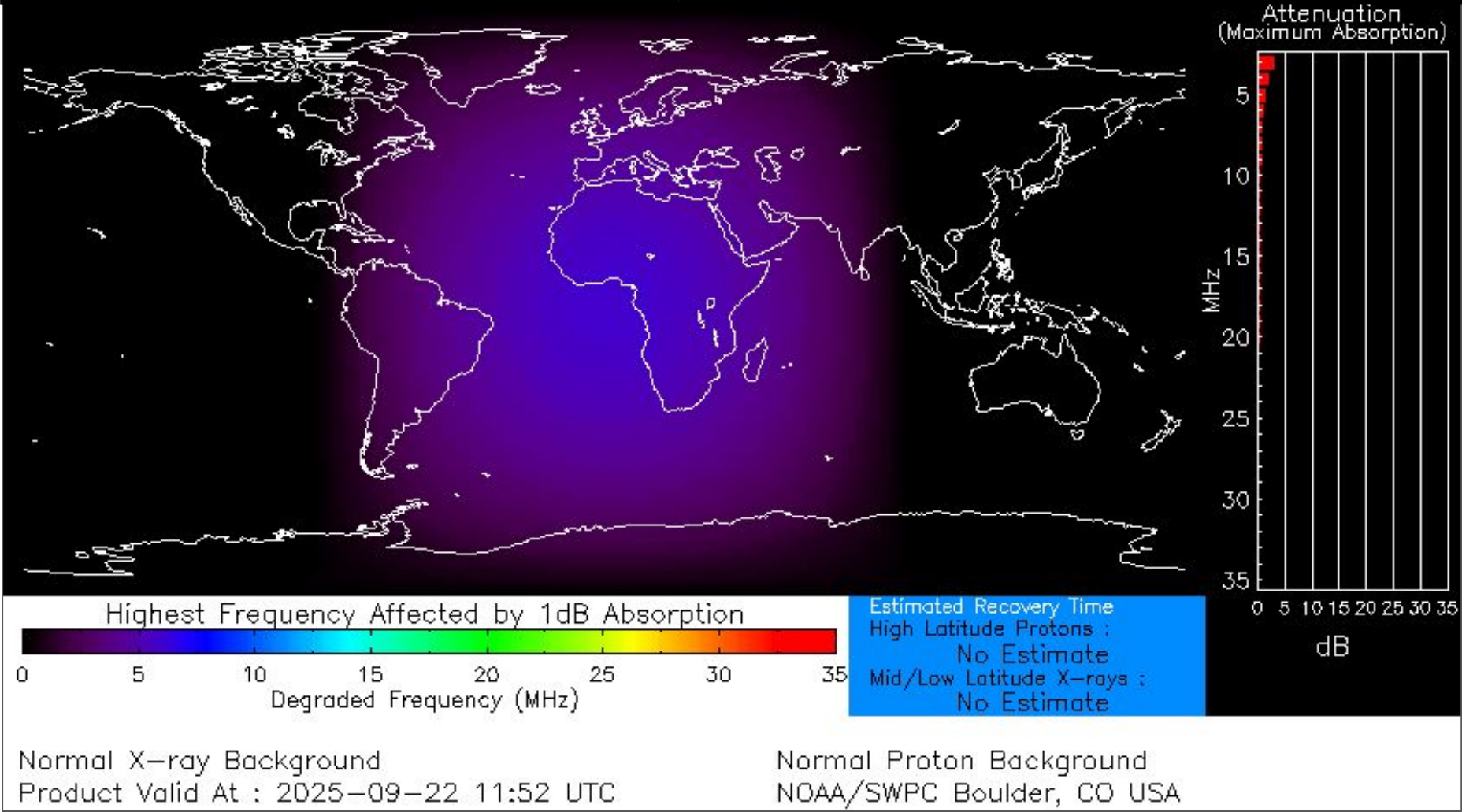






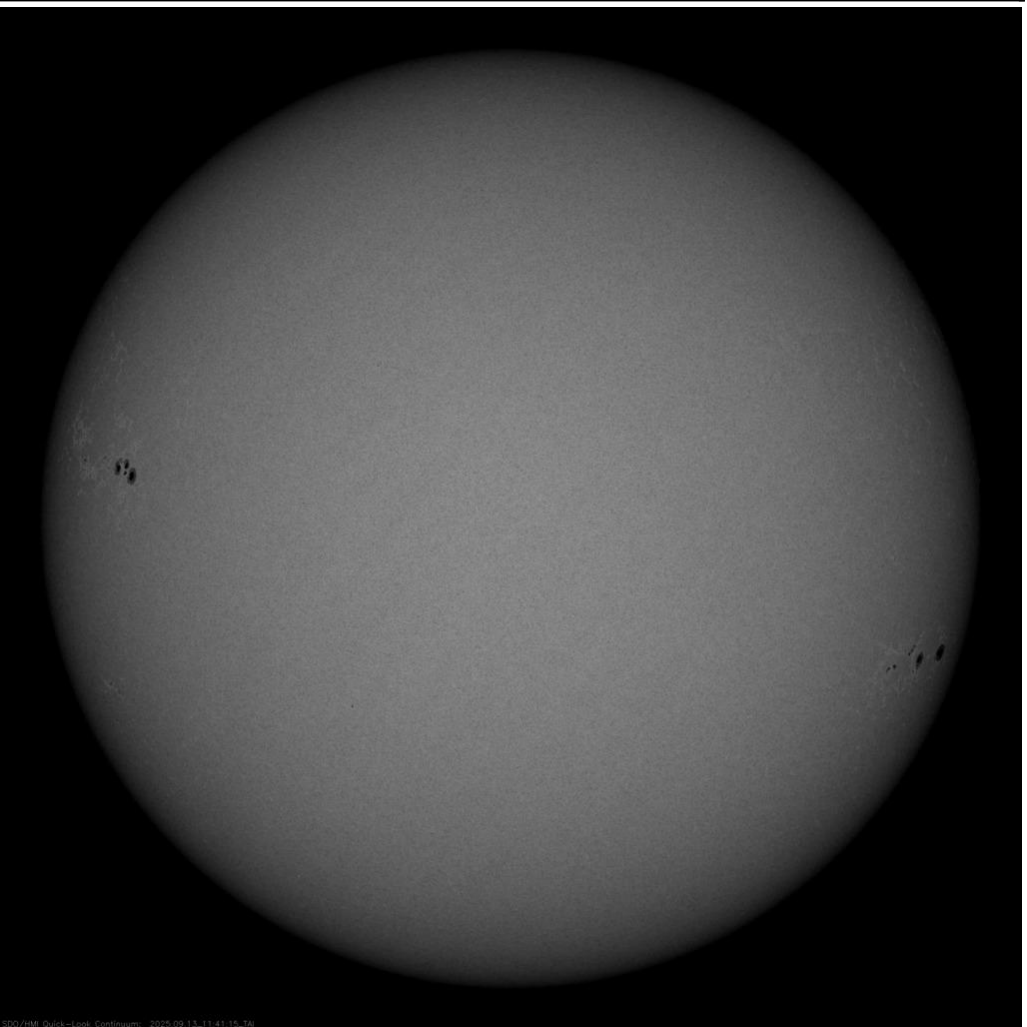

Green	<b>Little to None</b> Safety: Rarely a Direct Threat to Life and Property Impact Potential: Typically Results in Little Inconvenience to Daily Routines	Severe: Marginal Risk from SPC Flooding: Minor flooding expected over localized areas Tropical: None Fire Weather: No Watches/Warnings, fuel moisture above 10% or green up active	<ul style="list-style-type: none"> <li>Thunderstorms expected over LA this afternoon; a few may produce winds to knock down a few trees</li> <li>Something that happens almost every day in a particular season such as seabreeze storms in coastal TX</li> </ul>

Purple	<b>Extreme</b> Safety: Property Damage Unavoidable, Immediate Action to Save Life will be Needed Impact Potential: Typically Results in Long-Lived Widespread Major Disruption to Daily Life	Severe: High Risk from SPC Flooding: Major flooding expected over a widespread area (including urban locations) Tropical: A Major Hurricane (Cat3 or greater) expected to move towards or near any coastline Fire: Large area of critical conditions for 2 or more days, Warnings for 3 or more days, Long term (months) of severe to extreme drought	<ul style="list-style-type: none"> <li>A Category 4 hurricane is headed towards the SE LA; major storm surge, flooding and damaging winds anticipated to begin tomorrow</li> <li>Widespread severe storms expected, tornado outbreak probable with long-lived, very widespread and particularly intense storms</li> </ul>
