FEMA Region 6 Weather Threat Briefing

Wednesday, October 15, 2025

• Flash Flooding:

- Slight risk (level 2 of 4) Saturday in NE AR.
- Ruidoso Burn Scar: Minor risk (level I of 4) today.
- Burn Scar Note: Burn scar flash flooding is generally a threat from June 15 September 30, aligning with monsoon season. Slides have been extended into mid October for the Sacramento Complex (Ruidoso) burn areas due to the presence of moisture from Eastern Pacific tropical systems. Slides will be discontinued once this threat has ended.

• Severe Weather:

○ Slight risk (level 2 of 5) on Saturday over E OK, AR, NETX, N LA.

Tropical Weather:

- T.S. Lorenzo has formed in the tropical Atlantic. A recurve into the central Atlantic is ongoing with no impacts to FEMA 6.
- Eastern Pacific disturbance off the coast of western Mexico has a 60% chance of development, and no FEMA 6 impacts are expected.









Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall












Tomorrow's Tornado & Severe Wind / Hail Probabilities











"Day 3-7" Hazards Outlook









