FEMA Region 6 Weather Threat Briefing

Tuesday, October 28, 2025

- Fire Weather:
 - Elevated to critical (levels 1-2 of 3) fire weather concerns for C-STX tomorrow.
- Severe Weather:
 - Marginal risk (level 1 of 5) for severe weather in ETX,W LA, S AR today.
- Tropical Weather:
 - Tropical Storm Sonia continues westward in the Eastern Pacific, with no impacts to FEMA 6 expected.
 - Hurricane Melissa is expected to move very slowly to north in the Caribbean over the next few days, with eastward curve into the Atlantic later this week. No impacts to FEMA 6.









Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall







Marginal risk (level 1 of 5) for severe storms over ETX,W LA, S AR.









Tomorrow's Tornado & Severe Wind / Hail Probabilities







"Day 3-7" Hazards Outlook







