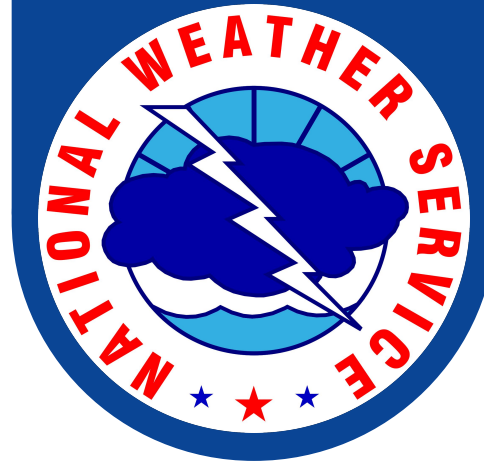

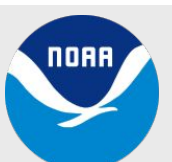

# Summary

- **Fire Weather:**
  - **Elevated to critical (levels 1-2 of 3) threat Friday for E NM into TX Panhandle.**
- **Tropical Weather:**
  - **Tropical cyclone activity is not expected in the next 7 days for FEMA 6.**

*Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall*



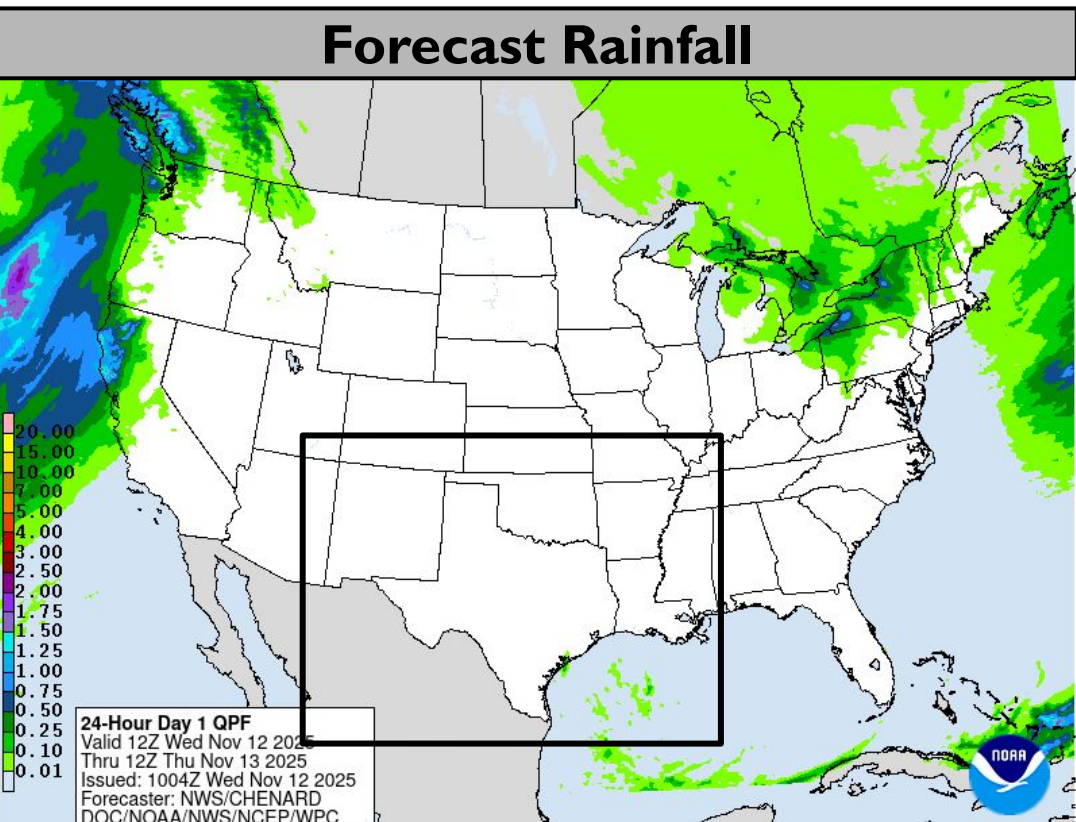
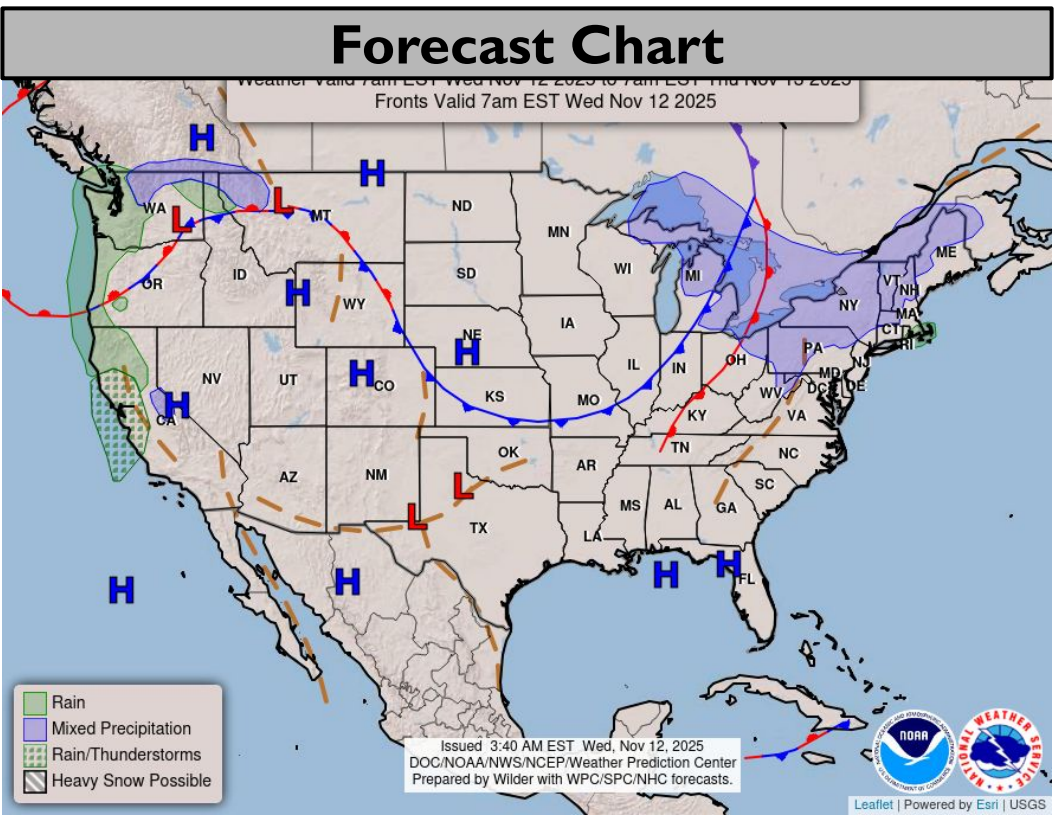

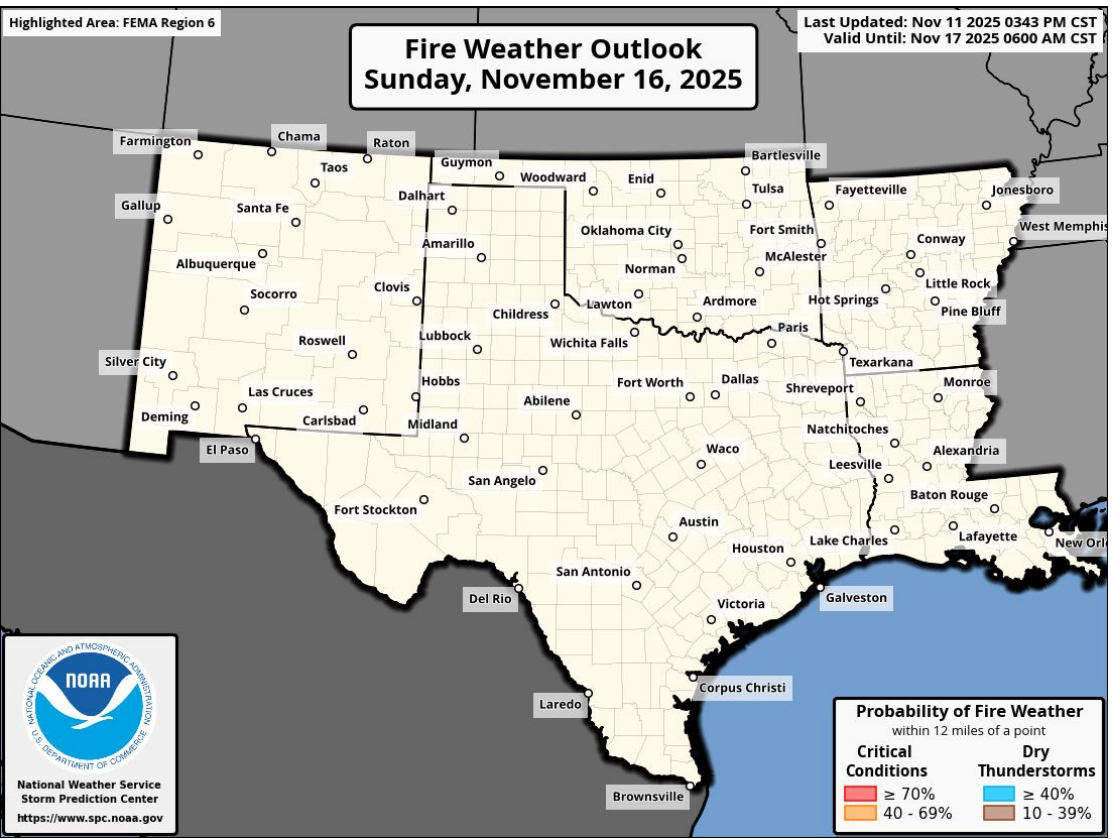
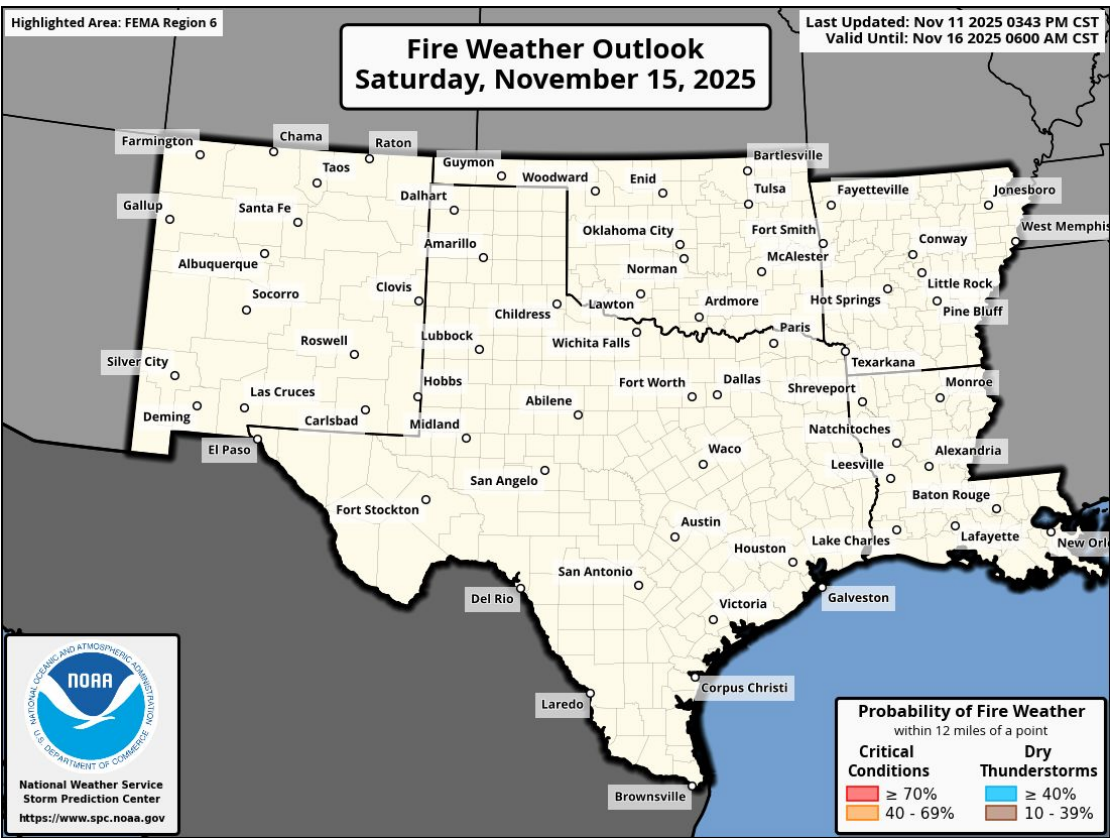
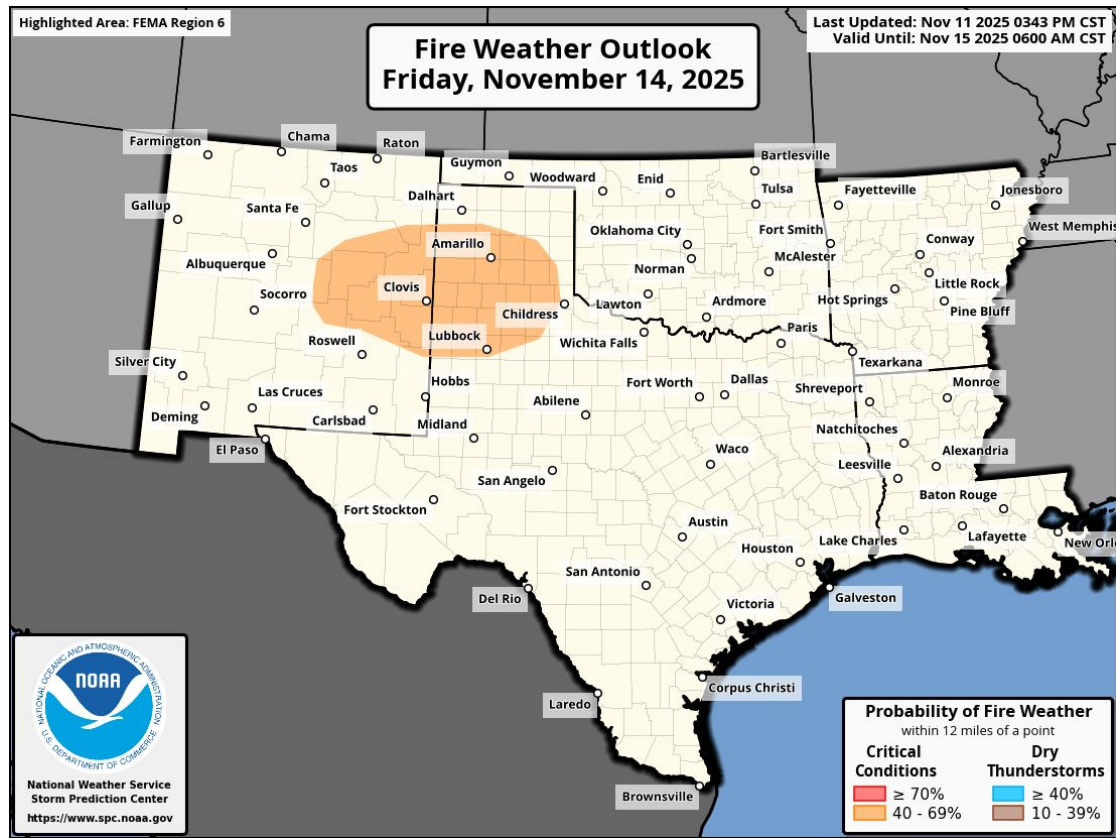
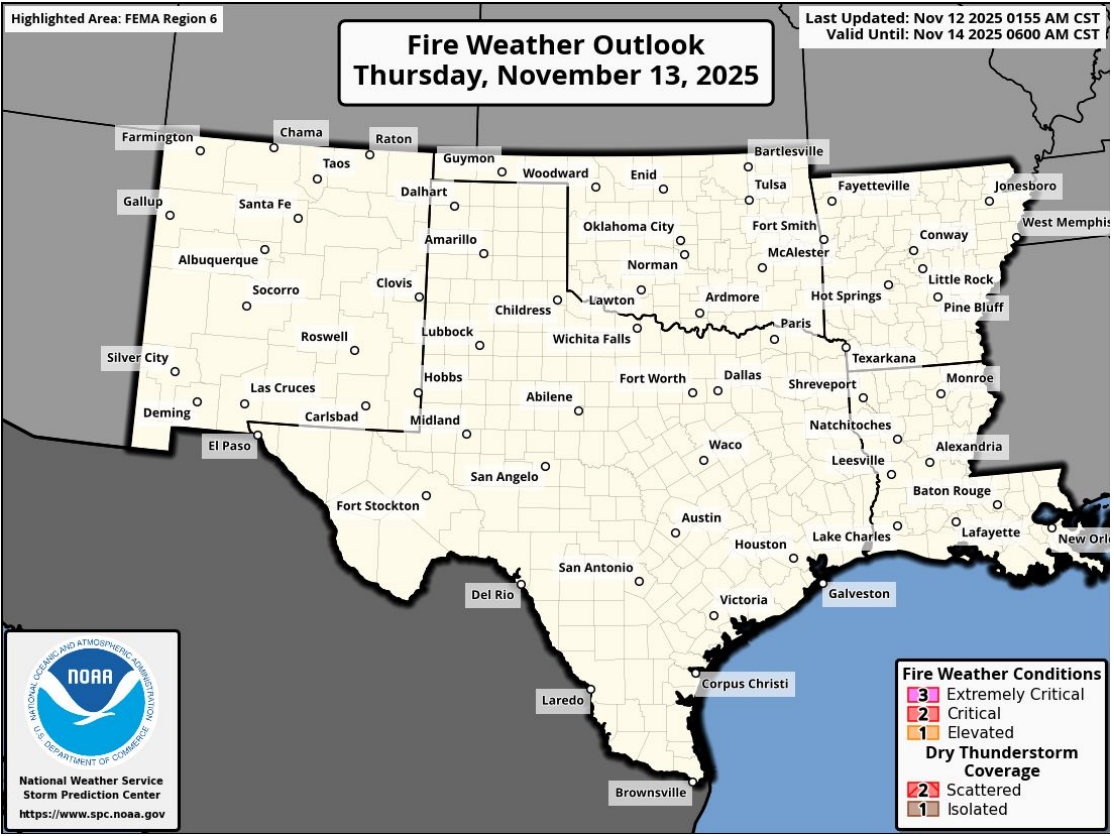
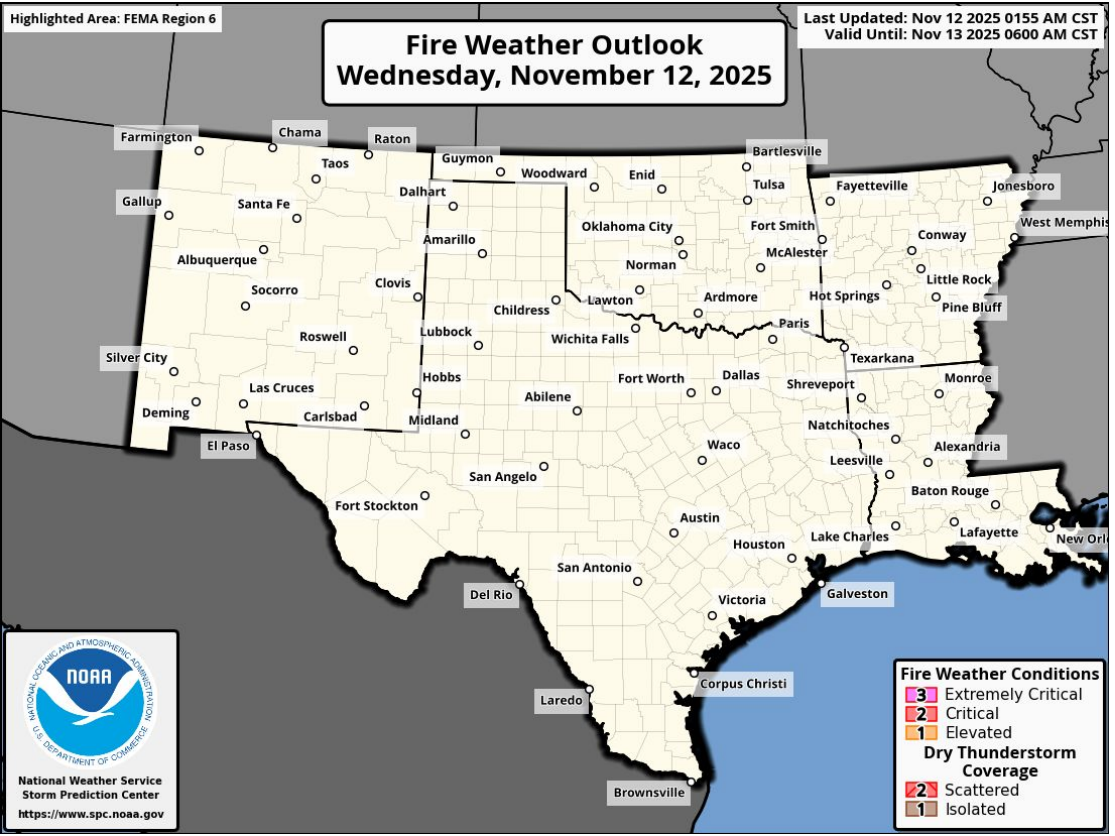
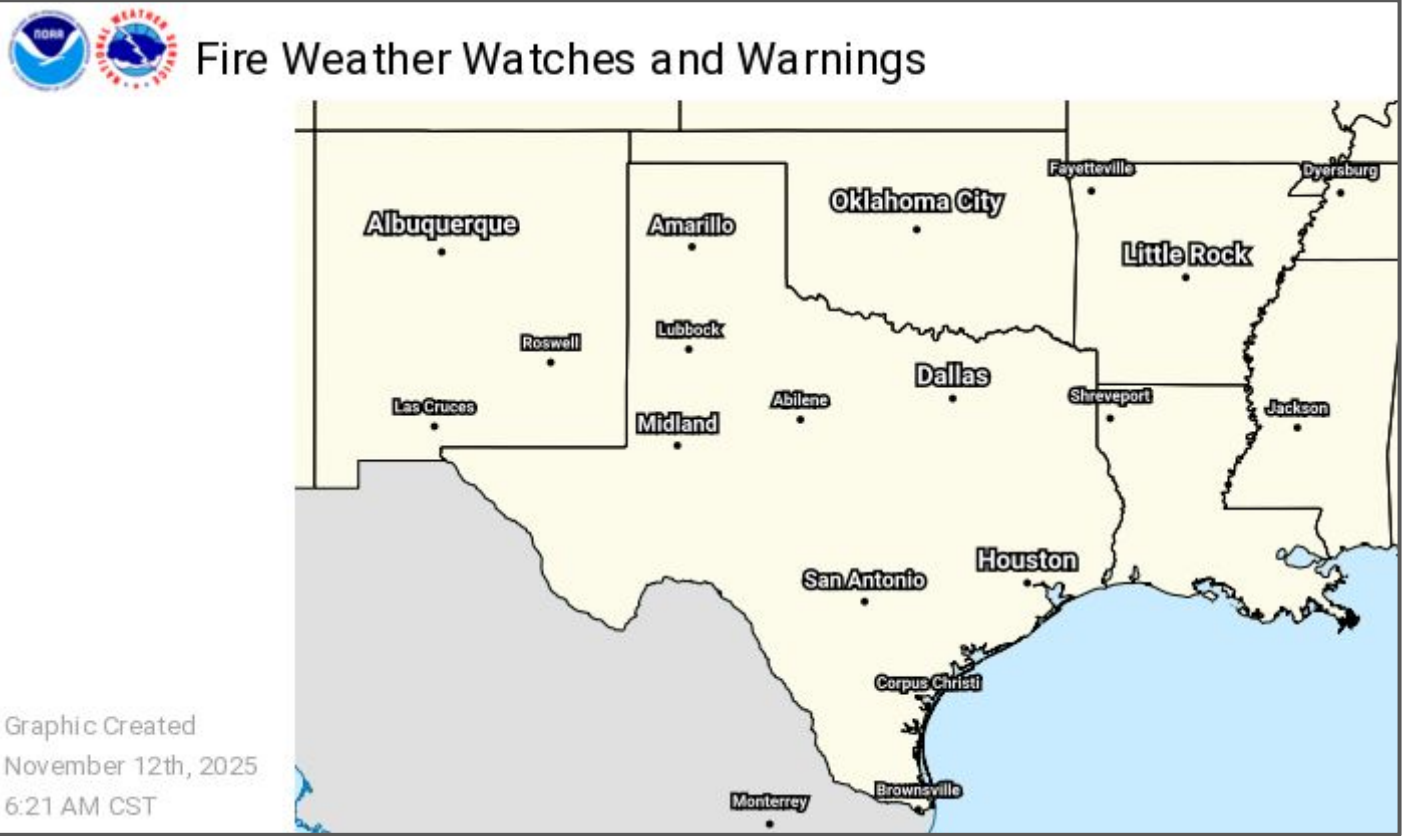


# Today's Tornado & Severe Wind / Hail Probabilities



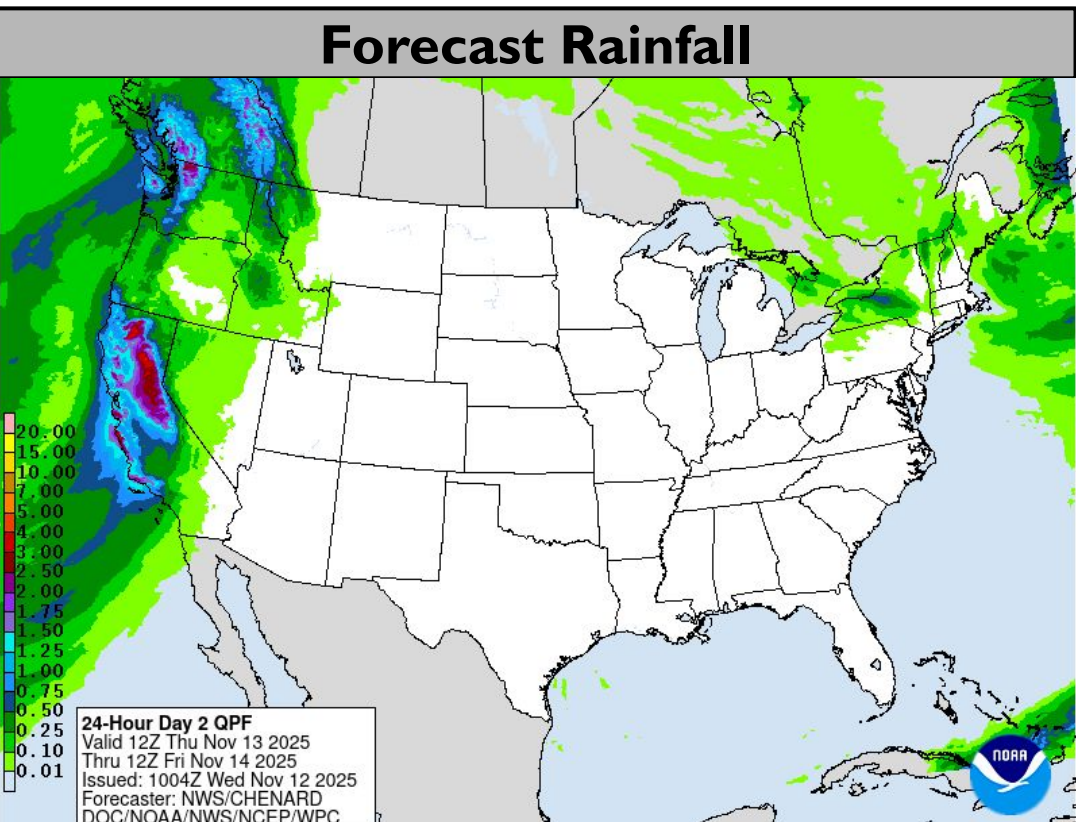
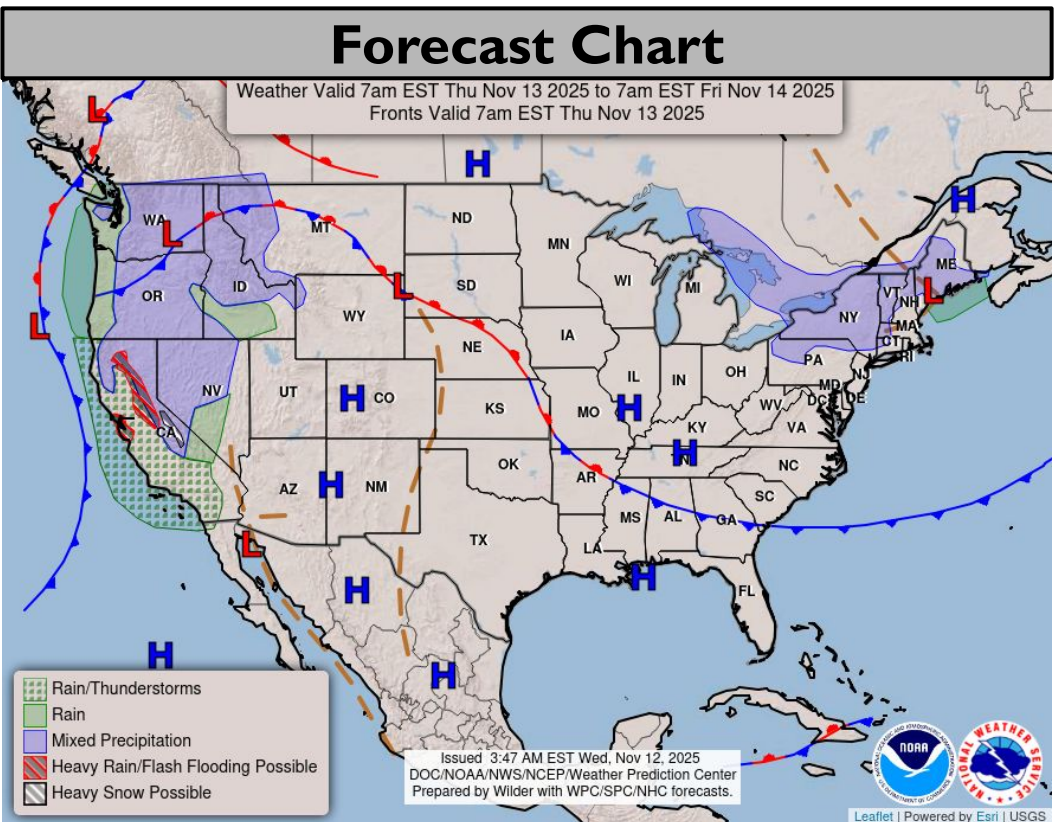
