FEMA Region 6 Weather Threat Briefing

Flash Flooding:

Marginal risk (level I of 4) today and Thursday over SETX, S LA and in SE LA on Friday.

• Winter Weather:

- Minor impacts (level 2 of 5) for snow in N NM mountains today. Minor impacts to travel in SE OK, AR due to snow, freezing rain, sleet, and rain this morning and again tonight.
- Another system pushes through on Wednesday night into Friday that has potential to bring wintry mix. At this time, snow totals remain non-impactful outside of N NM, but monitoring icing potential.

River Flooding:

Monitoring rivers in SETX Thursday for rises due to the rainfall.



Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall







Today's Tornado & Severe Wind / Hail Probabilities









Winter Weather Advisory for N NM Mts through 8 AM MST today for 2-6 inches of snow with up to 9 inches above 9000 ft, and in OK through 9 AM **CST** today for a glaze of ice, and in AR for a mix of snow and ice up to 0.2". Portions of AR expire by noon CST and other areas are in effect until 6 **AM** Tuesday.








Tomorrow's Tornado & Severe Wind / Hail Probabilities













"Day 3-7" Hazards Outlook








