# FEMA Region 6 Weather Threat Briefing

Tuesday, December 02, 2025

**Disclaimer:** The purpose of this briefing is to provide a <u>Regional</u> weather threat assessment and is meant as a general overview. County/Parish decision makers should consult their local NWS forecast offices for the latest detailed, local weather information.

- Flash Flooding:
  - Marginal risk (level 1 of 4) Thursday over SETX, S LA and in SE LA on Friday.
- Winter Weather:
  - Light snow over N NM on Wednesday will spread into the TX/OK Panhandles and W OK on Thursday.
    - 2-4" of snow in the northern NM mountains (4-8" above 7500 ft) with an 1" of snow elsewhere.
- River Flooding:
  - Monitoring rivers in SETX Thursday/Friday for rises due to the rainfall.



Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall





> Note: Numerical levels (e.g. level 1 of 4) will not be assigned to riverine flooding due to the varying levels of impacts across flood categories.












Winter Weather Advisory for N NM Mts Wed-Thu morning. 2-4" of snow with 4-8" above 7500 feet.








Minor impacts (level 2 of 5) to travel from snow in N NM into the OK/TX Panhandles.

Marginal risk (level 1 of 4) for flash flooding over SETX and S LA.





Severe Weather Outlook Monday, December 08, 2025





Purple	Extreme Safety: Property Damage Unavoidable, Immediate Action to Save Life will be Needed Impact Potential: Typically Results in Long-Lived Widespread Major Disruption to Daily Life	Severe: High Risk from SPC Flooding: Major flooding expected over a widespread area (including urban locations) Tropical: A Major Hurricane (Cat3 or greater) expected to move towards or near any coastline Fire: Large area of critical conditions for 2 or more days, Warnings for 3 or more days, Long term (months) of severe to extreme drought	<ul> <li>A Category 4 hurricane is headed towards the SE LA; major storm surge, flooding and damaging winds anticipated to begin tomorrow</li> <li>Widespread severe storms expected, tornado outbreak probable with long- lived, very widespread and particularly intense storms</li> </ul>
