Summary

- **Winter Weather/Cold:**

- **Cold temps this morning across OK, AR, TX, and LA. Most areas will see temps rise above freezing today (exceptions in portions of OK and AR).**
- **Black ice on roads can cause travel impacts. Abundant sunshine will help with melting.**



Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall




No significant flooding is expected.

Note: Numerical levels (e.g. level 1 of 4) will not be assigned to riverine flooding due to the varying levels of impacts across flood categories.








Cold temps this morning across OK, AR, TX, and LA.






Excessive Rainfall Outlook






Excessive Rainfall Outlook






Tomorrow's Tornado & Severe Wind / Hail Probabilities













“Day 3-7” Hazards Outlook








