STATEWIDE CURRENT SITUATION: On May 8, Governor Greg Abbott issued a disaster proclamation related to fire weather conditions that began on August 10, 2025, as amended and renewed in subsequent proclamations, certifying that increased fire weather conditions pose an imminent threat of widespread or severe damage, injury, or loss of life or property.

On March 18, Gov. Abbott announced that the Federal Emergency Management Agency (FEMA) has approved a request from the State of Texas for a Fire Management Assistance Grant (FMAG) for the Corner Pocket Fire in Donley County, which threatened and damaged homes and infrastructure in the Texas Panhandle and forced local evacuations.

On February 19, Gov. Abbott announced that the Federal Emergency Management Agency (FEMA) has approved a request from the State of Texas for a Fire Management Assistance Grant (FMAG) for the 8 Ball Fire that started in Armstrong County and entered Donley County, which has threatened homes and infrastructure in the Panhandle area and has prompted local evacuations.

On February 17, Gov. Abbott directed the Texas Division of Emergency Management (TDEM) to increase the readiness level of the Texas State Emergency Operations Center (SOC) to Level II (Escalated Response) ahead of critical wildfire danger

anticipated across portions of the western half of Texas.

On February 15, Gov. Abbott announced that he directed TDEM to activate additional state wildfire response resources in anticipation of elevated-to-critical fire weather conditions in large areas of South, West, and Northwest Texas.

OPERATIONAL PRIORITIES:

1. Protect life and property.
2. Support rapid & effective response.
3. Collect and disseminate accurate incident information to improve decision-making.
4. Accurately track incident costs associated with assigned resources for cost recovery.

Region 1 (Includes DDs 1, 2, and 7)

DD 1 – Amarillo (Includes Armstrong, Briscoe, Carson, Castro, Childress, Collingsworth, Dallam, Deaf Smith, Donley, Gray, Hall, Hansford, Hartley, Hemphill, Hutchinson, Lipscomb, Moore, Ochiltree, Oldham, Parmer, Potter, Randall, Roberts, Sherman, Swisher, and Wheeler Counties). [DDEOC 01 has activated to Level II \(Escalated Response\) on May 15.](#)

Carson County: [The McBride Fire burned 2,192 acres and is contained.](#)

Briscoe County: [The Cherokee Fire burned 3,222 acres and is contained.](#)

Childress County: [The Baylor Creek Fire burned 195 acres and is contained.](#)

Haskell County: [The Mustache Fire has burned 529 acres and is contained.](#)

Hartley County: [The Roman Fire has burned 2,000 acres and is 75% contained.](#)

Hall County: [The Ox Bow Fire has burned 2,000 acres and is 40% contained. The Chainey Mountain Fire has burned 600 acres and is 40% contained.](#)

Motley County: [The Crooked Cook Fire has burned 1,388 acres and is 100% contained. The Comanche Fire has burned 1,300 acres and is 30% contained.](#)

Oldham County: [The Line Fire has burned 10,000 acres and is 75% contained.](#)

Potter County: The Shifty Fire has burned 5,277 acres and is contained.

Randall County: The Hunggate Fire has burned 14,000 acres and is 40% contained. Approximately 800 people were temporarily evacuated from 310 homes. The Western Fire has burned 1,000 acres and is 80% contained. The Chocolate Chip Fire has burned 10,000 acres and is 50% contained.

DD 2 – Lubbock (Includes Bailey, Cochran, Crosby, Dickens, Floyd, Garza, Hale, Hockley, King, Lamb, Lubbock, Lynn, Motley, Terry, and Yoakum Counties) [activated to Level III \(Increased Readiness\) on May 15.](#)

Region 3 (Includes DDs 5, 6, 14, and 15)

DD 5 – Mt. Pleasant (Includes Bowie, Cass, Delta, Franklin, Hopkins, Lamar, Morris, Red River, and Titus Counties)

Bowie County: The Bowie 4050 Fire burned 2 acres and is contained.

DD 6 – Tyler (Includes Anderson, Camp, Cherokee, Gregg, Harrison, Henderson, Marion, Panola, Rains, Rusk, Smith, Upshur, Van Zandt, and Wood Counties)

Rusk County: The Rusk 4088 Fire burned 1.87 acres and is contained.

DD 14 – Lufkin (Includes Angelina, Houston, Jasper, Nacogdoches, Newton, Polk, Sabine, San Augustine, San Jacinto, Shelby, Trinity, and Tyler Counties)

Houston County: The Houston 4105 Fire burned 30 acres and is contained.

RESPONDING STATE AGENCIES/ORGANIZATIONS REPORTS

Texas Division of Emergency Management, Texas A&M University System (TDEM):

Communications Coordination Group (CCG):

Cellular providers continue to monitor tower sites and top off backup generators. Backup cellular platforms are on standby to deploy.

Mass Care:

Mass Care continues to monitor potential activities and provide sporadic feeding support. As of February 20, four feeding sites have provided a total of 1,115 meals in partnership with American Red Cross and the Salvation Army.

Education:

TDEM maintains communications with public university systems, who confirmed they are monitoring the weather and have no disruptions to their normal operations.

Texas A&M Engineering Extension Service Public Works Response Team (TX/PWRT):

PWRT continues to support and coordinate operations from the SOC and are monitoring requests for service.

Texas A&M AgriLife Extension Service (AgriLife):

On February 22, AgriLife conducted fencing damage assessments and monitoring needs with local landowners in affected counties. On February 23, the Disaster Assessment and Recovery (DAR) Animal Evacuation and Response Team demobilized and returned to headquarters.

Texas A&M Forest Service (TAMFS):

TAMFS has pre-positioned heavy equipment, engines, and aircraft across regions impacted by elevated fire weather conditions. The Emergency Operations Center (EOC) is activated. A targeted public awareness campaign is being conducted in the Panhandle region to include billboard messaging and outreach through local and regional news media. In total, TAMFS has 84 personnel committed to this event.

Texas Military Department (TMD):

TMD has activated one Rotary Wing Medium (RWM) Mission Ready Package (MRP) consisting of two UH-60s, to provide direct aerial fire support to TAMFS. TMD has activated 12 personnel for this event.

Texas Parks and Wildlife Department (TPWD):

Texas Game Wardens have responded to multiple wildfires in TDEM Region 1 and supported local Law Enforcement with evacuations for the 8-Ball, Lavender, and Spade wildfire, along with traffic control. In total, TPWD has assisted 100 people in evacuation.

Texas Department of Transportation (TxDOT):

TxDOT has an Emergency Management Coordinator (EMC) and a State Operations Center (SOC) Liaison Officer (LNO) supporting in Austin. TxDOT continues to

coordinate with Texas A&M Forest Service (TAMFS) for Dynamic Message Sign (DMS) wildfire messaging, if needed.

Up to date road conditions are available on drivetexas.org.

Texas Department of State Health Services (DSHS):

The State Medical Operations Center (SMOC) moved from Limited Activation Level to Increased Readiness Level. All assets have demobilized as of May 5.

Texas Emergency Medical Task Force (EMTF):

All EMTF assets have been demobilized for this incident. EMTF totals for this incident include 257 aided, 13 treated, and one transported.

Texas Health and Human Services Commission (HHSC):

HHSC began staffing the SOC in support of severe weather conditions on February 17 and will remain for the duration of the incident.

Texas Department of Information Resources (DIR):

Texas Department of Information Resources (DIR) is monitoring the situation using cybersecurity tooling and threat intelligence feeds. No cyber threats related to this weather event have been identified.

Texas Department of Agriculture (TDA):

The State of Texas Agriculture Relief (STAR) Fund has been activated to support farmers and ranchers affected by wildfires. Ranchers needing hay or feed can use TDA's Hay Hotline at (877) 429-1998. Mental health support is available 24/7 through the AgriStress Helpline by trained professionals familiar with rural challenges at (833) 897-2474.

Salvation Army:

The Amarillo Rapid Response Unit (RRU) has fed evacuees and first responders in Donley County. In total, 89 meals and 120 bottled waters were provided.
