



## Texas Division of Emergency Management State Situation Report

**STATEWIDE CURRENT SITUATION:** On May 21, Governor Greg Abbott announced that he directed the Texas Division of Emergency Management (TDEM) to request officials from the U.S. Small Business Administration (SBA) join state and local partners in conducting preliminary damage assessments in Panhandle communities affected by recent wildfire activity and South Texas communities impacted by April severe storms. These assessments will help determine if the state meets the thresholds for additional federal disaster assistance.

On May 13, Gov. Abbott announced that the SBA approved his request for a disaster declaration for additional Texas communities following impacts from last month's severe storms. The SBA has added the following counties to its declaration: Calhoun, DeWitt, Goliad, Jackson, Lavaca, Refugio, and Victoria. These counties have been included in addition to the North Texas communities approved for SBA assistance.

On May 11, Gov. Abbott requested that the SBA include additional Texas communities in the federal disaster declaration following impacts from last month's severe storms. If approved, the SBA declaration will make federal assistance available through disaster loans for Victoria County and its contiguous counties, in addition to the North Texas counties already included.

On May 7, Gov. Abbott announced that he directed TDEM to request officials from the

SBA join state and local partners in conducting preliminary damage assessments in coastal communities impacted by recent severe storms and tornadic activity. These assessments will help determine if the state meets the thresholds for additional federal disaster assistance.

On May 6, Gov. Abbott amended the state's disaster declaration for severe weather to include Calhoun, Lamar, Palo Pinto, Parker, Victoria, and Wise Counties.

On May 5, Gov. Abbott requested a disaster declaration from the SBA for North Texas communities impacted by severe storms. If approved, the SBA declaration will make federal assistance available through disaster loans for Parker and Wise counties and their contiguous counties.

On May 1, Gov. Abbott amended the state's disaster declaration for severe weather to include Palo Pinto County following impacts from severe storms. With this addition, the total number of counties included in the state's disaster declaration is now four. Additional counties may be added as conditions warrant.

On April 28, Gov. Abbott announced that he issued a disaster declaration for three North Texas counties impacted by severe storms that continue to affect homes and businesses in the region. The counties included in the Governor's declaration are Lamar, Parker, and Wise. Additional counties may be added as conditions warrant.

On April 10, Gov. Abbott announced that he directed TDEM to activate state emergency response resources in anticipation of severe weather expected to impact multiple regions of Texas over the next several days.

#### **OPERATIONAL PRIORITIES:**

- Protect life and property.
- Support rapid & effective response.
- Collect and disseminate accurate incident information to improve decision-making.
- Accurately track incident costs associated with assigned resources for cost recovery.

#### **Region 2 (Includes DDs 3, 4, and 22)**

DD 4 – Dallas/Ft. Worth (Includes Collin, Dallas, Denton, Ellis, Erath, Hood, Hunt, Johnson, Kaufman, Navarro, Palo Pinto, Parker, Rockwall, Somervell, Tarrant, and Wise Counties): On April 26, DDEOC 4 decreased from Level II (Escalated Response Conditions) to Level III (Increased Readiness Conditions). On April 26, Disaster

Declarations were received from Parker and Wise Counties. On May 4, DDEOC 4 returned to Level IV (Normal Conditions).

**Palo Pinto County:** On April 28, an EF-3 tornado with winds up to 145 mph occurred in Mineral Wells according to NWS preliminary reports. Support local recovery efforts by donating to the Mineral Wells Disaster Relief Fund, managed by the Envision Mineral Wells Foundation, Inc. For Palo Pinto County, monetary donations are managed by United Way of Parker County.

**Parker County:** Six shelters were opened in Parker County. The First United Methodist Church, Hilltop Family Church, Springtown Church of Christ, Legacy Church, and the Springtown Baptist Temple.

**Wise County:** Emergency supplies have arrived in the impacted area and are being distributed - Fixed site at 138 Port O' Call, Runaway Bay, TX - providing work gloves, trash bags, masks, shovels, rakes, and tarps. For Wise County, monetary donations are managed by United Way of Wise County.

### **Region 3 (Includes DDs 5, 6, 14, and 15)**

DD 6 – Tyler (Includes Anderson, Camp, Cherokee, Gregg, Harrison, Henderson, Marion, Panola, Rains, Rusk, Smith, Upshur, Van Zandt, and Wood Counties): DDEOC 6 returned to Level IV (Normal Conditions) on May 11.

## **RESPONDING STATE AGENCIES/ORGANIZATIONS REPORTS**

**Texas Division of Emergency Management, Texas A&M University System (TDEM):** Sixteen Incident Support Task Force (ISTF) members are deployed to Wise, Parker, and Palo Pinto Counties to assist with EOC operations, damage assessments, donation management, and survivor services. While mass care partners remain on-site for sheltering and feeding, no formal requests for coordination have been received. Mass care teams remain on standby to respond to identified community needs.

Disaster Loan Outreach Centers (DLOC) were opened in the following locations:

Wise County: Runaway Bay Event Center (Closed)

Parker County: First United Methodist Church (Open); Holiday Hills Golf Course, Conference Room (Closed)

Victoria County: Victoria County Regional Disaster Response and Recovery Center (Open)

**Texas A&M Engineering Extension Service Texas A&M Task Force 1 (TEEX/TX-TF1):** TDEM has authorized the complete demobilization of all TX-TF resources assigned to this event.

**Texas A&M Engineering Extension Service Texas Task Force 2 (TEEX/TX-TF2):** On April 26, Texas Task Force 2 (TX-TF2) completed their Wise County Search and returned to their pre-position location in Dallas County to monitor the weather. In total, 56 structures were searched, 27 of those being considered destroyed or severely damaged.

**Texas A&M Forest Service (TAMFS):** TAMFS activated three Saw Teams in Parker and Wise Counties. There were 13 personnel committed to this event.

**Texas Department of Transportation (TxDOT):** As of April 30, no state-maintained roads have been closed due to severe weather. TxDOT crews have been working on clearing debris and downed trees from state-maintained roadways. Check DriveTexas.org for the most current road safety advisories.

### **VOLUNTEER ORGANIZATIONS ACTIVE IN DISASTERS (VOAD)**

**Southern Baptists of Texas Convention Disaster Relief (SBTC):** SBTC is responding to the storms that struck Runaway Bay and Springtown area. [As of May 22](#), SBTC has provided [498](#) showers, completed [130](#) clean-up and recovery requests, provided [1,524](#) meals, made [604](#) spiritual/emotional care contacts, and provided [7,010](#) volunteer hours. Recovery operations for SBTC are anticipated to be completed on May 22.

**American Red Cross (ARC):** ARC assisted with operating shelter locations in Parker, Palo Pinto, and Victoria Counties. As of May 4, all shelters have closed.

**Texans on Mission (TXM):** TXM operations for this deployment stood down on May 16. There was a total of 124 work orders processed with one work order transferred to a local team to complete. TXM covered four sites, with over 178 volunteers. TXM performed 86 assessments, completed 96 chainsaw jobs, provided 274 showers, and provided 6,082 volunteer hours.
