STATEWIDE CURRENT SITUATION: The Texas State Emergency Operations Center remains activated at Level II (Escalated Response) to support local flood response operations as flood threats continue across South Texas and recovery efforts remain ongoing across Southwest and South-Central Texas. Personnel continue to coordinate requests from local officials for the appropriate phase of the disaster. Recovery staff continues to provide cleanup assistance, and personnel are connecting affected Texans with available resources. Staff across the state continue to encourage impacted individuals to report damage online at damage.tdem.texas.gov.

On August 3, Governor Greg Abbott announced that the Texas Health and Human Services Commission (HHSC) received federal approval to extend the deadline for Supplemental Nutrition Assistance Program (SNAP) recipients to apply for replacement benefits for food lost or destroyed during July's severe weather and flooding. HHSC also received approval to add two additional counties to the assistance list.

On July 24, Gov. Abbott visited Cotulla to assess flood damage and provided an update on the state's response to the recent severe flooding. During the visit, he credited local officials, first responders, volunteers, and residents for their swift actions, saying their efforts helped save lives. Additionally, Texas requested the addition of 30 counties to its Major Disaster Declaration request for FEMA Individual Assistance.

On July 22, Governor Greg Abbott announced that the Texas Health and Human Services Commission (HHSC) received federal approval to extend the time Supplemental Nutrition Assistance Program (SNAP) recipients can apply for replacement benefits for food lost or destroyed by recent flooding.

On July 20, Gov. Abbott surveyed flood-damaged communities by helicopter, then provided an update during a press conference in Kerrville on Texas' ongoing response to severe floods that impacted large parts of the state last week.

On July 17, Gov. Abbott requested a Presidential Disaster Declaration to support Texas' ongoing response and recovery efforts following severe weather and flooding impacting communities across the state. Gov. Abbott also visited Uvalde County to receive updates on flood conditions, survey damage, and meet with state and local officials coordinating the local response. This was followed by the Governor holding a press conference in the City of Uvalde.

On July 16, Gov. Abbott held a severe weather briefing and press conference at the State Operations Center in Austin to provide an update on the state's ongoing response to flooding across Texas. Response efforts continue while coordinating with local partners to provide assistance where it is needed most.

On July 14, Gov. Abbott issued a disaster declaration for 59 Texas counties as severe storms continue to threaten the state. Additional counties may be added as conditions warrant. The Governor also directed the Texas State Emergency Operations Center (SOC) to continue 24-hour operations at Level II (Escalated Response) to support the state's ongoing response to severe storms and flash flooding.

On July 12, Gov. Abbott directed the Texas Division of Emergency Management (TDEM) to activate state emergency response resources ahead of severe weather and flash flooding threats expected to impact multiple regions of Texas over the next several days.

OPERATIONAL PRIORITIES:

- Protect life and property.
- Support rapid & effective response.
- Collect and disseminate accurate incident information to improve decision-making.
- Accurately track incident costs associated with assigned resources for cost recovery.

Region 1 (Includes Disaster District (DD) 1, 2, and 7)

As of August 5, Region 1 had a total of 15 members deployed to support the State of Texas and TDEM Regions 5, 6, 7, and 8.

DD 1 – Amarillo (Includes Armstrong, Briscoe, Carson, Castro, Childress, Collingsworth, Dallam, Deaf Smith, Donley, Gray, Hall, Hansford, Hartley, Hemphill, Hutchinson, Lipscomb, Moore, Ochiltree, Oldham, Parmer, Potter, Randall, Roberts, Sherman, Swisher, and Wheeler Counties): DDEOC 1 remains activated to Level III (Increased Readiness Conditions) for severe weather.

DD 2 – Lubbock (Includes Bailey, Cochran, Crosby, Dickens, Floyd, Garza, Hale, Hockley, King, Lamb, Lubbock, Lynn, Motley, Terry, and Yoakum Counties): DDEOC 2 remains activated to Level III (Increased Readiness Conditions) for severe weather. DDEOC 2 is monitoring the weather for heat-related advisories and warnings to ensure district safety.

DD 7 – Abilene (Includes Brown, Callahan, Coleman, Comanche, Eastland, Fisher, Haskell, Jones, Kent, Knox, Mitchell, Nolan, Runnels, Scurry, Shackelford, Stephens, Stonewall, Throckmorton, and Taylor Counties): DDEOC 7 remains activated to Level III (Increased Readiness Conditions) for severe weather. DDEOC 7 is monitoring the weather for heat-related advisories and warnings to ensure district safety.

Region 5 (Includes DDs 19-21)

Region 5 continues recovery and response operations. State and mutual aid resources remain deployed to support [Live Oak County](#). As of [August 6](#), per the West Gulf River Forecast Center (WGRFC), the Nueces River is shown as [Minor](#) Flooding Occurring or Forecasted in Live Oak County.

As of [August 6](#), per Water Data of Texas, Lake Corpus Christi is [82.9%](#) full at 7:00 pm.

As of [August 6](#), per the West Gulf River Forecast Center (WGRFC), the Nueces River is shown as Moderate Flooding Occurring or Forecasted in Live Oak County. Three Rivers has fallen below [moderate](#) flood stage and is currently [22.43ft](#) at [10:00](#) pm.

[On August 6, in agreement with the Live Oak County Judge, the All-Hazards Incident Management Team \(AHIMT\) and the All-Hazards Group demobilized.](#)

TDEM field staff continue to meet with local officials across counties in the Region to emphasize the importance of coordinated communication, information flow, and messaging.

Situational awareness has also been established with the U.S. Coast Guard in Corpus Christi.

TDEM personnel continue to assist local partners with messaging coordination, tracking local resources and costs, and advanced planning for potential needs related to damage assessments, debris management, and recovery operations.

On August 3, the Mayor of the City of Three Rivers submitted a Mayoral Disaster Declaration due to Public Health and Safety due to flooding. A boil water notice has been issued for Three Rivers. On August 4, bottled water was delivered from the TDEM warehouse, and distribution has been initiated.

On August 6, TDEM delivered an additional 20 pallets of bottled water for distribution in Three Rivers. Additional bottled water has been requested to support ongoing needs.

As of August 6, Live Oak County Emergency Management's Voluntary Evacuation for low-lying areas remains in place.

As of August 5, all County Roads (CR) are now open.

On August 6, the Live Oak County Fairgrounds is now closed after being set up to accommodate livestock requiring evacuation.

DCEOC 20 is coordinating with state and local partners to address potential needs as preparations for the transition from response to full recovery are underway.

DD 20 – Corpus Christi (Includes Aransas, Bee, Brooks, Duval, Jim Wells, Kenedy, Kleberg, Live Oak, Nueces, Refugio, and San Patricio Counties): DDEOC 20 maintains Level IV (Normal Conditions) status.

Region 6 (Includes DDs 17, 18, and 24):

The Regional Emergency Operations Center (REOC) 6 maintains a Level IV (Normal Conditions) status. Region 6 continues recovery and response operations along with coordinated efforts with the TDEM HQ Recovery Section. Overall, personnel remain focused on supporting survivors, strengthening local recovery partnerships, and preparing communities for the next phase of recovery.

Individual State of Texas Assistance Tool (iSTAT) assessments have been completed for the following counties within Region 6: Bandera, Bexar, Comal, Dimmit, Gillespie, Kendall, Kerr, Kinney, La Salle, Maverick, McMullen, Real, Val Verde, and Zavala. Texans are encouraged to report damage to homes and businesses to inform officials of outstanding damage.

Public State of Texas Assistance Tool (pSTAT) has been completed for Bandera, Bexar, Dimmit, Gillespie, Kendall, Kerr, Kinney, La Salle, McMullen, Real, Uvalde, and Val Verde Counties. Assessments are ongoing for Comal and Guadalupe Counties.

The following counties have met their thresholds for public assistance within the Region: Bandera, Dimmit, Gillespie, Kendall, Kerr, Kinney, La Salle, McMullen, Maverick, Real, Uvalde, Val Verde, and Zavala.

DD 18 – San Antonio (Includes Atascosa, Bandera, Bexar, Comal, Frio, Gillespie, Guadalupe, Karnes, Kendall, Kerr, McMullen, Medina, and Wilson Counties): DDEOC 18 maintains a Level IV (Normal Conditions) status. Damage assessments are ongoing for homes, businesses, public facilities, and infrastructure. Response efforts are transitioning to recovery operations.

Bexar County: Bexar County EOC maintains Level IV (Normal Conditions) status. On August 4, Bexar County completed Damage Assessments. [Community needs are being met locally.](#)

Gillespie County: Gillespie County maintains Level IV (Normal Conditions) status. As of [August 6](#), the request to the Texas Commission on Environmental Quality (TCEQ) and Texas Historical Commission (THC) permits for the Gillespie County Landfill authorizing a temporary debris site and burn site is pending.

As of August 4, regional recovery efforts remain focused on connecting impacted households with governmental and voluntary agency resources to address residential repair, rebuilding, debris removal, and other validated homeowner unmet needs. State agencies remain in direct coordination with the County EMC following requests for assistance involving private roads, private property access, residential repairs, and debris clearing.

Guadalupe County: Guadalupe County maintains Level IV (Normal Conditions) status. The County stands at four pSTAT entries, all related to damaged flood sensors. Nine iSTATs have been submitted in Guadalupe County.

Kendall County: Kendall County maintains Level IV (Normal Operations) status. The county continues to focus on cleanup and recovery management activities following recent flood impacts. Local debris management operations remain ongoing, including dumpster pickup services for residents as recovery efforts progress.

Kerr County: On August 5, Kerr County returned to Level IV (Normal Conditions) status. [As of August 6, Kerr County's Debris Management Plan is in the final stages of completion. Additionally, meetings have been held regarding the repair of private roads. Road and Bridge personnel have begun making repairs.](#) As of [August 6](#), the county is continuing to verify the number of vehicles in the waterways. If they can see any identifying feature, they will call the owners and try to get them/insurance to remove it. For those they cannot identify owners or for those they cannot get in contact with, [the Sheriff's Office will have the vehicle removed.](#)

On August 5, Kerr County set up a Call Center with Crisis Response Ministry and Kerr Together. Catholic Charities continues supporting disaster case management activities while community partners assess ongoing housing assistance needs. Disaster Assistance Centers (DACs) will be operational in both Center Point and Kerrville, with the Center Point location planning on closing on August 30. ISTF personnel assisted with intake and DAC operations. Long-term recovery efforts remain active, with Kerr Together providing community recovery support through the Texas Community Recovery (TCR) program. Private sector partners continue assisting with small business recovery. ISTF personnel have recommended expanding outreach to additional agencies and organizations providing disaster case management services.

Up to 90 homeowners require assistance with damaged private roads and driveways, with additional needs involving debris removal, home repair, rebuilding, financial assistance, and volunteer labor. Efforts remain focused on expanding Disaster Case Management capacity, addressing housing and homeowner recovery needs, and

aligning partner resources to support locally led long-term recovery.

DD 24 – Del Rio (Includes Dimmit, Edwards, La Salle, Kinney, Maverick, Real, Uvalde, Val Verde, and Zavala Counties): DDEOC 24 maintains Level IV (Normal Operations) status. DD 24 remains focused on recovery, damage assessments, resource coordination, and support to impacted local jurisdictions. Currently, DD 24 is still tracking three TXDOT road closures. Another three are damaged, but passable with caution.

Dimmit County: Dimmit County EOC maintains Level IV (Normal Operations) status. As of August 5, the Nelson Well is still powered by a booster pump. A second booster pump installation is planned to keep up with supply and demand. Samples from the Ivy Well were taken and sent to TCEQ on August 2, results are pending. On August 5, Dimmit County completed pSTAT submissions.

La Salle County: La Salle County EOC maintains Level IV (Normal Operations) status. PWRT will continue to monitor lift stations, [PWRT is planning to demobilize this weekend](#). Pumps are being bypassed to continue operation of lift stations.

Recovery efforts remain focused on strengthening local capacity, coordinating partner resources, addressing survivor needs, and advancing fiduciary and Disaster Case Management structures to support sustainable, locally led long-term recovery.

Real County: Real County maintains Level IV (Normal Operations) status. As of August 5, pSTAT submissions were completed. The Real County Judge has extended the Disaster Declaration for this incident. A bypass road was constructed near Hackberry Rd to access Camp Eagle, as well as one at River Rd to access Camp Wood Hills. The city of Camp Wood is still clearing debris inside the city limits and has extended their Disaster Declaration.

Uvalde County: Uvalde County EOC maintains Level IV (Normal Operations) status. As of August 5, Farm to Market (FM) 481 remains closed due to the bridge being out of commission with no timetable for repair, and Highway 55 is passable with caution. Public messaging efforts remain ongoing related to long-term recovery plans and debris management plans to keep residents informed. Damage assessments will continue as previously inaccessible areas become more accessible.

As of August 5, Uvalde County has transitioned into sustained recovery. Recovery partners continue addressing interim and long-term housing requirements. Catholic Charities have supported approximately 119 temporary housing placements, while additional funding and housing resources are being evaluated. Red Cross shelter capability remains available should temporary housing needs increase. On August 5, Uvalde County set up a Call Center for assistance information.

Zavala County: Zavala County maintains Level IV (Normal Operations) status. Meals are still being served at the nutrition center in Batesville. Zavala County is making arrangements for mosquito abatement.

As of August 5, Zavala County continues transitioning into sustained, locally led recovery. Long-term recovery efforts remain focused on strengthening the LTRC,

establishing fiduciary and Disaster Case Management capabilities, and expanding partner participation. Damage assessment and debris management activities have been completed, with voluntary agencies continuing survivor assistance, residential cleanup, and unmet-needs support.

Region 7 (Includes DDs 8, 9, and 10)

DD 10 – San Angelo (Includes Coke, Concho, Crockett, Irion, Kimble, Mason, McCulloch, Menard, Reagan, Schleicher, Sterling, Sutton, and Tom Green Counties): DDEOC 10 maintains a Level IV (Normal Conditions) status.

Long Term Recovery coordination will continue until all needs are met.

Region 8 (Includes DDs 11, 12, 13, and 23)

DD 13 – Bryan (Includes Brazos, Burleson, Grimes, Leon, Madison, Robertson, and Washington Counties)

Grimes County: Grimes County has met its disaster threshold for public assistance. Recovery Operations continue in Grimes County. The pSTAT has been completed in the county with estimated damage costs and supporting documentation for state assistance accompanying the assessments.

As of August 4, Region 8 continues to support other regions and have personnel deployed in support of this incident.

RESPONDING STATE AGENCIES/ORGANIZATIONS REPORTS

Texas Division of Emergency Management, Texas A&M University System (TDEM):

The State Operations Center (SOC) has activated to Level II (Escalated Response) in support of this severe weather incident. The SOC is directing interagency coordination to maintain unified communication, deploy necessary resources, and support response operations in affected regions across Texas.

Communications Coordination Group (CCG):

TDEM ESF 2 / Communications Coordination Group (CCG) partners are monitoring the situation and continue to prepare resources to respond as necessary.

As of [August 6](#), Amateur Radio groups such as Amateur Radio Emergency Service (ARES) and Radio Amateur Civil Emergency Service (RACES), are standing by to provide support in the affected areas if needed.

ESF-5 Incident Support Task Force (ISTF):

The Incident Support Task Force supported response and recovery operations in TDEM Regions 5, 6, and 7. Over the course of the incident, a total of 64 members were rostered and available for deployment in support of the event. Of those, 49 members were deployed over a 22-day operational period. All resources have demobilized from this incident as of 8:00 am on August 6.

Texas A&M University Veterinary Medicine & Biomedical Sciences (TAMU-CVM):

As of July 18, the Texas A&M Veterinary Emergency Team (TAMU VET) Type 3 Veterinary Medical Support team repositioned from Kerrville to Raymondville High School. TAMU VET has 12 vet members and support equipment supporting search and rescue canines in the field. Canine teams are on standby for flooding issues as waters continue down the river basin, while most work is water rescue and not canine search. The team has answered two queries from different handlers about their canines-no requests for TAMU VET services.

Texas A&M Engineering Extension Service Texas Task Force 1 (TEEX/TX-TF1):

As of August 6, Texas Task Force 3 Flood Water Rescue boat squad was demobilized. The remaining Swift Water Rescue (SWR) boat squad is in Live Oak County, monitoring flood conditions.

Total contacts among Task Force resources include 54 rescues, 143 human/pet evacuations, and 17 shelter-in-place.

Texas A&M Engineering Extension Service – Public Works Team (TX-PWRT):

Texas A&M Engineering Extension Service (TEEX) / Texas A&M Public Works Response Team (TX-PWRT) continues to support and coordinate operations from

the SOC. PWRT will continue to work with state partners to assess any water/wastewater, utility, or other public works needs.

As of [August 6](#), TX-PWRT continues to support bypass pumping operations and repairs with one team of four in Cotulla.

Texas A&M Forest Service (TAMFS):

[On August 6, TAMFS demobilized all personnel and resources from this incident.](#)

Texas A&M AgriLife Extension Service (AgriLife):

AgriLife has the Disaster Assessment and Recovery (DAR) unit monitoring the weather situation from the flooding in South and Southwest Texas. Weather information has been pushed out, and contact has been made with officials in affected counties.

County Extension Agents (CEA) and DAR Specialists are actively monitoring the weather situation and communicating with clientele to move livestock out of low-lying areas and to provide guidance on how to report AgSTAT damages.

As of August 5, there were 184 entries from the State of Texas Assessment Tool portal from landowners with agricultural damage to fencing, crops, livestock, and equipment, and 70 of those are requesting assistance from the AgriLife Extension Service. County Extension Agents in those affected counties will be notified to contact the requesting landowners to provide relief assistance.

On August 5, AgriLife demobilized all response for this event at 7:00 pm.

Texas Alcoholic Beverage Commission (TABC):

TABC has Enforcement Agents prepared to respond to areas affected by severe weather conditions. TABC has one liaison at the SOC and 35 Agents available.

Texas Commission on Environmental Quality (TCEQ):

TCEQ has placed emergency management staff and emergency response hazmat contractors on heightened readiness for possible deployment to assist with any air/water/waste related issues including drinking water/wastewater issues and/or emergency response activities.

As of [August 6](#), TCEQ is tracking one drinking water system on a boil water notice (BWN) affecting a population of 4,428. TCEQ has approved [10](#) temporary debris management sites.

Texas Department of State Health Services (DSHS) (Texas Emergency Medical Task Force (EMTF)):

On July 26, DSHS State Medical Operations Center (SMOC) is at Increased Readiness and is actively monitoring and supporting severe weather operations. DSHS will continue active SOC LNO coverage beginning July 14. [On August 6, all resources supporting this event have been demobilized.](#)

Texas Parks and Wildlife Department (TPWD):

Texas Game Wardens have identified statewide resources that are ready to support response operations as needed due to the increased severe weather threat affecting Texas. These resources include swift water rescue boat teams, helicopters with hoist capabilities, and Unmanned Aircraft System (UAS) teams.

As of August 4, the TPWD UAS team continues to assist TEEX with reconnaissance in the flooded areas of Live Oak County. The team will be conducting surveillance on the Nueces River to monitor crest progress.

TPWD has assisted in 154 rescue operations, 92 evacuations, and 27 shelter-in-place orders for this response.

Texas Military Department (TMD):

On August 5, all resources committed to this event were demobilized.

TMD has assisted with 19 rescue operations and 62 evacuation operations totaling 305 persons assisted and 25 pets.

Texas Cyber Command (TXCC):

As of July 29, TXCC is monitoring the weather situation and is ready to support the state's response efforts. TXCC is using cybersecurity tooling and threat intelligence feeds. There are no cyber threats related to this event.

Texas Department of Agriculture (TDA):

As of August 4, TDA maintains the Hay and Feed Hotline, a service for donating or requesting hay and other livestock feed resources, at (877) 429-1998. TDA also offers the AgriStress Helpline, offering confidential, professional mental health support to anyone seeking assistance at any time, at (833) 897-2474.

Volunteer Organizations Active in Disasters (VOAD)

American Red Cross (ARC):

The ARC is conducting Accelerated Outreach at three DAC locations to connect disaster with survivors, identify unmet needs, provide recovery information, and assist with registration for potential Immediate financial assistance through in-person support and outreach teams.

The ARC has established a Level 2 Disaster Relief Operation (DR 546-27) for this response.

As of August 4, ARC has closed all open shelters and concluded mass care service delivery operations. In coordination with TDEM and the Live Oak Office of Emergency Management (OEM), ARC has transitioned into recovery-focused support services.

The ARC Disaster Response Operation (DRO) is demobilizing and is transitioning into an Immediate Financial Assistance (IFA) Task Group on August 7. The IFA Task Group is expected to relocate their Headquarters to the ARC office in Kerrville to enhance operational effectiveness on August 8. Additional ARC resources will focus on casework, client care, and damage assessment activity, while supporting focused and accelerated outreach efforts.

The Salvation Army:

In response to the major storm impacting Central and South Texas, The Salvation Army is supporting shelter feeding as requested across the area and evaluating conditions to begin service in affected areas as requested.

As of July 27, The Salvation Army has distributed a total of 18,705 meals, 18,326 drinks, and 12,245 snacks across Uvalde, Zavala and Kerr Counties.

Texans On Mission (TXM):

As of [August 6](#), TXM continues to assess homeowner requests for flood recovery assistance. Kerrville has processed [185](#) requests and [transferred 14 to rebuild for completion](#); Uvalde has processed 76 requests. [The Uvalde team demobilized on August 5. The Kerrville teams are expected to demobilize on August 8.](#)

Southern Baptist Texas Convention (SBTC) Disaster Relief:

SBTC Disaster relief has responded to the flooding occurring in Southwest Texas. As of 8:00 am, [August 7](#), in Uvalde County, SBTC prepared and served [16,032](#) meals, made [922](#) emotional and spiritual care contacts, provided [381](#) showers, completed [188](#) loads of laundry, and served [5,750](#) volunteer hours. [The Uvalde site will be closing on August 8.](#) In Dimmit County, SBTC has provided [328](#) emotional and spiritual contacts, provided

101 showers, completed 71 loads of laundry, and served 670 volunteer hours. In Crockett County, SBTC has prepared and served 72 meals, nine emotional and spiritual care contacts, 34 showers, completed 16 loads of laundry, and served 20 volunteer hours.
