- **Elevated to critical fire weather across NM/W TX into the TX/OK Panhandles today.**
- **Severe thunderstorms with isolated heavy rain/flash flooding across Central and South TX on Friday into Saturday.**
- **Moderate to isolated major river flooding continues along the MS River.**



Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall



Moderate to major flooding is ongoing or forecast along the MS River. Osceola & Baton Rouge continue at major flood stage, and Vicksburg and Natchez are forecast to reach major flood stage next week. Crests are not expected near New Orleans until mid-April.

The Trinity River at Liberty is at moderate flood stage, with roads leading to subdivisions possibly flooding. Additional minor river flooding is possible across TX Friday into Saturday.

Atchafalaya River at Morgan City will hover around moderate flood through the week. Some flooding impacts to buildings possible.











Tomorrow's Fire Weather Outlook














Space Weather 3-Day Forecast




