

Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall



Moderate to major flooding continues along the MS River.

- **Major flooding is occurring near Baton Rouge, LA with a crest around 43.6ft expected in the next few days. Shipping and industrial activities significantly affected.**
- **The Bonnet Carré Floodway continues to operate and reduce flow at New Orleans, LA, maintaining 17.0ft (minor) flood stage through this week. Impacts to navigation. A 20 ft project levee protects the city.**

The Atchafalaya River at Morgan City, LA will maintain moderate flood stage for the next several days. Some flooding of buildings possible.







Excessive Rainfall Outlook





Winter weather advisories for NM and the TX Panhandle.










