

Note: Even though the image displays 5 days of forecasted rainfall, river forecasts only include 1-2 days of rainfall



Moderate flooding continues south of Vicksburg on the MS River. Points will continue to recede, outside of Baton Rouge that will remain at major flood stage through mid-May, with impacts mainly to agriculture and navigation.

- **The Bonnet Carré Floodway continues to operate and cresting conditions will continue at New Orleans, LA and Reserve, LA until the floodway is no longer operating. The USACE will slowly close bays over the next week as the lower MS River falls.**
- **The Atchafalaya River at Morgan City, LA will maintain moderate flood stage through next week. Some flooding of buildings possible.**

Minor river flooding continues across AR and ETX with minor and isolated moderate flooding in LA. Impacts are primarily to agriculture and secondary roads.




Lingering isolated severe storms this morning in Southeast Louisiana.









Space Weather 3-Day Forecast




