- **Slight risk area for severe thunderstorms with hail/wind and isolated heavy rain across NE NM/TX/OK into SW AR/NW LA.**
- **Isolated severe storms with heavy rain/flash flooding tomorrow across NE NM into the TX/OK Panhandles and E TX/LA into SE AR.**
- **Isolated strong/severe storms with heavy rain/flash flooding Wednesday across SE TX and S LA.**






5-Day Precipitation Forecast & River Flood Status




Space Weather 3-Day Forecast




