- **Slight risk of severe storms over NE NM and the TX/OK Panhandles today; damaging winds and hail are the main threats.**
- **Marginal risk of severe storms over NE NM and the Panhandles Monday/Tuesday.**




5-Day Precipitation Forecast & River Flood Status

Minor flooding continues for portions of the Navasota and Neches Rivers in E TX today, but should be falling below flood stage by Monday morning.

The White River near Augusta in NE AR remains in minor flood stage through next week with seasonal agricultural impacts.

Bayou Dorcheat near Springhill in NW LA is expected to be in minor flood stage for much of this week, with lowland flooding expected.

The Calcasieu River near Glenmora in Central LA is also in minor flood stage through Tuesday with a few local roads possibly flooded.

No additional flooding is expected due to the forecast rainfall the next 5 days.







Excessive Rainfall Outlook




Space Weather 3-Day Forecast




