




# 5-Day Precipitation Forecast & River Flood Status

**Moderate to Major river flooding continues across SW LA.**

**The Calcasieu River, at points near Oberlin and White Oak Park, is currently in major flood stage. Impacts to structures, homes, roads, and camps may occur.**

**The Mermentau river at Mermentau is forecast to reach moderate flood tonight and Bayou Nezpique at Basile is currently in moderate flood. Impacts include flooding of the shipyard and a few residences and recreational camps.**
